SUMWALT'S RETIRE

Joe and Virginia Sumwalt of Warren, have recently ended a 33 year career of making the rounds at area nursing homes.

Joe and Virginia have been involved in other types of ministry work also. In addition to working and raising a family of four, the couple traveled all over to hold revivals. When Joe got home from work, they'd pile into the car and take the kids and the organ and head off to a revival. Joe sang, and Virginia played the piano, organ and accordion.

They kept that up for around 25 years before retiring from that aspect.

Their church, the First Church of the Nazarene in Huntington, asked for someone to head up it's nursing home ministry. The Sumwalt's said

Every week without fail the Sumwalts took their ministry to Miller's Merry Manor in Huntington, and twice a month visits to Markle Health and Rehabilitation and monthly services at Norwood Health and Rehabilitation. They also included stops at nursing homes in Bluffton and Warren at the beginning of their ministry.

Their ministry consists of sing $alongs featuring \, the \, old \, traditional$ church hymns, whose familiar notes often came easily to Alzheimer's patients. Visiting with residents was a very important part of their ministry as well Patients looked forward to seeing them on a regular basis.

In March of 2010, the Sumwalt's lost their daughter and then Virginia had a stroke. The decision was made to retire and turn the ministry over to someone younger. They still plan to visit the nursing homes when they can. If anyone would like to be a part of the nursing home ministry - contact

BMV CENTRALIZES

Beginning in 2011, all customers will receive their registration cards, stickers and license plates through the mail under a centralized distribution system announced by R. Scott Waddell, commissioner of the Indiana Bureau of Motor Vehicles (BMV). As a result, stickers and plates will no longer be available at any license branch or self-service terminal.

Customers can renew their registrations online myBMV.com, by phone at 888-692-6841 or by mail using a new postage-paid envelope enclosed with the registration renewal reminder. Since 2008. millions of Hoosiers have utilized these convenient methods to renew their materials.

Persons with a more complex registration issue may receive assistance from the staff at a license branch. The customer may order a $plate\, or\, renew\, their\, registration\, at$ the branch, but the license plate and/orregistration card and sticker will still be mailed to them from the central facility within 14

business days.

"Unless a registration renewal is unusually complex, there's no need for customers to visit a license said. branch " Waddell "Centralized distribution is more effective and will virtually eliminate inventory costs since plates are not produced until they are needed "

Historically, plate inventories in branches caused costly excesses at the end of the plate cycle. The new make-to-order production system allows all license plates to be printed immediately when the order is received.

"We are constantly looking for ways to improve customer service while conserving taxpayer dollars," Waddell added. "Central issuance controls costs by diverting routine transactions away from the branches where costs are the highest. It allows our branch staff to focus on more complex services, such as driver's licenses and vehicle titles."

Some media outlets have incorrectly reported that registration renewals may not be completed at BMV license branches.

R. Scott Waddell, Commissioner of the BMV, made the following clarification, "Although renewal stickers and license plates will not be available at the license branches, BMV customers may still visit a license branch to pay for their vehicle registration renewals. Our staff will be there to help with any complex transactions. However, customers will not leave the branch with any registration documents, only receipts of their payments."

"We encourage customers to consider using the more convenient ways to renew their registrations. Already over 50% of our customers renew their registrations online at myBMV.com, by mail or through the BMV Customer Service Center

at 1-888-692-6841."



MITCHENER HONORED

Former Grant County resident, (Bryant) Janice Mitchener. Noblesville, received the Presidential Math Award for



Excellence in teaching Mathematics in Washington DC this month. Janice was the recipient of the prestigious award for the State of Indiana. The honor

is awarded annually to the best pre-college-level mathematics teachers from across the country. A panel of distinguished scientists and math educators selected a math and science teacher from each state to receive the Presidential Award.

Mitchener is a graduate of Eastbrook High School. She has a B.S. in Mathematics Education from Purdue University and an M.S. in Secondary Education from Indiana University-Purdue University Indianapolis. She has been an educator for 26 years. teaching the last 20 years at Carmel High School. She started her teaching career at Southern Wells High School and Greenwood Community High School. She was also an instructor at a mathematics enrichment camp, engaging students with hands-on-projects. As a certified Teaching with Technology Regional instructor, Janice provides professional developing on using technology in the classroom to teachers and has presented sessions at several state and national conferences

Janice was named 2007 Carmel Clay Schools Teacher of the Year and was a 2008 finalist for Indiana Teacher of the Year. She received the Math MovesU Math Hero Award in 2006 and the Indianapolis Power and Light Golden Apple Award in 2005.

WFBINAR JAN 10

The value of farmland has certainly been a hot topic for farmers and landowners during the past few months. They're aware of the higher prices for agricultural land at area auctions this fall.

Recent reports from the Kansas City and Chicago Federal Reserve Banks noted strong increases in farmland values. The Chicago report showed lowa and Indiana farmland increasing at 13 and 11 percent respectively.

The Purdue University Center for Commercial Agriculture will be conducting a free live webinar event on January 10th at 1:00 pm EST to answer your questions about farm land values. Producers are cautiously optimistic about growing corn, soybeans and wheat when they hear projections of good farm income for 2011. This is a key factor that is driving the trend of higher prices for agricultural land. There are, however, other factors that are influencing the farmland market across Indiana such as federal tax policies and the potential conversion to urban development.

In August 2010 the Purdue Agricultural **Economics** Department released the 2010 Indiana Farmland Values and Cash Rents Survey. According to this annual report, the average value of bare Indiana cropland ranged from \$3,501 per acre for poor quality land to \$5,301 per acre for top quality land. State-wide the cropland values increased 4.5% to 6.3% from June 2009 to June 2010. Results from the survey and a full report are available online at http:/ /www.agecon.purdue.edu/ extension/pubs/paer/2010/ august/paer0810.pdf . As noted the more recent data released by the federal banks indicates even higher land values since this report was released last summer.

While the current trend shows much strength in the farmland market, the many factors that influence prices should be evaluated by investors and growers. Resources are available to help people understand and interpret the current level of farmland values.

Old, expired medications can lose their potency thus reducing or providing no value to the condition being treated and unused medications have the potential to be abused and misused.

"As you finalize your resolutions for a happier and healthier New Year, why not add this simple task to your list?" asked Thomas E. Menighan, APhA Executive Vice President and CEO. "A medicine cabinet cleanout is one of the smallest resolutions a person can make for their personal and family's health. To help protect yourselves and the environment, it just takes a few simple steps to properly store and dispose of medications. And if you have any questions about your medications' expiration date or potency, talk with your pharmacist."

Tips for Storing and Cleaning Out Your Medicine Cabinet or Other Medication Storage Areas:

- · Medications should be stored in a secured area that has low humidity, a stable temperature and adequate lighting.
- · Check the date on everything in your medicine cabinet and dispose of anything that has passed the expiration date.
- · Properly dispose of anything you have not used in the past 12 months

Properly dispose of any prescription medications you no longer need. Do not share prescription medications with

- Properly dispose of medicines no longer in their original container or that can no longer be identified.
- Properly dispose of medicines that have changed color, odor or

Do not flush unused or expired medications and do not pour them down a sink or drain.* They should be disposed of properly in the household trash or through your community's medication disposal program, when available. Follow these easy steps before disposing in the trash:

o Pour medication into a sealable plastic bag. If medication is a solid (pill, liquid capsule, etc.), add water to dissolve it.

o Add kitty litter, sawdust, coffee grounds (or any material that mixes with the medication and makes it less appealing for pets and children to eat) to the plastic bag.

o Seal the plastic bag and put it in the trash.

o Remove and destroy ALL identifying personal information (prescription label) from all medication containers before recycling them or throwing them awav.

This happens today. We are good at hiding it from others. We skate at home and in our work life. At work when you skate you will eventually be found out and your iob is at stake. 

Free Tax Preparation is by appointment only and times that are available each week will be Monday through Wednesday between 9:00 A.M. and 8:00 P.M., Thursday between 9:00 A.M. and 5:00 P.M., Friday from 9:00 A.M. until 3:00 P.M. and Saturday from 9:00 A.M. until 1:00 P.M.

The Earned Income Tax Credit or EITC, provides tax credits to working adults and families with low or moderate incomes. Money can be used to pay down debts, buy things families need, or can be saved for the future.

The maximum EITC for 2010 is:

- \$457 for families with NO qualifying children
 \$3,050 for families with 1
- qualifying child
 \$5,036 for families with 2
- qualifying children
 \$5,666 for families with <u>3</u> or more qualifying children

Families may qualify for the Earned Income Tax Credit if they meet the following guidelines:

- If the family has no children and made under \$13,460 (\$6.47/hr.) in 2010, or if the family has no children and made under \$18,470 (\$8.87/hr.) if married filing jointly.
- If the family has 1 child and made under \$35,535 (\$17.04/hr.) in 2010, or if the family has 1 child and made under \$40,545 (\$19.49/hr.) if married filing jointly.

- If the family has <u>2 children</u> and made under \$40,363 (\$19.40/hr.) in 2010, or has 2 children and made under \$45,373 (\$21.81/hr.) if married filing jointly.


- If the family has <u>3 or more children</u> and made under \$43,352 (\$20.84/hr.) in 2010, or has 3 or more children and made under \$48,362 (\$23.25/hr.) if married filling jointly.
