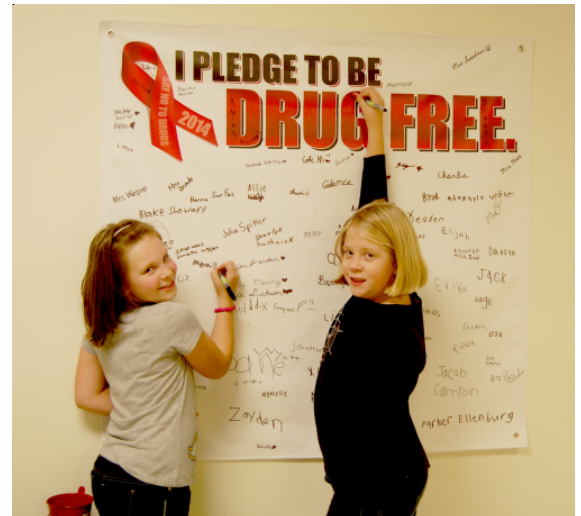

EXTENDED HOURS

Don Snemis, Commissioner of the Indiana Bureau of Motor Vehicles (BMV), announced that BMV license branches will extend hours of operation on Monday, November 3 and on Tuesday, November 4 to issue ID cards and driver's licenses that may be used for identification at a polling place.

Branches will be open on Monday, November 3, from 8:30 a.m. to 8 p.m. and on Tuesday, November 4, from 6 a.m. to 6 p.m.

License branches will only process new, amended or replacement ID cards, and renewed, amended or replacement

driver's licenses, learner permits, and CDLs. Aside from disability placards, the branches will not perform any other BMV services.

The Indiana BMV provides free, state-issued ID cards for voting purposes to any unlicensed Hoosier, as long as he or she can provide proper documentation and is old enough to vote. The following documents are required to obtain a new state ID card or driver's license (a complete list can be found at www.myBMV.com).

- Proof of Identity document, such as a birth certificate or passport.

- Proof of Social Security document, such as a Social Security card, pay stub or W-2.

THE UPTOWN GARDENER by Ruth Herring

After the last entry of our article you may know why I have gray hair(or grey hair) which ever way you spell it. What was not printed it is best one never know about. I have always said someday there will be pay back time.

For me in my growing up years, we didn't have access to cars, no way would dad give us keys to his old 1939 or 40 car even though gas was 15 cents a gallon. We were lucky to find a friend to loan you a bicycle. The most fun we had was tying screen doors shut knocking on the door. There was an old guy in town who qualified as the king of grouchy people, naturally we always called upon him. He threatened to shoot us but we knew the gun he had was wooden and shot rubber bands but they did kind of sting if you got hit. The best part was a couple little sweet old ladies always gave out nickels and that was a must stop, they graciously gave us the nickel and said "now boys I am old please don't soap my windows." We were always nice to her because my dad always delivered potatoes and dressed chickens to her. If you got there early at both houses you had 10 cents and that bought a nice ice cream cone. The restaurant was always busy at Halloween time. Then after a night of fun we had to call our dad to come get us because we were afraid to walk home and pass between the barns that were on each side of the road we lived on. It housed a bunch of roudy hogs and a nasty old bull that was rather mean and often got loose from the pen. Enough said about my experiences.

The frost we had did a number on the flowers so have been slowly cleaning up and put the beds to rest for winter. Got all 80 tulip bulbs planted that was a birthday gift from the brother in Texas, the one and only who chose not to come up and help me. Now I hope the squirrels don't have a feast on them and I see a mole is working its way there. Guess I need to get out the artillery and go after it.

The trees were especially beautiful this year and really enjoyed the view from my back yard. Certainly hope all of you did as well.

I will give you my mom's recipe for apple dumplings and sure would like having some of hers with that special touch or pinch of ingredient that no one knew what it was, just could have been the fact that we had lot of rich milk and cream to top it off.

2 cups flour, 2 teaspoon baking powder, 1/2 teaspoon salt, 2 tablespoon lard or shortening, 1 tablespoon butter. Work up like a course meal, add 3/4 cup milk, adding a bit more flour to make a nice soft dough, divide into 6 parts, roll out 1/8 thick, brush with melted butter, add a peeled sliced apple to each, sprinkle about 1 tablespoon sugar, 1/8 teaspoon cinnamon, brush edges of dough with melted butter, fold up dough over the apples, transfer to a lightly oiled 9x13 pan, bake at 350 for 1/2 hour.

Make a syrup of 1 cup sugar, 1 tablespoon cornstarch, 1 1/2 cup hot water, 1 tablespoon butter, bring to a boil and pour over the dumplings, bake another 15 minutes.

TURBINES COMING

If you are a citizen/taxpayer of Huntington County, this may be the most important 'letter' you

will ever read. The financial security of our county is at risk because of actions by the Plan Commission (PC) of our county - who are advised by the Planning Director. A majority of that commission have ignored valid data concerning the truth about Industrial Wind Turbines (IWT) - presented by the Huntington County Concerned Citizens (HCCC); this writer, whom has researched IWT for several years, along with various other knowledgeable authorities. The United States Congress is in process of doing the same. Hopefully, it will become law soon.

Documented evidence points to the reality that IWT are a dying breed and being abandoned even by Investors...They are now betting on the new 'gold rush' - Natural Gas. Warren Buffett and

George Soros, two of the world's wealthiest investors are advising, "Without government support, IWT are Worthless". The major taxpayer support has been 'Tax Credits' - paying 2.3 cents for each kilowatt of electricity produced by IWT. The tax credits alone have cost the American taxpayer Hundreds of Billions of Dollars In The Past 18 Years. Another excellent source of easy money for the IWT operator, is Sec 1603 of the U.S Tax Code: If a given wind turbine (which on average operate at 24% efficiency) does not produce the full 'Manufacturer Stated Output Capacity', the operator can be reimbursed for the amount of electricity NOT PRODUCED. Oh, what a great country!

According to the U.S. Dept. of Energy (DOE): In 2013, U.S. installations of IWT were down 92% from 2012. (That was WITH the tax credits). The DOE also reported - for 2013 - IWT provided a net 1% of all electricity produced by all sources in the U.S.! In the fall of 2013, a desperate Apex Clean Energy sent their representative back into Huntington County seeking contracts with landholders for installation of 60 - 500 Foot Tall IWT in the Plum Tree area - to start with. When a landholder or non-participant citizen signs the contract, they transfer all property rights to the developer. Where had Apex been since 2009?... when our present IWT ordinance was created by the (then) Planning Director, Plan Commission (PC) of 9 volunteer citizens - none of whom had knowledge of IWT - and later signed by only 2 of the 3 County Commissioners - who also possessed little IWT knowledge. In fairness, it is pointed out that 2 'outside' lawyers were retained by the county, to approve the

ordinance before the signing. (In 2009, lawyers and Apex knew very little about IWT). Now it's different. If you have access to the net - go to huntingtonHCCC.org for up-to-date IWT info or if you have read the many letters to the editor - you should be well informed on IWT. (Wonder if Apex was any help in writing the first ordinance? They are now certainly trying to reduce citizen protections with their amendments presented for consideration by the current PC. (Note: According to the County Recorder, up to about 3 weeks ago, Apex had filed a total of 12 IWT contracts - only one being accomplished in 2014. That represents One-Fourth of One Percent of the total 14,422 households in Huntington County).)

Earlier this year in a local newspaper poll, 72.4% of Huntington County people Voted "Opposed" to IWT. A few in favor, still refer to 'Free Electricity' (see above) and 'Big Bucks' that should be derived from property taxes and other promised sources. Promises - not Guarantees. On that issue, the Plan Commission Chairman refuses to even consider requiring Apex to provide a financial statement to our county. (Ever try to buy a car without completing a financial statement?). Remember the 'Netherlands Dairy Farm Group'? They too came into our area, made all kind of promises without proof of solvency; created nothing but trouble for everybody they dealt with; left the properties in a mess; local citizens holding the financial bag to clean up after them; filed bank-

ruptcy and vanished. Mr. Planning Director, members of the Plan Commission and County Commissioners: History Does Repeat Itself. Those who ignore it, live to regret it. Please provide our citizens One Guaranteed Benefit That Huntington County Citizens Will Derive From Industrial Wind Turbines?

If some Huntington County officials have their way, Industrial Wind Turbines will be built in the Plum Tree area! Jay Poe our county surveyor and member of PC, has worked valiantly for several weeks to prepare needed, viable De-Commissioning amendments for the present IWT ordinance. They include strict requirements and restrictions for the developer Apex Clean Energy. A major one is that all financial dealings be with a 'Grade A' bank. The present law requires only a bond be provided, for when removal of IWT occurs...and it will happen - most likely unexpectedly. The average life of an IWT, in the U.S., is 18 years. In Mr. Poe's amendment, Apex would be required to annually place 5%, of the total estimated de-commissioning costs, in a county held reserve. This would be in addition to their 1% cost of a bond, letter of credit or other similar guarantee for the balance, at any given time. In 20 years, our county would have, in hand, the total monies originally determined necessary, with a buffer of any interest earned. The Planning Director's office totally ignored Mr. Poe's work and none of his efforts are reflected in the 'Revised' ordinance. This edition - provided the commission and public - does include those

amendments made by Apex - which the Planning Director told me "would simply speed up the process". What they actually do is dilute requirements placed on the developer; makes the ordinance more beneficial to Apex; increases our county exposure to unknown massive financial needs; and will potentially cost you and other citizens many Millions of Dollars to 'clean up their mess'.

Our family lives in Wabash County, where the officials care about the citizenry. Huntington County's current ordinance has a 1,000 foot set-back law - which the PC Chairman insists not be changed. ????? Wabash County recently changed theirs from 1,500 feet to 2,640 feet. In some foreign countries they are increasing set-backs to 2 miles or more. Three counties, in our part of the state, Ban IWT. Others have an average set-back of about 2,800 feet...and NO WIND TURBINES. In Tipton & LaGrange Counties and elsewhere, the developers have moved out. The state of Ohio - by changing one line of their IWT law - has killed them. For which Apex reportedly stated: "(We) will have no choice but to take its investment and its business elsewhere". It has baffled me why our county did not follow the lead of others. Contact your Planning Director and PC Chairman... ask where they stand...and why.

On November 12, 2014, the Plan Commission will meet in the GAR room of the courthouse at 6:30 PM. It is scheduled to be for final arguments of amendments to the current ordinance - and possibly a vote on the issues. If you do not help to fill that room and the hallways of the courthouse, with your presence, don't whine how 'nobody did anything to protect us from stuff like this'. The HCCC and people like me have been doing everything we can to stop IWT. We're tired of fighting your battle. If 60 - 500' IWT are each set in 1,500 tons of concrete, in our county, and disrupt or destroy your lifestyle, don't point your finger of fault at others. Remember, three fingers are pointing back at you! (John Paul, Warren, In.)

CHAUTAUQUA

Chautauqua Literary Society held its first meeting of the season October 3, 2014, at Heritage Pointe, with 24 members attending. President Betty Yoder welcomed everyone, the Collect was repeated, program books were distributed and reviewed, and the October business meeting was conducted. Roll call was

answered by stating "What do you appreciate about Abraham Lincoln?"

A very interesting and historical program given by Betty Yoder was a book review of "Killing Lincoln" written by Bill O'Reilly.

Abraham Lincoln was born February 12, 1809—2nd son of Thomas and Nancy Hanks Lincoln, in Hodgeville, Hardin County, Ky. In a one room cabin. At one time Thomas Lincoln was a very wealthy man—owning and leasing farm land, town lots, and livestock. In 1816 he lost everything in Court cases because of faulty property lines. The family then moved to Spencer County, Indiana.

In 1818, when Abe was 9, his Mother—Nancy Hanks Lincoln—died of milk sickness. In 1819 his father married a widow with 3 children, Sarah Bush. Abe became very close to Sarah, and she always encouraged him to read. He became an avid reader, and thus a self-educated man. He was also 6'4", and became very strong yielding an ax, splitting logs, and building fences. It was also customary to give all the wages earned away from home back to the family until 21 years of age.

In 1830, at 21 years of age, he moved to Illinois. In March of 1832 he began his political career, and then served as a Captain of the Illinois State militia. In 1835 he met the love of his

life—Ann Rutledge—but unfortunately she died of typhoid fever at the age of 22.

Lincoln was admitted to the Bar in 1836. As a successful lawyer he became known as a formidable adversary, excelling in cross-examination and closing arguments. Lincoln served in the Illinois State House 1834—1842 as a member of the Whig party.

In 1842 he married Mary Todd from a very wealthy slave-holding family. Lincoln was already concerned about the slavery question. His early Church forbid holding slaves. In 1846 he was elected to the US House of Representatives, and in the 1850's he campaigned for the US Senate on an anti-slavery platform, arguing this point in the famous Lincoln/Douglas debates. He lost the election to Douglas in 1858. However, in 1860 he won the Republican nomination for President on the 3rd ballot. He was elected President Nov. 1860, by a narrow popular margin, but a decisive Electoral College margin.

Soon action from the Southern states for secession from the Union began, electing Jefferson Davis as the President of the Confederate States of America. However, Lincoln refused to recognize the new Confederacy declaring it illegal. The Civil War began April 12, 1861, on his watch. He as so dismayed that he frequently was seen survey-

ing the situations on the battlefield.

In 1862, Lincoln he issued The Emancipation Proclamation, freeing the slaves, and the bloody war continued. In July, 1863, President Lincoln spoke the most quoted speech in American history at the battle fields of Gettysburg, Pa. --- a 272 word speech written on the back of an envelope on the train to Gettysburg.

Lincoln won his 2nd term as President in 1864. In March, 1865, he delivered a memorable inauguration speech. The speech stated, "With Malice toward none and Charity for all let us bind up the Nation's wounds." When the Civil war ended, all on both sides were allowed to return to their homes. The war ended with Gen. Lee surrendering to Gen. Grant at the Appomattox Court House, Va.

President Lincoln was assassinated by the actor, John Wilkes Booth, at Ford's Theater in Washington, DC, just five days after Lee's surrender. He died April 15, 1865, and was taken to Springfield, Ill for burial. Because of vandalism he has been relocated many times.

Lincoln was the father of 4 sons, with Robert being the only one to reach adulthood.

Lincoln was a devoted Father, and a dedicated and consummate Leader of the United States of America.
