INTERNET MEMORIAL WEB SITE

Veterans' Service Officer, Torn Applegate, announced that a new website honoring Huntington County veterans who passed away in 1999 is now online.

The web site, located at <http://memday2000.homestead.com/index.html>, contains a separate Memorial Page for each of the eighty-three veterans. Each page contains information about the veteran's branch of service and when he served, the ribbons and medals he received, the name of the veterans organizations he belonged to, and also provides some family information.

A highlight of each page is a picture of each veteran taken when he was in the service and another picture taken of him more recently. Beneath each set of pic-

tures is his date of birth and date of death. Each page also contains a picture taken during the Memorial Day 2000 ceremony of a family member accepting a certificate offered by the Huntington County Commissioners and presented by local veterans organizations commanders.

Finally, each page contains a counter which keeps a running total of the number of people who have visited the veteran's Memorial Page.

The Veterans' Service Office is pleased to be able to offer this final tribute to Huntington County veterans. A new site will be added each year to honor those who passed away the year before.

APPLICATION DEADLINE

Veterans' Service Officer, Tom Applegate, announced that the deadline for submission of applications for the Korean War Service Medal is August 15th.

Applications for medals which are received after that date may mean the medal is not received in time to be presented to the veteran during the Veteran's Day ceremony on November 11th, this year.

Veterans who served in Korea between June 25, 1950 and July 27, 1953 are eligible for this medal recently authorized by the governments of Korea and the United States. The medal can also be awarded posthumously to other family members.

Many veterans have already purchased the medal through private suppliers but Applegate advises that only the medal furnished by the government of Korea is considered to be the "official" medal. Those veterans should apply for the medal through the Veterans' Service Office.

Eligible veterans or family members should provide a copy of the DD Form 214 proving the veteran served in Korea and that the service was during the required period of time. Bring the form to the Veterans' Service Office, Courthouse, Room 106. Office hours are weekdays from 8:00 a.m. to 4:30 p.m. Those veterans who have already applied do not need to reapply.

BACK TO SCHOOL TIME!

Get into the routine before school starts

Going back to school for the first time in months can be a shocking experience for your children. To help them get off to a good start, begin your school day routine a week or two ahead of time. Here's advice from the PTA on how to do it.

Health

- Fix healthy meals and serve them at the times kids eat during the school year.
- Keep them physically active. Kids who are strong and in good condition will learn more easily.
- Set the hours of sleep as you will when school is in session.
- Put a big emphasis on hand washing. Kids who wash well and with regularity get sick less often and are absent fewer times, according to studies by St. Joseph's Hospital in Charles-ton, S.C. Teach them to use plenty of soap and wash for about 13 seconds.
- Review safety rules for those who walk, ride bicycles, or take the bus.

Mental preparation

- If they have avoided reading all summer, get some super interesting books and have them read now. Read with younger kids or have them read out loud to you. Recent studies show that reading out loud is very helpful for young readers.
- Teens should consider reducing or eliminating their working hours on an outside job. Remind them that risking their education or their health is not worth the extra money, even if it's for a car.
- Have positive discussions about school. Talk about seeing their pals, their new outfits, what teachers they might have, and what extracurricular activities they will be enjoying.
- Get kids to practice a little quiet time. Those in the lower grades can spend time coloring or drawing for 20 minutes to half an hour at a time.

HOW TO SAY GOODBYE WITH FEWER TEARS

It's called separation anxiety, but parents of kindergartners may know it only as a time for tears.

Doctors at the Child Study Center at Wellesley College in Wellesley, Mass. say you can help:

- Practice separation: Before starting school or preschool, let your child have play dates at a pal's house or stay with grandma or a sitter.
- Visit the classroom ahead of time with your child.
- Stay a while in the first few days. Don't rush off or sneak off, but don't prolong the stay.
- Help the child select an interesting activity.

It's important to address separation anxiety quickly. Social connections and routines develop in the first few days of the year. Kids who are absorbed in their own distress could miss out on these significant developments, say psychologists.

AREA NEWS

BISHOP WHITE

REAPPOINTED

After having served the Indiana Area's approximately 250,000 United Methodists as their episcopal leader for the past eight years, Bishop Woodie W. White, the state's first black bishop, has had his tenure in Indiana extended for another four years.

The decision of the United Methodist Committee on Episcopacy (bishops) was announced recently at the quadrennial meeting of the Church's North Central Jurisdiction, in Madison, Wisc. In reassigning White to Indiana, the committee acceded to the request of both the North and South Indiana (regional) Conferences, as well as that of the bishop, himself. In practice, it has been unusual for a bishop to be appointed to an area for more than eight years; however, Church law allows for an extension of that limit when in the best missionary interests of the area.

Bishop White has been widely known for his leadership in racial healing and reconciliation. He has given special leadership to Africa University in Zimbabwe. Through his initiative, United Methodists of Indiana have given financial and human resources to build four residence halls at Africa U., which currently has students from 17 African nations. In addition, White has launched a special Indiana Initiative on Children and Poverty, and continues to support anti-legalized gambling efforts in this state.

North Central Jurisdiction of the United Methodist Church is one of five such regions in the U.S. and consists of seven states, including Indiana. In addition to assigning bishops to areas of service, the jurisdictional conferences also elect new bishops. Three bishops retired this year and three new ones were elected in the Jurisdiction; a total of 13 were elected nationally.

Four Hoosier United Methodist clergy had been nominated for bishop but were not elected: the Rev. Thomas Rough, superintendent of the Calumet District; the Rev. Gregory McGarvey, senior pastor of Old Bethel UMC in Indianapolis; the Rev. Phillip Granger, senior pastor of College Ave. UMC in Kokomo; and the Rev. Katherine Lehman, superintendent of the Lafayette District.

Each of the Indiana candidates withdrew during the course of the 19 ballots taken.

Four years ago, the Jurisdictional Conference was held in Fort Wayne, and two Hoosiers were elected: Michael Coyner (Indianapolis) now bishop of the Dakotas, and John Hopkins (Evanston), now bishop of Minnesota.

The denomination has 8.4 million members in the United States. Following the elections this month, 15 of the 50 active U.S. bishops are African American, eleven are women, one is Korean American and two are Mexican Americans.

CELEBRATING 26 YEARS OF SERVICE

What do hats from around the world, great music from the 1930's, awards and yummy food have in common? The Council on Aging's Annual Banquet. On Tuesday, July 18th sixty people joined to celebrate 26 years of service to the elderly of Huntington County. The First Presbyterian Church hosted the annual meeting and dinner.

Following the delicious dinner, the Senior Singers provided super entertainment, singing six musical selections from the 1920-1950 era. Bill Fetrow directed the chorus accompanied by Evelyn Wohlford.

Awards were presented to three outstanding people. Sister Theresa Egidy from Victory Noll received the Senior Volunteer of the Year. She was chosen for her life-long outreach to the needy. On August 10th, Sister Theresa will go to the State Fair to represent the nine county northeast Indiana district as the Area Senior Volunteer.

Jerry Helms received the Volunteer of the Year Award for his tremendous help with transportation. Last December, Jerry began getting up at 4:00 am three days a week in order to transport four Huntington seniors to the Lutheran Hospital for kidney dialysis treatments. The Council on Aging and these seniors are greatly indebted to Jerry's willingness to volunteer to help.

This year the Staff Member of the Year Award went to Trudy Perdue, one of the Council on Aging's homemakers. Trudy is dearly loved by those she helps each week. She goes the extra mile by checking in on sick clients and often doing extra errands to

lighten the seniors' load.

Bob Whitesell, President of the Council on Aging Board, highlighted some of the accomplishments of the Council on Aging this past year. These included a 63% increase in the amount of hours served by the homemaking service and the continued needed met by transportation service. He explained the past year's budget and talked about some of the upcoming year's needs.

Bill Fetrow, Executive Director, shared highlights of the upcoming year's projects and how they hope to be funded. He explained the HAT-the new Huntington Area Transit system that the Council hopes to have in place by the new year. Hopefully, by September they will have final approval of the INDOT grant that will help fund this project.

CHILDREN STILL WAITING

In September 1999, President Clinton cited Indiana for being 6th among 35 states for moving children from foster care to the love and security of an adoptive home. Still, hundreds of children continue to wait for a "forever family." In the August 2000 edition of the

"My Forever Family" Newsletter, published monthly as a public service by the Adoption Initiative office, 8 children are featured who have waited from 37 to 22 months for a family of their own. Children like Adrian, age 14, who have grown up in the Picture Book, the Initiative's monthly photolisting of children who are legally-free for adoption. Adrian, around, chubby-cheeked little boy in 1997, is a handsome teenager today, still

waiting for his "forever family."

Children like Adrian are considered special needs because they are older or a member of a sibling group. "Special needs" children may also be of minority racial background, or have physical, mental or emotional challenges often due to backgrounds of neglect and abuse.

"The heartbreaking thing is that

WHEELS FOR THE ROAD

In January 2001, the Huntington County Council on Aging will begin a public transportation system for all ages throughout the county. COUNCIL MEETING

The July 24 meeting of the Warren Town Council was held at the local Fire station and opened at 6:30 p.m. President Chod Boxell conducted the meeting which opened with the Pledge to the American Flag.

Approval was given to the minutes of a regular meeting July 11 and a special meeting July 19.

Engineer Jim Lauer discussed plans with Council for a future water improvement project in Warren. With IDEM approval, it is hoped to proceed with the project by January 2001. Also discussed were aspects of the upcoming wastewater project.

Council adopted Ordinance 2000-6 which allows for a three-way stop at the intersection of Hillcrest Drive and Riverside Drive in Salamonie Heights.

IDEM has granted verbal approval of a waiver by Dollar General to locate in Warren. Written documentation is expected within ten days.

An updated easement plan was reported available for the Professional Business Park. The Town has required additional utility easements in the area at the newly constructed Medical Building.

New trash receptacles have been placed in the downtown area. Council plans are that the old receptacles be repaired and taken to Tower Park.

A meeting was set for 1 p.m. Thursday with representatives of Council and others with Engineering Butler Fairman Seyfert concerning an INDOT-SR5, SR 218 project in Warren. The Council has requested that the highway be reconstructed and that curbs and sidewalks be considered.

The Town-Wide Clean-up was reported to have gone well, with seven loads being collected. Council thanked those who followed guidelines for dumping.

Five new copies of the Town Code had been ordered from American Legal. That with re-codification of codes up to July of 2000 will cost \$800.

A number of issues had been discussed during a special meeting with Nelson Steel, INDOT

Project, as well as issues related to the 2000 Budget. Council set the 2000 tax rate at \$2.35 per hundred, the third year that the local rate has not increased.

Town-Clerk Marilyn Morrison gave a report on the Budget. A meeting is scheduled on Aug. 3 with the Indiana State Board of Tax Commissioners.

Darrel Bice reported from the Utility Department. Projects included flushing of water hydrants and repair of leaks.

Fire Chief Tim Ford reported the Warren Fire Department had no major fires in June. There had been a vehicle accident.

David Miller is a new member of the local Department, transferring from the Liberty Center Department. Ford reported the local department is still one member short. Council had approved capital spending for 2000 Budget as requested by Ford.

HEALTHY COMMUNITIES/ HEALTHY YOUTH

Part 3 of 4

The Youth Task Force of Huntington County is working to promote developing assets in our county's youth. How can one build assets in our county's youth? First adults must shift their thinking. Instead of focusing on what is wrong with teenagers, we must start thinking about what is good about them and try to build a positive relationship with them. Using the developmental assets will help us accomplish this goal.

Next, we need to focus on one particular asset we would like to build in a teenager. Then model that positive behavior we would like to see in that child. Nurturing our own assets will give us the strength to help a teenager develop their own assets. Work together. Both parties involved should take responsibility in developing the relationship. Stay involved when a teenager seems turned off by adults. That is when they most need our support.
