## FUTON RECALL

In cooperation with the US Consumer Product Safety Commission (CPSC), The Standard Mattress Co., of Hartford, Conn., is voluntarily recalling approximately 47,000 futons. Some of these futons may fail cigarette ignition resistance tests, in violation of the federal Flammable Fabrics Act, because the boric acid flame retardant inside the futons may not have been evenly disbursed. This could result in burn injuries, should one of these futons catch fire.

The futons being recalled were sold between May and October 1998 with model numbers 605, 608, 611 and 613, sold under the brand names of Gold Bond, IKEA, and Verlo. The model number and brand name are located on the permanently sewn-in label. The futons come in varied sizes, most of which are full size. Other sizes include king/chair, queen and twin. All are covered in a cotton/polyester fabric in a natural (off-white) color.

Furniture and futon stores nationwide sold the futons for \$140 to \$250.

Consumers who purchased one of these futons during this period should immediately call The Standard Mattress Co. toll-free at 888/512-6169 anytime to obtain a free replacement futon. Consumers should not return the futons to the store where they purchased them. Replacements are available only by calling the company.

## HEATER RECALLS

The CPSC and Cadet are recalling approximately 1.9 million in-wall electric heaters under the brand names Cadet and Encore. These heaters were sold from 1982 to 1999. According to the CPSC, these heaters may be defective and could overheat, fail, catch fire, and spew flames and molten particles.

Heaters to be replaced are Models FW, FX, RX, LX, RLX, TK, RK, Z, ZA, RA and ZC. If you have already removed one of these heaters, please call the hotline for more information regarding reimbursements.

safety recall, please call the Cadet Recall Hotline at 800/567-2613 or visit the Cadet website at [www.cadetco.com](http://www.cadetco.com). This recall program is offered only by Cadet, not through its retail, wholesale or distribution channels. The Hotline and website are the first places consumers should go to participate in the recall.

Timing is critical, because owners of recalled Cadet heaters must complete the necessary forms and return them within 24 months of the announcement of the recall to receive replacement heaters and/or reimbursements. If you have a Z model heater, you are urged to stop using it and use an alternate heat source. If no alternate heat source is available, use the heater only while you are in the room and able to watch it carefully, keep everything at least 3 feet away from the heater.

## TUITION ASSISTANCE

### D-DAY MEMORIAL UNDER CONSTRUCTION

The plan for a D-Day Memorial in Bedford, Va., had simple beginnings, but today land dedicated to it reaches 88 acres. The projected cost of the project is \$12 million which will be paid for entirely with private contributions. The memorial commemorates the greatest military operation of all time.

Bedford is a fitting place. It suffered the highest per capita loss on D-Day of any community in the U.S. Twenty-one of Bedford's 3,200 residents died on Omaha Beach. In all, 9,758 Americans were killed, wounded, or reported missing on June 6, 1944.

Though contributions have been accumulating for some years, interest in the memorial increased significantly with the publicity of the 50th anniversary of D-Day in 1994. In 1997 "Peanuts" creator Charles Schulz became the campaign chairman and donated \$1 million to the project. And Congress officially designated Bedford as the location for a national D-Day memorial in 1997.

A plaza situated on Bedford's highest hill honors those who took part in the invasion. A middle plaza provides visitors with information, and a lower plaza, far from the monument's focal point, is for personal reflection. A 44-foot granite arch is inscribed with "Overlord," the code name for D-Day. It is fashioned after Rome's Arch of Titus through which victorious Roman troops marched.

One story wall bears the names of Allied and American soldiers killed on D-Day. There is a series of reflecting pools and a symbolic beach where 12 life-size statues represent the troops. They are realistic, showing pain, fear, and determination.

The upper level features exhibits, a theatre, a library, and archives.

### NEW ORLEANS: JUNE 6, 2000

#### NATIONAL D-DAY MUSEUM OPENS

New Orleans is a fitting place for the National D-Day Museum. It was in New Orleans that the famous Higgins Landing Craft was made.

The boat was credited by Gen. Dwight D. Eisenhower as pivotal to Allied victories in World War II. Though it is most famous for the invasion of Normandy, it played a critical role in many invasions in Europe and the Pacific.

The 67,000 sq. ft. museum is located in the Warehouse District at the corner of Magazine Street and Howard Avenue in New Orleans.

Its rich collection of artifacts from Utah and Omaha beaches include Allied and German vehicles and a vast array of weapons and equipment. Also featured are a British Spitfire and U.S. Avenger aircraft.

The museum's interactive exhibits include oral histories, documents, photos, and rare film footage.

## AREA NEWS

### FIRST AID CLASS

The American Red Cross is sponsoring a Community First Aid and Safety class on Thursday and Wednesday evenings, June 6 & 7, 2000 from 6-10pm at the Trinity United Methodist, Huntington. Another Community First Aid & Safety class is being offered on Saturday, June 24 at Trinity United Methodist Church from 8-5 p.m. These courses will instruct you in the skills of adult, child and infant rescue breathing, choking emergencies, and cardiac emergencies (CPR). You will also be able to identify and care for life-threatening injuries and sudden illnesses, including bleeding, fractures, poisoning, burns, exposure to heat/cold, injuries of the eye/nose and other medical emergencies. The cost is \$35 per person (\$25 if you have the current text). This course is recognized by OSHA (Occupational Safety & Health Administration).

Anyone wishing to participate in any of the above classes may sign up at the American Red Cross Office, Room 417 of the Huntington County Court House, any weekday between 9:00 & 4:00 p.m. or contact the office at 219-356-2910 (huntingt@twi.com) and a course schedule and prepayment form will be sent to you. Registrations are needed at least three working days prior to the start of class.

### BABYSITTER CLASSES

To Help Make Children of Families in Huntington County Safer

To help improve the safety of young children left in the care of adolescents, the Huntington County Chapter will offer the new nationally available American Red Cross Babysitter's Training program. The course instructs youth on how to care for infant through school-age children by teaching them how to prevent injuries and what to do if an emergency arises. The U.S. Consumer Product Safety Commission estimates that each year nearly two million children through the age of eight receive emergency room treatment for injuries related to consumer

products and recreational activities around the home.

The American Red Cross Babysitter's Training, an 8 hour class, is written and designed for youth age 11 - 15. It provides adolescents with a range of injury prevention, first aid, and basic child care skills. Participants work on projects such as identifying safety problems around the house and yard, and selecting appropriate toys and games for children of various ages. Babysitter's Training also builds decision-making and leadership skills and addresses the business of babysitting and how to seek babysitting jobs in a professional manner.

"The Red Cross is offering Babysitter's Training not only to equip youth with the knowledge of how to keep children and themselves safe but also to give parents the peace of mind they need when leaving their children at home with a sitter," said Douglas Hatfield of the Huntington County Red Cross. "With more than 85 years of experience in educating millions of people in health and safety, our national headquarters decided to work with chapters from around the country and experts in the field to develop this nationally standardized course to keep our children safe."

The interactive, multimedia approach of Babysitter's Training includes a video and print presentation in addition to problem-solving sessions.

The Babysitter's Training Class will be offered on Saturdays, June 3 & 10, 2000 from 8:00 am to 12:00 p.m. at the new Huntington Memorial Hospital, 2001 Stults Road, Huntington at cost of \$20 per participant. Registration and prepayment are needed no later than Thursday, June 1.

### WARREN COUNCIL NOTES

On Monday evening, May 22, members of the Warren Town Council met at 6:30 p.m. at the local Fire Station. President Chod Boxell opened the meeting with the Pledge to the American Flag.

Minutes of the regular meeting of May 8 and a special meeting, May 11, at Salamonie School were approved as submitted.

A citizen in attendance was concerned as to why Council had decided against another stop sign at Salamonie Heights. Council informed they are uncertain as to whether the street in question has been dedicated. Council is expected to do more research to determine if the street is dedicated before taking further action.

Also questioned was an address in the County thought to be incorrect. The citizen was informed that the County Plan Commission would be notified, but that the residence was in the County.

Council was expected to get bids for maintenance of the water tower at Tower Park. The Engineer had advised a three year for interior and a five year plan for exterior. Three quotes will be requested.



Superintendent Jim Webb reported there were no water leaks and eight water related complaints were answered in May.

There were three sewer related calls. Also storm sewer drains were being cleaned and repaired.

Town Clean-Up Days May 13 and 20 were reported successful, there were three 30-year dumpsters filled. May 20 included metal, tires, etc.

Ground work has been completed at the Park for new playground equipment to be installed. The pavilion is to be painted. More quotes are to be obtained for fence around the park.



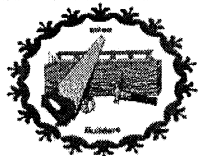
