# REGISTRY OPENS World War II produced many he-

roes, both overseas and at home. For the first time there is a registry which recognizes those men and women who were unable to fight overseas, but who helped win the war through their efforts at home.

In addition to those who served in the military, the registry encourages those who contributed to the war effort on the home front to place their names on record. 16 million Americans served in uniform during the Second World War, but the American Battle Monuments Commission (ABMC) encourages all members of the World War II generation to enroll in the registry, accessible on the memorial web site at www.wwiimemorial.com.

Any American who served in the armed forces or contributed to the war effort on the home front, whether in factories, shipyards, farms or neighborhoods, is eligible.

There is no charge to place a name in the registry. Individuals can be enrolled through the web site or by calling the memorial's toll-free number at 1-800-639-4992.

The registry contains more than 1.3 million records, most submitted by the public. The ABMC has been compiling names for several years, but has only scratched the surface of the database potential, which also includes lists from the National Archives and Records Administration of those killed in service during the war, and names of those buried in ABMC WWII overseas cemeteries or listed on its Tablets of the Missing.

Of 1,002 U.S. adults responding to a survey last May, 22 percent believed that only 100,000 served in uniform during the war, 34 percent thought one million served and 14 percent thought 8 million served. Just 8 percent correctly stated 16 million and 22 percent admitted they just didn't know.

The WWII Memorial will be dedicated on the National Mall on May 29, 2004. The registry will be accessible from the Memorial when it opens to the public.

The Indiana Veterans' Service Officers' Association encourages any veteran of World War II or any person who contributed to the war effort on the homefront to place their name in the registry. Huntington County veterans and other members of the public are encouraged to contact their county Veterans' Service Officer, Tom Applegate, at 358-4863.

#### FIRST AID TRAINING

#### **BABYSITTER'S TRAINING**

To help make children of families in Huntington County Safer

To help improve the safety of young children left in the care of adolescents, the Huntington County Chapter of the American Red Cross is offering Babysitters Training on Saturday, January 31, 2004 from 8-3 p.m. at the Annex, 354 North Jefferson St. (2nd floor). This course instructs youth on how to care for infant through school age children by teaching them how to prevent injuries and what to do if an emergency arises.

The American Red Cross Babysitters Training is designed for youth age 11-15. It provides adolescents with a range of injury prevention, first aid, and basic childcare skills. Participants work on projects such as identifying safety problems around the house and yard, and selecting appropriate toys and games for children of various ages. Babysitters Training also builds decision-making and leadership skills and addresses the business of babysitting and how to seek babysitting jobs in a professional manner.

The Red Cross is offering Babysitters Training not only to equip youth with the knowledge of how to keep children and themselves safe but also to give parents the peace of mind they need when leaving their children at home with a sitter.

# IT TAKES KNOW-HOW TO MAKE NEW YEAR'S **R**esolutions, **W**ILL Power to KEEP THEM

New Year's Day brings the urge to change things. Your life, your health, or how you work, are popular choices. Before you get carried away, however, decide whether you're making a wish list or real resolutions. When it comes to things that are hard to do, make only one or

two resolutions. In reality, you couldn't quit smoking, lose weight, stop cussing, and get all your work done every day, not all at the same time.

A study by psychologists at the University of Washington shows that most people keep the promise they put at the top of their list, at least for a month or two. People who thought seriously about their resolutions were more successful than those who come up with them at the last minute.

The researchers found that people are more willing to do something good than to give up something that's wrong. They found that 84 percent started to exercise, the most common resolution to do right. Only 7 percent wanted to reduce the use of tobacco or alcohol. Word your number one resolution carefully. Instead of saying you are going to relax more, say you are going to explore different ways of relaxing. You are likely to fulfill the resolution by experimenting with techniques.

Make a written plan. For relaxing, you might plan to surf the Internet for different techniques. Make a list of all you find and try a new one each month.

Columnist Ann Landers came up with a big list of "good" resolutions, a few of which you might like to try, such as:

\* Lighten up. Ask yourself, "Will it matter a week from today? Or next vear?"

\* Be a friend, we need each other. . Don't discourage a beginner.

\* Walk tall and smile more.

\* Don't be afraid to say, "I love you."

\* Don't give up your principles.



mitted prices for a snow plow to be mounted on the grass buggy. Council accepted the offer from W. A. Jones for \$4,368.


Bice also reported quotes for repair of the road grater, expected to be approximately \$13,000. Council approved the repairs.

# **USPS** Fraud Tips

Though the holidays bring out the best in people, they sometimes bring out the worst. All year long, and especially during the holidays, the United States Postal Service reminds customers to be on the lookout for those who prey on unsuspecting and trusting folks.

Every year, illegal telemarketing and mail fraud schemes rob consumers, often elderly citizens, of their hard-earned life-savings. If someone contacts you or a loved one with an unsolicited offer: \* Don't give your financial information to callers you don't know. \* Don't be pressured into making

an immediate decision. \* Get all information in writing before you agree to a purchase.

Additionally, if you are contacted by a person or persons presenting themselves as postal employees, they should be in a postal uniform and/or be able to present a Postal ID with their photograph on it. If you are uncomfortable for any reason, do not open your door. Ask them to leave the item on your porch for later retrieval. You could also call your local post office and speak to a supervisor to confirm the individual's identity.

Always remember, If it sounds too good to be true, it probably is. An unbelievable sounding deal probably is not true. Protect yourself from becoming the victim of such fraud by remembering the following tip-offs:

\* High-pressure sales tactics. A swindler often refuses to take no for an answer; he has a sensiblesounding answer for your every hesitation, inquiry, or objection.

\* Insistence on an immediate decision. Swindlers often say you must make a decision "right now," and they usually give a reason, like, "The offer will expire soon."

\* You are one of just a few people eligible for the offer. Don't believe it. Swindlers often send out hundreds of thousands-and sometimes millions-of solicitations to consumers across the nation.

\* Your credit card number is reguested for verification. Do not provide your credit card number if you are not making a purchase, even if asked for it for "identification" or "verification" purposes, or to prove "eligibility" for the offer. If you give your card number, the swindler may make unauthorized charges to your

account, even if you decide not to buy anything.

\* You are urged to provide money quickly. A crook may try to impress upon you the urgency of making an immediate decision by offering to send a delivery service to your home or office to pick up your check. This may be to get your money before you have a chance to think carefully about the offer and change your mind, or to avoid the possibility of mail fraud charges in the future.

\* You are given no detailed written information. If you must send money or provide a credit card number before the telemarketer gives you the details in writing, be skeptical. 00 not accept excuses such as. "It's such a new offer we don't have any written materials yet," or "You'll get written information after you

\* You are asked to trust the telemarketer. A swindler, unable to get you to take the bait with all of his other gimmicks, may ask you to "trust" him. Be careful about trusting a stranger you talk to on the phone.

\* You are told you have won a prize, but you must pay for something before you can receive it. This payment can either be a requirement to purchase a minimum order of cleaning supplies or vitamins, or it can be a shipping/handling charge or a processing fee. Do not deal with a promoter who uses this tac-
