COUNCIL NOTES

The Warren Town Council met at 6:30 p.m. Monday evening, December 13 in Assembly Hall. President Bill Cartwright conducted the meeting.

Final steps have been taken to file for a planning grant with the office of Community and Rural Affairs for a study of the wastewater / stormwater system to reduce infiltration and inflow into the Sewer Plant. The amount of the grant is \$40,000. Request for proposals for engineers has been published and sent to firms. The study will also include the underground waterway located under Second Street and plans for redirecting stormwater lines that flow into it.

A general engineering contract with Commonwealth Engineers. The contract allows the Town to have consulting contract with the firm while specific projects would be handled individually.

Contact with Wabash Central Railroad continues over repair to the crossing arm system on State Road 5 which was damaged when a Warren Utility worker cut an electrical cable. The last estimated cost of repair was set at \$32,000. The first estimate was \$10,000. While the railroad has asked the town to handle the project, President Bill Cartwright stated that the request would not be approved as the Council has no expertise with railroad equipment. The matter has been turned over to the Town's insurance company. The Council concurred with requesting Railroad authorities to handle the project and further contact will be made with the insurance company.

An invoice from Huntington County United Economic Development was submitted

and approved in the amount of \$1850.00

Also approved was a contract for 2011 in the amount of \$3700.00, two payments of \$1850.00.

Ordinance 2010-7 was introduced. The Ordinance would raise Sanitation rates to \$8.50 from the current rate of \$6.25 due to the increase in the contract amount. A public hearing was set for December 27 at 6:30 p.m. H&H Disposal will be the contract hauler beginning in January of 2011.

Due to the Indiana Association of Cities and Towns were approved in the amount of \$1,000.00. The annual dues are used to provide training opportunities and legislative programming for municipalities throughout the state.

Reviewed was a matter going to the Warren Area Board of Zoning Appeals regarding placement of a remediation trailer behind Huggy Bear at the corner of Matilda and Wayne Streets. The trailer is to be placed by the Indiana Department of Environment Management to monitor levels of contaminate in soil. Council gave no recommendation to the matter.

Clerk-Treasurer Morrison reported that the 2011 Municipal Budget had been right on target with only minor decreases in certain funds due to less revenue available than what had been projected. Total decreases amounted to just under \$3,000.00 and will be absorbed by operating balances in those funds. The Cumulative Fire Fund saw a reduction of \$4.00 while the Cumulative Capital Development fund saw a deduction of approximately \$1,400.00. Other deductions fell in that range.

Utility Manager Day noted that purchase of a small Dump Truck was scheduled for 2011 in the Comprehensive Financial Plan and that the search had started. Council members requested that Day get quotes for a new vehicle as well as for late model

used vehicle with low mileage. The truck will be fitted with a snow blade as well.

The next Council meeting will be December 27 at 6:30 p.m., a Public Hearing.

VB COUNCIL

On Wednesday evening, December 15, the Van Buren Town Council held their last meeting of 2010.

President Tony Manry conducted the meeting which opened at 7 p.m. All in attendance repeated the Pledge to the American Flag. Officer Pat Collins presented the Police report. He said All offenders of the junk car Ordinance had complied.

Superintendent Jim Webb gave his report. He said that due to recent snows they were unable to read meters in December. For this reason the January bills will be estimated.

He also noted that he had noticed a number of open crawl spaces at various homes. He reminded this causes frozen water pipes.

The Department of Transportation has been assisting in putting up new Railroad signs and other signs around town.

Council has issued a reminder that there is a limit of six trash bags per week. The trash company will no longer pick up the additional bags.

The Council says: Merry Christmas and Happy New Year.

"Buying toys for children can be an exciting time for both parent and child," said Joan Duwve, M.D., medical director of injury prevention, Indiana State Department of Health. "But it can also be confusing. Choosing toys which are developmentally appropriate and safe for your child will help prevent frustration and injury. Toys intended for older children

can prove life-threatening in the hands of a toddler."

Thanks to an increase in federal regulation, toy-related fatalities and toy recalls have steadily declined since 2008, according to a recent report by the Consumer Product Safety Commission. However, toy-related injuries are on the rise. In 2009, there were an estimated 186,000 emergency room-treated injuries nationwide related to toys with children younger than 15, which is up from 152,000 injuries in 2005.

The Consumer Product Safety Commission has put together four simple tips to consider when purchasing toys for a safe holiday.

- For children under three, toys with small parts can cause choking. To determine whether a toy poses a choking risk, try fitting it through a toilet paper roll. If a toy or part of a toy can fit inside the cylinder, it's not safe.

- Select toys to suit the age, abilities, skills, and interest level of the intended child.

- For children under eight, avoid toys with sharp edges and electric toys with heating parts.

- Look for labels with age and safety advice, and use these as a starting point when selecting toys for your child.

Safety doesn't end once the gifts are wrapped and ready to be enjoyed. Keep wrapping and packaging materials away from little hands by immediately discarding once gifts have been opened. When play time has begun, supervise children to make sure they are using their gifts appropriately. Safety gear, including helmets, pads and protective eyewear should be used appropriately when playing with sports-related or riding gifts, such as scooters and bicycles.

"By just playing with your kids, you can teach them how to play safely while having fun," Dr. Duwve said. "Remember, finding that perfect gift for your child means giving them something that is both fun and safe."

TYPE O NEEDED

As a result of the recent bad weather across our region, during this holiday season, the local blood collections have decreased. Type O negative blood is especially needed now.

"Winter weather caused four blood drives cancellations in our area last week, representing nearly 180 units of blood that could not be collected. Across our three-state Red Cross division, 37 blood drives have been cancelled, resulting in more than 1,500 units of blood that were not collected," states Sharyn Whitman, CEO of the Indiana-Ohio Region of the American Red Cross. "We encourage eligible donors, particularly those with type O-negative blood, to call 1-800-RED CROSS or visit redcrossblood.org to find a convenient blood drive location."

Since type O negative blood can be used for any patient when there is not time to determine the patient's blood type, it is crucial that there be a sufficient supply.

The holidays are a critical time for blood donation. Without winter weather impacts, this time of year is difficult to collect blood because people are busy with holiday plans, shopping and family events. But every day, regardless of the season, hospital patients need blood or platelets for cancer treatments, lifesaving surgeries, or emergency care related to accidents or trauma.

Your help is needed to replenish the blood supply. Schedule your appointment to give blood through the American Red Cross today and help save lives. Call 1-800-RED CROSS or visit redcrossblood.org.

When you come to donate now through Jan. 1, you will be entered to win a weekly region-wide drawing for a \$250 Visa gift card!

"Why, of course boys can't have a good time without sleds,"

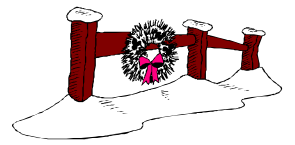

over the hard crust in their queer sleds. And the boys shouted and swung their hands as they flew past the window.

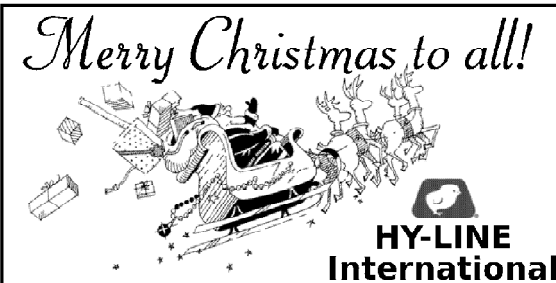
"I do expect they'll wear 'em about through," murmured grandma; "but boys must slide,—that's certain."

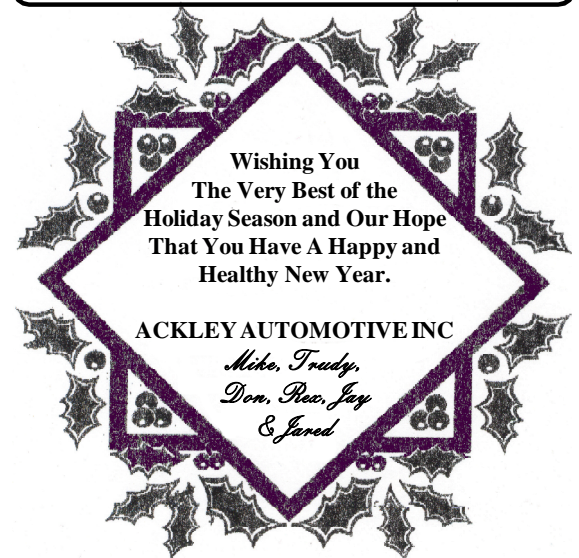
to see Job Easter that night. He promised to make two small sleds for the pair of socks she was knitting.

learned what God must feel like to have the gift that He sacrificed so much to give be rejected and scorned. How hurtful to take away the blessing of giving from someone or to reject their gift. Yes, it seemed to be popular to say, "We can't afford to exchange gifts this year", but it didn't matter. She would continue to love, sacrifice and give, always following her heavenly Father's example.

The above story is fictional but I wrote it because within a week's time I've heard so many people say, "We aren't exchanging gifts because we can't afford it". What was even more shocking was these words came from people who typically made more money in one week than I did in one year and yet I, with so much less income seemed to have no problem buying gifts for my whole family.

When I commented about this to my son, he said "Mom, what you don't realize is that a lot of these people feel like if they can't spend \$400 or more on each person, they can't afford it so they just don't give at all." Once again, I see it is all in the way you look at things. If you are feeling that you can't afford Christmas gifts this year you may want to do some soul searching. Don't let pride stand in the way of giving gifts to your friends and family. Instead of saying "We can't afford it" which seems to be the acceptable and politically correct thing to say, be honest with yourself and others. Is there somewhere you could sacrifice something? If circumstances in your life have changed then maybe you could just say "I can't afford to give what I used to give but I love giving gifts and I still want to exchange. I just can't spend as much".

Make sure you are not just saying the words "We can't afford it" because you are tired of the hassle of shopping and trying to figure out what people want. We don't want people to think less of us so we say "We can't afford it" because that sounds nicer than "I don't want to bother with finding you a gift".

If you feel that way, then it may be that your gift giving is getting out of hand. Are you buying gifts for your hairdresser, garbage man, mailman, babysitter, and your third

cousin's fourth removed son? No wonder you are frazzled. You don't need to explain anything to these people. Just stop buying gifts for people that aren't close to you.

If you don't want to mess with the gift exchange at work, just politely say you can't do it this year. If you still feel like you have to give something and can't say no then buy one inexpensive gift to give everyone. For example I know a woman who buys several gingerbread men every year and gives them as gifts. Young and old alike love them and they are gender friendly. They don't cost a lot and it saves wear and tear on her nerves trying to find that perfect gift for someone she doesn't know very well.

Seriously think through your gift giving and your reasons for or against it. Remember it really is the thought that counts and not the expense. If you don't think that is true, then why is it that the present your child spent \$1.00 of their hard earned money on and much time and energy picking out, means more than a very expensive gift given to you out of obligation by someone you don't know very well?

I know there are times when you really and truly can't afford to exchange gifts or maybe because of extra large families or combined families you need to draw names. That is fine. The above story isn't describing you. You know your situation better than I and you don't have to explain yourself to me or anyone else. Who I am talking about though, are those who sit in their favorite restaurant, where nothing on the menu is under \$15, with a days worth of shopping for new clothes for themselves (\$100 pair of shoes, \$200 purses, \$60 name brand jeans) sitting at their feet while they call to say they can't afford to buy Christmas gifts for anyone.

Check your motives carefully and this Christmas buy your gifts with your heart and not with your pocketbook.

1 cup shortening, 1 cup granulated sugar and 1 cup brown sugar, cream together and add 2 beaten eggs, 1 teaspoon vanilla, sift 1 1/2 cups flour, 1 teaspoon soda, 1 teaspoon salt, add to it 3 cups rolled oats, 3/4 cup coconut, mix well in to shortening mixture and form into rolls and chill slice and bake a 350 for about 8-10 minutes.
