To the Editor:

I am a proud member of the Huntington County Concerned Citizens (HCCC) group. Over the past few months, we have been working hard to inform folks of the terrible aspects of Industrial Wind Turbines. We have utilized various methods such as letters to the editor, documentary film showings, personal contacts with citizens, elected and appointed county officials, and by way of our popular website www.huntingtonccc.org to present the acts about this issue in a fair, open, and honest way.

Several weeks ago, we hosted a showing of the documentary "Windfall" in the town of Warren to a standing-room-only crowd. As a result of that showing (as well as a previous showing at the Huntington City-Township Public Library), many people requested and were furnished yard signs proclaiming 'No Wind Farm.' At least 100 signs were placed throughout the city and county, not counting those requested and placed after the 'Windfall' showings.

Recently, it has been noted that most of these signs have mysteriously come up "missing." We don't know if they have been stolen, destroyed, or otherwise removed and we don't know who's responsible. Names have been provided us including that of a group that

EXTENDED HOURS

Don Snemis, Commissioner of the Indiana Bureau of Motor Vehicles (BMV), announced that BMV license branches will extend hours of operation on Monday, May 5 and Tuesday, May 6 to issue state ID cards and driver's licenses to provide voters with credentials for use at polling locations.

Branches will be open on Monday, May 5, from 8:30 a.m. to 8 p.m. and Tuesday, May 6, from 6 a.m. to 6 p.m. To ensure voters have immediate access to services, license branches will only process ID cards, driver's licenses and learner's permits. Driver's tests will adminisnot be tered.

The Indiana BMV provides free, state-issued ID cards for voting purposes to any unlicensed Hoosier, as long as he or she can provide proper documentation and will be old enough to vote in the general election. The following documents are required to obtain a new state ID card or driver's license. A complete list found can he at www.mybmv.com.

One document proving your identity, such as a birth certificate or passport

One document proving your Social Security number, such as a Social Security card, pay stub or W-2

One document proving your lawful status in the United States, such as a birth certificate or passport

 Two documents proving your IN residency, such as a voter registration card, utility bill or bank statement

All license branches will resume normal business hours and operations on Wednesday, May 7. Branches normally closed on Wednesdays will re-open Thursday, May 8.

Local farmer John Maddox has directed a \$2,500 donation to the Southern Wells High School Athletic Department. Funded by America's Farmers Grow Communities, the donation will help the school purchase uniforms and upgrade the athletic department.


