BOXCAR CHILDREN AT THE PULSE

The beloved story by Gertrude Chandler Warner is coming to life on the Pulse Opera House stage. The Boxcar Children, read by millions all over the world, tells the story of the recently orphaned Alden children's attempt to preserve their family. Alone and fleeing from what they fear will be separation from each other, the children turn an unused railroad boxcar into a home. With a huge reward on their heads they are determined to elude the pursuit of the authorities and a mysterious stranger. Coping by themselves in a seeming wilderness the children discover resources within themselves that they did not know they had. They also discover what it truly means to be a family and to take care of each other. Originally presented at Seattle Children's Theatre, the show by playwright Barbara Fields has delighted audiences around the country.

HIGH SCHOOL ART

Huntington University will host a high school art exhibit from March 7-28 in the Robert E. Wilson Gallery of the Merillat Centre for the Arts.

"We wanted to provide an opportunity for regional high school students to have a professional quality exhibit to showcase their work," said Rebecca Coffman, professor of art. "It's also a great opportunity to introduce them to Huntington University. Most importantly, we want to celebrate the visual arts being created by high school students in this area."

The competition is open to high school students within a 150-mile radius of the University. The deadline for entries is 5 p.m. on March 3.

High school seniors may compete for the Huntington University Department of Visual Arts 2007-2008 Performance Grants. The grade point average minimum is 2.5 overall and 3.0 in art classes. Performance grants are available to students intending to come to Huntington as full-time art majors. Along with GPA, portfolios are considered. In exchange for the award, students work in some type of service role for the Department of Visual Arts such as a student assistant or gallery assistant.

The exhibition awards will be juried by Huntington University Department of Visual Arts faculty including Rebecca Coffman, professor of art, and Andrew Dickson, assistant professor of art. Best of show, first place, second place and third place awards along with cash prizes will be given.

The awards reception will be held from 6 to 7:30 p.m. on March 10.

The high school art exhibit is open to the public. The Robert E. Wilson Gallery is open weekdays from 9 a.m. to 5 p.m.,

CORNELL SCHOLARSHIP

High school seniors who will graduate from an Adams, Allen, or Huntington County school are invited to apply for the Dr. Beaumont S. Cornell Scholarship at Indiana University-Purdue University Fort Wayne (IPFW). The renewable \$2,000-3,000 per year scholarship is for pre-med students only. The deadline to apply is March 31, 2007.

Those students coming to IPFW directly from high school must either rank in the top 25 percent of their class and have SAT scores of 1870 or greater, or ACT composite of 28 or greater; or rank in the top 10 percent of their class and have SAT scores of 1650 or greater, or ACT composite of 24 or greater. These students must also be admitted to IPFW by

4-H LICENSE PLATES

Have you ever wanted to purchase a 4-H license plate, but could never remember to send in the authorization form in advance of buying your annual plates? With the 4-H plate moving to "trust" status, the Indiana 4-H License Plate is now available at the Bureau of Motor Vehicles and can be purchased without securing advance paperwork. 4-H License plates can be purchased for cars, vans, trucks and motorcycles so you can support 4-H with a variety of vehicles. Ask for a 4-H license plate when you go to renew your plates at the Bureau of Motor Vehicles (BMV), either in person or via the BMV website.

Since the 4-H plate is a specialty plate, there will be an additional \$40 fee to pay at the time of purchase at the Bureau of Motor Vehicles. Of that fee, \$25 goes to the Indiana 4-H Foundation and is a tax deductible contribution, with \$10 returned to the county in which you reside to benefit local 4-H programs.

This is a great opportunity to support 4-H every day and to continue the tradition of "Making the Best Better."

For youth ages 16 to 18, an apprentice program also will be offered at the same time. Apprentices are students with theatre interests that assist with facilitating the camp. They will work more closely with the camp directors and serve as assistant directors, assistant choreographers, stage managers and assistant designers. The cost, dates and times are the same for the apprentices as they are for the younger campers.

The theatre arts camp is building strong relationships with the Huntington County Community School Corporation and the LaFontaine Arts Council.

"These groups see the need for a strong arts-oriented summer program in Huntington County," said Mike Burnett, assistant professor of theatre. "They offered valuable advice to us for our first camp last summer, which presented 'Music Man Junior.' Both LAC and the school corporation are excited about that possibility and how it can strengthen the youth of the Huntington area."

David and Kristi Shamburger, Huntington University theatre faculty, will serve as co-camp directors. The Shamburgers created and directed summer youth musical theatre camps in Georgia and have experience with the Nevada School of the Arts youth theatre programming. Mike Burnett, assistant professor of theatre at Huntington, has worked in youth programming throughout the United States and will serve as camp technical director. In addition, three Huntington theatre students will serve as mentors.

After six years of running a theatre arts camp while teaching at Middle Georgia College in Georgia, the Shamburgers came to Huntington and were surprised to find that the University did not have a similar program.

"We have the facility, the means, the personnel to do a top-notch arts camp," said David Shamburger, assistant professor of theatre. "It's a necessity to offer the arts to the community, sort of an outreach program. We want to build a bridge with the community, and the best way to do that is to connect with children."

In addition, Shamburger hopes the camp will help promote the University's Department of Theatre Arts, assist Huntington theatre students by providing camp positions, and most importantly, impact the local community for Christ. "We are a Christ-centered university, and everything we do is through Him," he said.

While in Georgia, Shamburger and his wife Kristi, a member of the university's adjunct faculty,

led campers in full-fledged productions of musicals such as "Music Man," "Guys and Dolls," "Fiddler on the Roof," "Wizard of Oz" and "Li'l Abner." Intensive rehearsal taught children to sing, dance and act.

Shamburger says the Huntington University camp is a great opportunity for youth to work with real theatre professionals. "Both my wife and I are actor union members and professionals, and Mike and Ella Burnett are also professionals in the field. It's great for kids to not only do theatre, but to do theatre with professionals."

Shamburger most enjoys the enthusiasm and passion of the young actors. "To them it is magic," he said. "I always try to get my actors to return to a sense of play. The children still have that, and it's nice to work with."

QUILTING HISTORY

Quilts can tell as much about American history as some books.

Find out how March 10, when quilt historian and published writer Leigh Fellner presents a free talk at the Indiana State Museum in Indianapolis, in the Dean and Barbara White Auditorium, at 2 p.m.

The author of Betsy Ross Redux: The Underground Railroad "Quilt Code," will discuss the history of quilts, the roles they have played in our society, and the code explored in her paper. The code was introduced to the general public in various books published in the late 1990s and early 2000s. Her extensive research examines the code's inconsistency.

The author will also talk about the many ways American women have used quilts to warm both body and spirit during the past two centuries, and how examining fabrics, assembly techniques, and designs can help people better understand the era in which a quilt was made. Attendees are encouraged to bring their historic quilts.

Fellner is currently researching West African textiles of the slave trade era. Her Web site is www.hartcottagequilts.com.

FISHING REGULATIONS

There is a two-page fish identification guide and maps that show locations of state parks, reservoirs, forests and fish and wildlife areas.

- Boating and life preserver rules.
- Controlling aquatic nuisance species
- Entry forms for the state record fish and fish of the year programs.

Let's just say I was persistent in my quest to get organized and along with that persistence I used the consistency of doing one thing every day to help me find the peace that I knew was out there! It worked for me and it has worked hundreds of thousands of people as well. When you find something that works you stick with it. We don't try to reinvent the light bulb every time we screw one in a socket; we trust it and don't waste our time trying to improve on it. We are very creative people and we love to do things our way or shall I say try to make better a system. This is when we skip the foundation baby steps. I am giving you a light bulb that works! Trust it and take the first steps of shining your sink and being nice to yourself. As you establish the basic habits you are going to begin to feel your light shining brightly! With your habits established you are free to follow your dreams and use your creativity in ways that bless you instead of ways to sidetrack you. You can't skip the most important steps of Persistence and Consistency.
