#### **UPTOWN GARDNER - RECIPE CORRECTION**

Sorry folks but I really goofed on the recipe for pumpkin pie last week. I hope none of you ventured into making it yet. I guess I really needed a vacation after all. Here is the recipe with directions. Pumpkin Pie

11/2 cups pumpkin canned or cooked fresh

1/4 cup white corn syrup

2 eggs slightly beaten

1/2 cup evaporated milk

2 tablespoon butter

1/2 cup hot milk

1/2 cup brown sugar

1/2 teaspoon salt,

1 1/2teaspoon cinnamon

1/2 teaspoon nutmeg

1/4 teaspoon ginger

1/8 teaspoon cloves

1 unbaked 9 inch pie shell

Combine pumpkin, corn syrup, eggs and evaporated milk. Stir butter into hot milk. Combine brown sugar, spices then combine pumpkin and hot milk with sugar and spices blending well. Pour into the pie shell and bake in hot oven 450 degrees for 15 minutes reduce heat to 350 and bake for about 35 minutes or until knife inserted into center comes out clean.

## AREA NEWS

#### SPECIAL MEETING

The Warren Town Council held a special meeting on Monday evening, Oct. 9 at 5 p.m. Council metwith Jim Lauer from Schnelker Engineering Company to discuss plans for the Streetscape project, expected to get underway next spring.

Lauer presented Council with blueprints of proposed changes to be made in the downtown area. The project is expected to in-clude a new water main downtown, new sidewalks and street lights.

Council has agreed to purchase materials for the project, with work to be done by contractors.

Once a total estimate of cost is determined, a Grant is expected to be applied for.

It is believed the project can be completed in 90 days.

#### COUNCIL NOTES

At 6:30 p.m. Monday evening, Oct. 9, President David Scheib called the regular meeting of the Warren Town Council to order. The meeting was held in Assembly Hall.

Minutes of the regular meeting of Sept. 28 were approved as submitted.

Citizens in attendance were concerned about junk cars and prop-erties cluttered with trash on College, Jefferson and Hendricks Streets. There was also a problem about a semi often park-ing in the street, sometimes at angles which poses a problem.

There are currently no restrictions about parking in that area. Council agreed to take the matter under advisement.

Salary Ordinances were taken under consideration for adoption. They included: Ordinance 2006-11, utility and part-time; Ordinance 2006-12, elected and appointed officials; Ordinance 2006-13, law enforcement; Ordinance





2006-14, amendment to town code, Fire Department. Council agreed to adopt all Ordinances.

A WHARMM meeting was scheduled for Oct 16 in Markle at 6:30 p.m.

Ordinance 2006-2 (amended) was reintroduced. A Public Hearing was set for Oct. 23 at 8 a.m. Council agreed to sign a water connection agreement with Crazy D's Truck Stop.

A report was given on the 5 p.m. special meeting with Jim Lauer. The Clerk-Treasurer's report included the September financial report.

The Utility/Street Departments report was given by Curtis Day.

A storage building has been constructed. Crews are picking up leaves. Day was given permission to dispose of an old gener-ator no longer used.

In a report from the Fire Department, one member had taken a leave of absence and one member had resigned.

Town Marshal Dennis Spitler presented monthly activities report to Council.

The formal part of the celebration will begin with a program at 1:30 pm and will include a flag raising by VFW Post 2689, introductions of key courthouse officials, a portrayal of Teddy Roosevelt, and musical entertainment. The courthouse will also be open for tours.

The celebration will culminate in 2008 with a dedication ceremony, as historian, Joan Keefer, has been unable to find any records to show that the Huntington County Courthouse had ever been formally dedicated. If anyone has any documentation to prove otherwise, please come forward with this documentation immediately.

Huntington is named for Samuel Huntington, who signed the Declaration of Independence, and became President of the Continental Congress under the Articles of the Confederation. The courthouse has been the site of the Bush/Quayle presidential kickoff campaign. Bobby Kennedy and Teddy Roosevelt both got off the train here next to the courthouse while campaigning.

A "Friends of the Courthouse" organization has been established and is seeking memorabilia and stories from the last one hundred years. Anyone that would like to share their stories with the committee should write them down and contact Mel Ring at 260-356-7471 or Rose Meldrum

at 260-359-8687. Anyone that would like to donate towards the event can mail their check to the Friends of the Courthouse in care of the Huntington County Commissioner's at 201 N. Jefferson, Room 103.

#### Receives Funding

For the first time in five years, local units of government across the state today received direct state support for their bridge and road projects. The first of two \$75 million motor vehicle highway fund (MVH) distributions to all 92 counties through Governor Mitch Daniels' Major Moves initiative was completed today.

"The huge transportation shortfall Major Moves addressed was not state government's problem alone. From my travels to cities and towns across the state, I've seen firsthand the need to help local governments address their own infrastructure needs," said Daniels. "Companies looking to locate in Indiana don't care whether the roads they would use bear a federal, state or local designation. First class transportation infrastructure at all levels is vital to our future economic comeback."

The governor proposed the MVH distribution when he announced the Major Moves program in January. Counties, cities and towns

had not received such funding for local projects for the past five years. The funds are being distributed based on the current motor vehicle highway fund formula. The state transferred the first \$75 million to local governments today via electronic transfer. The second \$75 million will be distributed next year.

These funds are on top of the more than \$10 billion the state will spend on new construction, major preservation, and resurfacing projects across the state over the next 10 years.

The share of the funds that local units of government in Huntington County received is \$625,920.71.

Here's how the Huntington County funds will be distributed by the county auditor: \$470,049.64, Huntington County, \$8,850.46, Andrews, \$119,721.39, Huntington, \$7,560.63, Markle, \$754.69, Mount Etna, \$10,256.93, Roanoke, \$8,726.97, Warren

The counties and cities can use the MVH funds as prescribed by IC 8-14-1-3, which includes construction, reconstruction, and maintenance of highways, roads and bridges and the purchase or lease of highway equipment, among other things.

In June, the state received \$3.8 billion for a 75-year lease to the Indiana Toll Road Concession Company to manage and operate the road. Since July 5, when the State Treasurer invested the money, the state has earned more than \$52.5 million in interest at an average rate of 5.46 percent.

Vier C. Ditzler Sr. started making ice cream in 1906 when his father, J.F. Ditzler, had a store in Montpelier. From 1912 to 1916, Mr. Ditzler operated an ice cream plant in Huntington and after World War I he worked in a Warren ice cream firm. In 1924, Vier started The Warren Bottling Works in the building beside the Warren Library where Ray's TV store is. More about the Warren Bottling Works in a later article.

In 1928, J.F. Ditzler purchased a twin building on Wayne Street which accommodated two business stores, one of which had an ice cream plant. After purchasing equipment and fixtures from Frank Andrew, Vier Ditzler Sr. opened an ice cream parlor in the front of the store and started manufacturing Nu-Way ice cream in the back. Nu-Way ice cream was manufactured in a large screened-in area which featured a cement floor. At engallon freezer

was located in this space and later a silver and nickel plated Cherry-Burell freezer was purchased. The dasher blades on the more modern machine could whip up the mix into ice cream in about twenty minutes. A salt brine tank was used in the early process and was later replaced by a more modern method.

Sometimes the making of ice cream would last an entire day. The soft ice cream had to be takento a hardening cabinetwhich took two days for the product to freeze properly. Due to his expertise from years of experience, Mr. Ditzler could tell by sound when the ice cream was done. A five gallon container, quarts and pints would be filled from the batch. Plain flavors would be made first and then followed by nut and fruit flavors.

While vanilla, chocolate, strawberry and lemon flavors of ice cream were always featured, Mr. Ditzler created many distinctive flavors such as honeymoon and orange pineapple. He made butterscotch and caramel flavors, in addition to nut varieties which were always popular and in demand. In all, about 25 kinds of ice cream were manufactured. For years, pints sold for 15 cents;

quarts were 25 cents and two dips cost a nickel. Many customers asked for a double dip cone with four dips of ice cream for a dime. The Nabisco Company said the Nu-Way ice cream parlor was one of the largest cone users in northern Indiana.

On Wednesday and Saturday evenings, the Warren merchants remained open until 9:00 p.m. local merchants often brought their instruments and gathered around the piano. They entertained the customers who came for ice cream, malts, sundaes, banana splits, or a popular item, a bottle of pop and a dip of ice cream served in a glass—a pop soda for five cents.

Among the familiar sights on Wayne Street were the two large cement ice cream cones which stood on each side of the entrance. These cones were made in Eaton, Indiana by a man who did custom cement work. They were to be a cone with two dips. but it was decided this design would be top heavy and unsafe. Instead a single dip was molded and a space fixed for a glass globe to represent the trademark of the candy placed on every cone sold. These cement cones were electrically wired and a small red light bulb made the cherries
