KUDOS, KICKS & KARATS

THE UPTOWN GARDENER

I think we are finally having some hot sticky good ole Indiana summer weather. Perhaps this will give a boost to the lagging crops and gardens. If this helps I will try not to complain about the weather.

Finally the Early Girl tomatoes that normally ripen in early July are now ripening good. The green beans are producing well. This year I planted a variety called Jade they are a very good producer. I know for sure next year I will be planting that variety again. It is one type that stays nice green color after cooking and freezes and cans well and of a good flavor. From a 15 foot row I have canned 50 pints and they are still blooming.

We are enjoying nice fresh dug potatoes and onions and the kohlrabi is producing well.

In the garden the sunflowers are tall and full with bloom and the bright yellow finches are having their own feast on the seeds. They are so busy and singing their hearts out. It is nice to hear them.

Today I was checking the weather predictions in the Farmers Almanac and I find it interesting to follow. It was right on the button for today being one of the warmest for August. I enjoy reading the short stories and garden tips I find in it.

One story was about the old bull horns. I had forgotten about them. Dad had one stashed away in the barn, probably belonged to grandpa, my brother and I had no idea what the thing was or its purpose. We figured it was probably some kind of a bugle grandpa had while serving the Civil War. We knew it sure sounded like a mad bull. We cleaned it up a bit to be sure there was no mice nest in it and took it out to the pasture to play marching war games. We thought it strange our only cow at the time came running up to where we were. After a while she became bored with us and went back to the shady area. The next time dad talked to our neighbor who had cattle across the road from us, asked if he had seen anything unusual around that the cattle had torn down some fence as if they were trying to get away. Dad had seen the bull horn out and it began to make sense what was going on. We got a good drilling on what we were doing with it and we were soon aware of what could have happened if the herd of about 100 head of cattle would have come charging toward us. It was bad enough that our ole "Jersey" took a liking toward us. Don't know if dad ever told the neighbor what happened, but for sure we kids never told. And that folks is how we learned what a bull horn was used for and believe me they don't make very good music to march by.

I was asked by a reader for pickle recipes. Here is an easy one to make and nice to have on the shelf.

Crisp as Ice Cucumber Slices
 1/2 cup salt, 4 quarts sliced cucumbers, 8 onions sliced thin, 2 green peppers seeded and cut in thin strips, 4 cups sugar, 1 1/2 teaspoon tumeric, 1/2 teaspoon cloves, 3 1/2 teaspoon mustard seed, 4 1/2 cups vinegar.

Sprinkle salt over the thin sliced vegetables, mix and empty a tray

MAKING A PEACEFUL MOVE

Every summer many families decide to move to a new home. This move can be across town or on the other side of the country. Making the move in the summertime is easier on the children. Change is always difficult even in the best of times. Now with the job market and the housing situation many families are forced to downsize. Then we also have our parents deciding to get rid of their larger homes and move into something that fits their life in retirement. Some families are moving in together. Moving can be overwhelming and emotional! We can help you!

It all starts with making it fun even if you are not excited about the move. Your attitude is everything. If you think it is going to be hard it will be; if you imagine it being a breeze then your dream will come true! What you think about you bring about!

Just 15 minutes planning your move is going to help you feel in control of the situation. Pour yourself a nice tall glass of lemonade, prop your feet up and get your notebook out. We are going to build your Moving Control Journal.

You will make lists of things to get done. We all love lists but instead of this being one big random list that goes on for ten pages we are going to break this move into baby steps. Place a heading at the top of each page. As you think of things you can flip

to the page it goes on.

Things to do in the new location: Turn on power, telephone, television, gas and any other thing you can think of like cleaning carpets and painting. Just the basics; don't get caught up in your perfectionism before you even get there. It doesn't have to be perfect! Progress not Perfection!

Things to do at your current location: Turn off power and other utilities, get a truck, hire movers, declutter and PACK!

List things you will need when you get to the new location. This is usually the same things you needed the last day in your old house; coffee pot, sheets, towels, clothes, toiletries, basic food preparation tools and food. The last thing on the truck is the first thing off. Plan it this way. Unless you are going to get to your new home way ahead of your moving van; then you will have to take this stuff with you! Think of it as going camping.

Make a list of things you need to make packing go smoothly; moving Control Journal, lots of same sized boxes, colored markers, colored note cards, lots of packing tape and several tape holders, duct tape (for labeling trash so you don't move it), bubble wrap, tissue paper and several boxes of big tough trash bags. I like the new unprinted newspaper sheets because the dishes will be clean when they go into the box and they will be clean when they come out. Keep a master list with your boxes numbered and color coded per room. This will help you put the boxes into the correct room at your new destination. Then you will be able to find stuff easily. Your job will be to direct traffic with your master list in hand and your color coded notecards posted over the door of each room. Please don't mark every

Ask SHIP

Q: I was just diagnosed with diabetes and have to test my blood sugar every day now. Will Medicare pay for the supplies? What else will it cover?

Generally, Medicare Part B covers the services that may affect people who have

diabetes. It also covers some preventive services for people who are at risk for diabetes. Medicare Part D covers diabetes supplies used for injecting insulin. You must have Medicare Part B and/or Part D to get these covered services and supplies.

Anti-Diabetic Drugs - used to maintain blood sugar, are covered by Part D. You will pay the co-pay and a Part D deductible may also apply.

Diabetes Screenings - Medicare Part B covers tests to check for diabetes for people with certain risk factors. These include high blood pressure, history of high blood sugar or if you have any two or more of the following:

- Are you age 65 or older?
- Are you overweight?
- Do you have a family history of diabetes (parents, siblings)?
- Do you have a history of gestational diabetes or did you deliver a baby weighing more than 9 pounds?

Self-Management Training - Medicare Part B covers outpatient training for people at risk for complications from diabetes or recently diagnosed with diabetes or recently diagnosed with diabetes to teach them to manage their diabetes. Your doctor or other health care provider must provide a written order to a certified diabetes self-management education program.

You will pay 20% of the Medicare-approved amount

after the yearly Part B deductible.

Diabetes Supplies - Medicare Part B covers some diabetes supplies, including blood sugar testing monitors, blood sugar test strips, lancet devices and lancets, and therapeutic shoes (in some cases). There may be limits on how much or how often you can get these supplies.

Insulin/ Insulin Pumps - Medicare Part D covers insulin that isn't administered with an insulin pump. If the beneficiary injects insulin with a syringe, Medicare Part D covers the syringes, insulin, alcohol swabs, and gauze. You will pay the co-payment and a Part D deductible may also apply.

Medicare Part B covers external insulin pumps and the insulin that the device uses under durable medical equipment for people who meet certain conditions. You will pay 20% of the Medicare-approved amount after the yearly Part B deductible.

of ice cubes in center of vegetables. Let set for 3 hours. Combine sugar, spices, and vinegar, heat to boiling. Drain vegetables thoroughly, pour hot syrup over them, heat over low temperature to scalding. Do not allow mixture to boil. Stir often to prevent scorching. Ladle into hot sterilized jars seal at once and process in boiling water bath 5 minutes. Makes about 5 pints.
