DON'T BE FOOLED

Don't be fooled by plans that don't meet Medicare guidelines.

Indiana Attorney General Steve Carter is alerting seniors that starting October 1, 2005, Medicare Prescription Drug Coverage Plans can begin marketing their products to the more than 922,000 Indiana Medicare recipients. Carter is urging seniors to be aware of certain marketing rules, including a prohibition of enrollment prior to November 15, 2005.

"Seniors will begin hearing a lot more about Medicare Prescription Drug Plans this month and they should be cautious if confronted with overzealous or unscrupulous sales tactics," said Indiana Attorney General Steve Carter. "Don't take someone's word for granted if they claim to represent a 'Medicare Approved' company; always double check to ensure the company is legitimate."

In order to protect themselves from fraud and potential identity theft, Medicare beneficiaries should familiarize themselves with certain guidelines and rules. Government approved prescription drug coverage plans will have a "Medicare Approved" seal on their materials. People who are legitimately working with Medicare cannot make door-to-door sales calls or send solicited emails; however they can call people about a plan as long as they follow the state's Do Not Call law.

Medicare recipients should not give out personal information (such as Social Security Numbers, bank account numbers, and credit card numbers) to plan representatives, because plans are not allowed to request such personal information in their marketing activities.

A Medicare provider is also prohibited from enrolling consumers into a drug coverage plan or from asking consumers to pay for a drug plan over the phone unless the consumer is

adding prescription drug coverage to a Medicare Advantage Plan or other Medicare Health plan already in place. Medicare providers won't ask for payment over the Internet, rather they are required to send a bill if a consumer enrolls online.

The new prescription drug coverage is effective January 2006 and is available to all Medicare participants regardless of their financial status. Low income seniors will receive extended benefits, but the average Medicare participant will receive a minimum of \$1,200 to \$1,400 benefit to their prescription drug cost.

"The bottom line is that a program like this is bound to attract con artists who will find ways to trick the public," Carter added. "The more we can spread the word about the possibility of fraud, the more we can help people avoid becoming victims."

Consumers should be aware the Social Security Administration (SSA) has contracted with NCS Pearson, Inc. and its partner, West Corporation, to conduct follow-up telephone calls to individuals who have not responded to its mass mailing of low-income subsidy forms for the upcoming Medicare prescription drug benefit.

When these calls are made, the callers will clearly identify themselves as employees of NCS Pearson and the West Corporation calling on behalf of the Social Security Administration.

The vendor will follow a closely monitored script designed to remind individuals about the importance of completing and mailing the application back to Social Security if the individual is interested in filing.

The vendor will not ask for any personal information such as Social Security numbers, dates of birth, income or resource information, etc.

If a Medicare beneficiary receives a call from someone claiming to be a Social Security

employee and is at all suspicious, they should:

Ask the caller for their name and telephone number to call them back.

Hang up and call Social Security immediately at 1-800-772-1213 (TTY 1-800-325-0778) to confirm that the call is legitimate.

NOTES EVERYWHERE?

Organize and Save with these new programs

If your desk is littered with yellow legal pads, note pads, and, of course, the ubiquitous removable sticker notes, then there is a new way of note taking that might just interest you.

A new breed of computer programs is on the rise that combines the letter writing ease of a Microsoft Word with the power of a database program to create a kind of endless, but organized, note.

In effect, you just write and keep writing and the program organizes it for you, automatically saving your work from note to note, topic to topic, day to day. Telephone notes, meeting notes, and vacation ideas are all saved and organized in one place.

EverNote for the PC and NoteTaker for the Mac are two programs of several available. They are helping computer users rethink the way they use their computers. They help users organize and save the diverse bits of information gathered in their daily lives.

Of course, you could write everything down on a regular word processing program. But with these "document model" programs, you end up with lots of little documents: Individual letters and notes.

With the endless note programs, all these items are in one file and you can do lots of things with them. You can organize bits under different topics, select parts to email, select other parts to print. You can store Web pages, pictures, sounds, even movies in some cases.

While these new programs might not work for more formal applications, they will help you organize projects. One example is genealogy notes. There are lots of program available to help you organize the family tree, but they often don't help with all the diverse notes you take in the research process. These programs will also let you paste in pictures as you go.

MEDICARE SEMINAR

The Warren Pharmacy will coordinate a Seminar that will focus on the new Medicare Part D Prescription Drug program. The seminar will be open to the public and will feature Twila Stech, a representative of the Senior Health Insurance Information Program (SHIIP). It will be held at the Knight-Bergmann Center in Warren, on Thursday, 20 October 2005 at 6:30 PM.

Beginning January 1, 2006, a new program will provide prescription drug coverage under Medicare. It will be a voluntary program, which provides Prescription Drug Insurance for all people who are eligible for Medicare. It will be administered through dozens of Insurance Companies and hundreds of different plans. Not everyone will need this coverage. Those who already have Prescription Drug coverage through their employer or retirement plan may not want, nor need, this coverage. People who have both Medicare & Medicaid will be automatically enrolled in a plan! Enrollment will not begin until November 15, 2005.

As with any Insurance plan, there will be Premiums, Deductibles and Copays. For now, the important thing to do is to become informed about the program and whether or not you should choose to enroll in a plan.

If you are a Medicare beneficiary with limited income and resources, you may be able to get extra help paying for prescription drugs under this program. You will need to apply now to Social Security to see if

The Social Security office in Wilkes Barre, PA has mailed out millions of applications to Medicare recipients, which it believes might qualify for extra help. If you have received an application and think you might qualify for this assistance, you must fill out the 5 pages & 16 questions and send it in. This does not enroll you in a Medicare Part D program. It will only allow you to know if you qualify for help

paying for your monthly premiums, deductibles and co-payments.

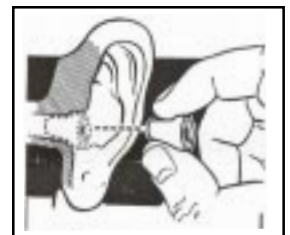

State health officials today reported that the U.S. Consumer Product Safety Commission and Dollar General Corporation of Goodlettsville, Tennessee have announced a voluntary recall of about 455,000 of the company's necklace and earring sets.

According to the U.S. Consumer Product Safety Commission, the jewelry contains high

levels of lead. Lead is toxic if ingested by young children, and can cause adverse health effects. Consumers should immediately take the recalled jewelry away from children and return to Dollar General stores for a refund.

Health officials warn that elevated levels of lead in blood are dangerous for children, especially for children younger than six years of age, whose developing brains are particularly vulnerable. In addition to

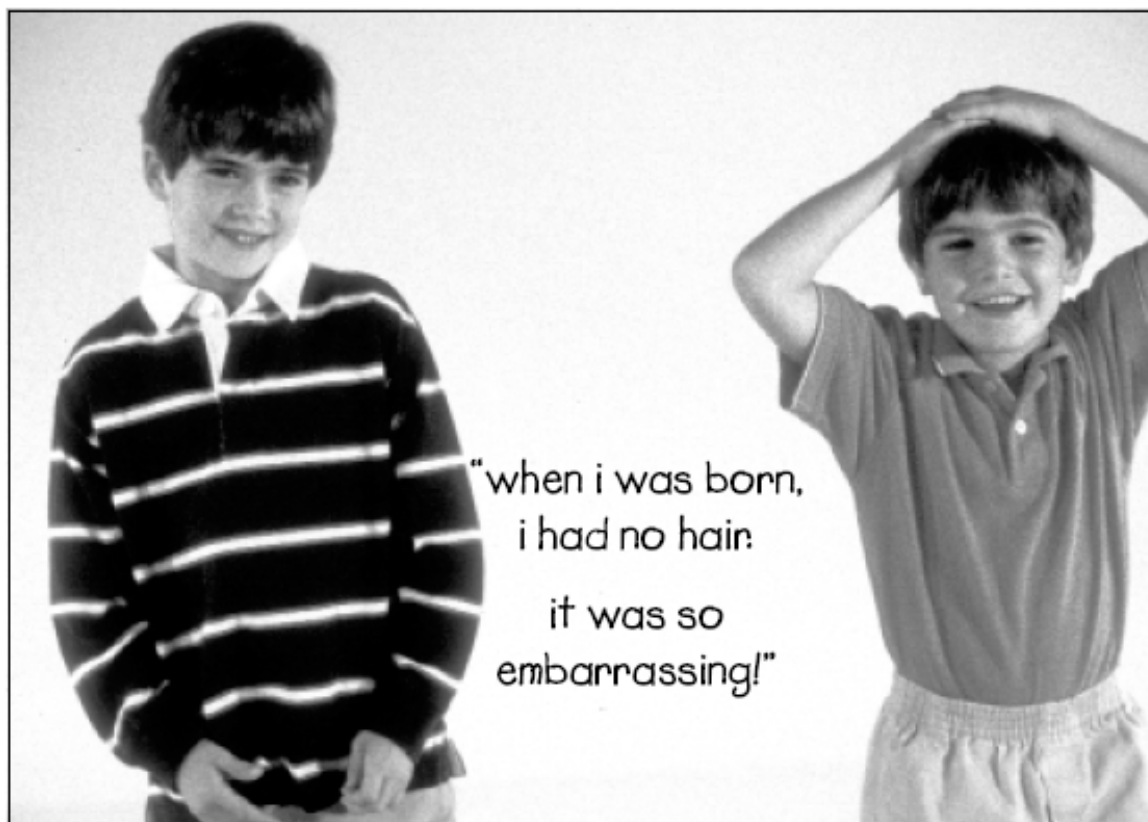
