NAIS:

WHAT'S THE LATEST?

You may have heard the news last month that plans were being scrapped for a national animal identification system (NAIS). Reports came across the Saturday morning farm programs that the United States Department of Agriculture (USDA) was essentially shifting responsibility of animal identification to the states. This change was made to allow states more flexibility in their approach to animal disease traceability.

So, how can a process of animal disease traceability help us in Indiana? A good example is the response of the Indiana Board of Animal Health (BOAH) to an incident in southern Indiana in December 2008. A cow with bovine tuberculosis (commonly called "TB") was traced to a herd

located on a Franklin County farm. Note that bovine TB is a chronic bacterial disease that affects primarily cattle, but can be transmitted to any warm-blooded animal. (More information about the results of 2008 TB case and the Indiana BOAH, can be found at this Web site: www.in.gov/boah/)

When an incident such as TB occurs, the Indiana BOAH responds by investigating cattle farms in a 3 mile radius. Bret Marsh, head of the Indiana BOAH, mentioned in a presentation last year that he simply draws a circle with a can on a map to aid in the identification of farms. State of IN veterinarians will then inspect farms and possibly test animals in the identified area.

There are certainly many questions regarding the USDA position on animal identification. The USDA Animal and Plant Health Inspection Service provided a fact sheet which helps address many questions. This factsheet can be found at the following Web site: www.aphis.usda.gov/traceability/.

One question that is addressed in the fact sheet is the use of radio frequency identification tags in the ears of animals as location identifiers for disease programs. These tags are commonly referred to as "840 RFID tags". In this fact sheet,

USDA-APHIS reports that "the 840 radio frequency (electronic) tag will be considered as a first choice due to ease of testing and recording/reporting information."

Note that each of the RFID tags has a 15 digit number on the outside of the tag. The first 3 digits of the numbers on all the issued tags is the U.S. code - 840. The code on the tags can be read either visually or electronically with a reader attached to a computer program. These tags are essentially tamper-proof and anyone who removes them prior to animal slaughter may be subject to penalties. It is important to mention that in Huntington County some 4-H cattle, sheep and goats will be tagged with the RFID tags as part of the enrollment process in 2010.

Teresa Steckler, University of Illinois Extension beef specialist, says many questions remain unanswered by the USDA in regards to national animal

identification. Per Steckler, "How will the USDA handle 50 different state programs and the myriad of individual animal ID that can be used? If data is stored by each state, how will the resources be secured to implement a new mandate? How will this data be handled for interstate transactions? Only time will tell..."
