tients. "You get attached to your patients just like family," he said.

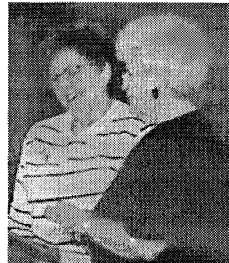

This years Samuel Jones Pioneer Award honoree is a Warren native, has been very active in civic affairs, graduated from Warren High School in 1965 and Ball State University in 1969 with a BS degree in Speech and Hearing. She was born in 1947, (now we are telling her age). We are very glad to honor Marilyn Morrison as this years Pioneer.

Marilyn was born on November 7, 1947 to Lloyd and Martha Morrison. She attended Warren High School all her school years and graduated in 1965. She then attended Ball State University and graduated in 1969. The Huntington County Community School and North Adams Community School Corporations have employed her. She has been a Senior Business Training Representative for Slender You Incorporated and is still a consultant for them. From, 1988 to 1991 she worked as deputy clerk-treasurer for the Town of Warren and in 1992 was elected City Clerk-Treasurer and still holds that position.

She has belonged to several teacher association groups and many governmental groups of which she has been and still is quite active. Some of these are Huntington County Economic Development, which she helped to get started and was its president for two years in 1997 and 1998. Others are Warren Area Local Development Corporation, Indiana League of Municipal Clerk-Treasurers, International League of Municipal Clerks and 3A Development District.

Some of the Civic and local organizations that she is involved with are Huntington County United Way, with its board of directors and allocation committee. Warren Area Chamber of Commerce, legislative committee. Kiwanis Club of Warren Area, president 1997, 1998 and 1999. Knight Civic Center, board of directors and at present time is president of the board. Junior Achievement consultant, Project LEAD, Tri Kappa Sorority and Warren Church of Christ.

The Mayflower Compact, 1620
 Having undertaken, for ye glorie of God, and advancemente of ye christian faith and honour of our king & countrie, a voyage to plant ye first colonie in ye Northerne parts of Virginia. Doe by these presents solemnly & mutually in ye presence of God, and one of another, covenante & Combine our selves together into a civill body polittick; for our better ordering, & preservation & furtherance of ye ends aforesaid; and by Vertue hereof to Enacte, Constitute, and frame Shuch just & equall lawes, ordinances, Acts, constitutions, & offices, from time to time, as shall be thought most meete & convenient for ye generall good of ye colonie.

We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness. A special exhibit featuring the life and times of the Honorable Congressman J. Edward Roush is on temporary exhibit at the Huntington County Historical Museum. NEW SEWER/WATER LAWS

INDIANAPOLIS - New state laws taking effect July 1 will continue ongoing efforts by State Reps Mark Lytle (D-Madison) and Scott Mellinger (D-Pendleton) to assist rural property owners affected by policies enacted by regional water and sewer districts.

Public Law 193, authored by the two legislators, provides additional protections for homeowners

who have recently installed septic systems on their property and been asked to hook up to a regional district's sewer system. It is the latest step by Lytle and Mellinger in ensuring greater public accountability from the governing boards for sewer and water districts, a process that included several months of study by lawmakers last summer.

"We began this work in response to concerns from local residents who felt they were being ordered to hook on to these systems without getting the chance to have their say about the decision," Lytle said. "Our work proceeded on a couple of different fronts: requiring districts to do a better job notifying residents about projects and protecting the interests of homeowners if those projects cause additional financial burdens for them."

PL 193 enables a property owner to avoid hooking up to a sewer district's system if the person's septic system was installed in the past five years, approved by the local board of health and certified to be functioning properly. Lytle said the change gives homeowners the option of when they want to hook up to the system.

"This part of the law protects those homeowners who have spent thousands of dollars to install a new Septic system, only to be asked to pay to hook up to a district system," Mellinger said. "The choice is given to them rather than being forced to make die switch, which could mean the loss of a considerable investment," Lytle added. "A person will be able to hook up to the system when they want. If they choose to make the connection now, they will receive a credit for their septic system that will help reduce their monthly sewer bills."

Homeowners also will gain the ability to appeal rate increases sought by the district authority if they file a petition in a timely fashion. Lytle and Mellinger said the appeal process is part of a movement toward greater accountability that began with a law passed in 2000 that requires districts to notify affected landowners of proposed improvements through first class mail and legal advertisements in local newspapers.

"This legislation reflects the wishes of many people across this state who did not believe they should have changes forced upon them without some measure of recourse," Mellinger said. These are difficult subjects that touch on personal property rights and it is a sign of the quality of the final law that it passed with strong biparti-

san support."

Lytle added, "The final product contained in Public Law 193 assures that homeowners across this state will have their voices heard, and not have changes dictated to them without their approval."

It was hoped to complete three major projects this summer.

Town Marshal Steve Donnelly said a person serving community service would be available to assist with clean-up during

Salamonie Summer Festival.

He also told of new computer equipment now available for police vehicles. It was also noted there may be Grants available.

VB TOWN COUNCIL

The Van Buren Town Council met on Wednesday evening, June 27, in the Council Room at Town Hall. At 7 p.m. president Tony Manry called the meeting to order and all in attendance repeated the Pledge to the American Flag.

Minutes of the previous meeting were approved as submitted.

Council reported the matter should have been called to their attention several months ago. They said the Town would dig one more time with a Council member to be present. If no broken drain is found the citizen was instructed to return to Council about the matter.

A citizen was concerned if resurfacing of State Road 5 and current construction and water project would interfere with this year's Popcorn Festival. It was advised that resurfacing and milling is scheduled to begin August 13, starting at the intersection of State Road 5 and State Road 218. Completion of the project is set for October 1.

Council discussed some possible Resolutions. Included in the discussion was water bill adjustments. It was decided that if a customer is advised of a water leak, they must have the problem rectified by the second billing in order to receive adjustment.

Another Resolution to be established pertains to cell phones. Under the Resolution, cell phones owned by the Town cannot be used for personal calls.

A Resolution was set at \$1,000 for threshold fixed assets.

Council voted a \$10.00 per month pay raise for the cleaning person.

A discussion was held by Council concerning deposits on rentals. It was learned many of these homes have water leaks.

Superintendent Jim Webb reported two meter changes, water

tap and cuts are done for the water project currently underway. Bacteria tests are to be made and hydrants are yet to be placed.

The site for the new water plant has been leveled.

Cement has been put in cuts. Several tie-ins are expected at which time water will be shut off in various areas.

The IPEP tests were reported to have gone well.

A box scraper had been purchased and works fine.

A house and swimming pool on Jefferson Street were reported to now be cleaned up.

At a vacant house on Second Street there were reports of children playing there. There was concern about safety.

Norman Noe was in attendance to discuss cost for inspection of the South Water tower.

Bids for the inspection of the Tower are expected by 1 p.m. July 11, with bids to be opened at 7 p.m. that evening.

The next Council meeting will be Wednesday, July 18.

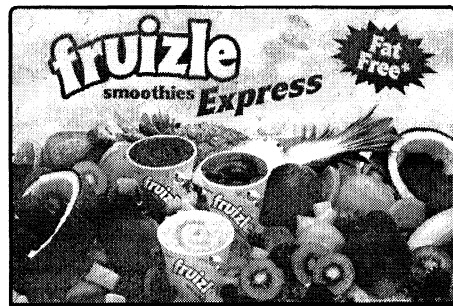

As American minister to France, Benjamin Franklin attended a dinner in Paris shortly after the British surrendered at Yorktown in 1781. The French foreign minister, Vergennes, began the toasts, saluting his King: "To His Majesty, Louis the 16th, who, like the moon, fills the earth with a soft, benevolent glow."

The British ambassador rose: "To George the Third, who, like the sun at noonday, spreads his light and illumines the world."

At last, Franklin rose: "I cannot give you the sun nor the moon, but I give you George Washington, General of the armies of the

United States, who, like Joshua of old, commanded both the sun and the moon to stand still, and both obeyed."


Johns Adams' final toast

In 1826, John Adams, the second President of the United States, then 90, was on his deathbed as the nation prepared to celebrate its 50th Independence Day. An emissary had been dispatched to invite the president to speak on the Fourth. Adams was ill and he declined. The emissaries persisted, so Adams instead offered a toast.


His visitors anticipated grand words of flattery and praise, as was the custom of the day. But when Adams raised his glass he uttered only two words. Surprised, the emissaries asked him if he would expand upon his toast. "Not a word!" said Adams. Adams' final toast was that of a revolutionary:

"Independence Forever!" he said. Hear! Hear!
