HOLIDAY POPS

Northeastern Indiana's most popular and beloved holiday event returns to Huntington University at 2:30 p.m. on Sunday, Dec. 10 when the Fort Wayne Philharmonic goes on tour throughout northern Indiana.

Join Associate Conductor Bradley Thachuk and guest vocalist Tony Didier as they lead the Philharmonic in a colorful presentation of holiday music.

The program, consisting of popular and classical holiday music includes traditional favorites like "Sleigh Ride," "White Christmas," "Winter Wonderland," and other tunes including "The Skater's Waltz" and the "Concert Suite" from "Polar Express."

Guest vocalist Tony Didier returns to the stage with the Fort Wayne Philharmonic after a recent stint as a guest vocalist with the orchestra in a Pops concert featuring Boots Randolph, singing "Mack the Knife" and "Mona Lisa." More recently, Didier accompanied the orchestra in September 2006 for "Classics Rock," the first unplugged concert of the 2006-2007 season. During the day, Didier makes his living teaching ballroom dancing at American Style Ballroom.

LOOKING FOR THE PERFECT GIFT?

How About a Home Emergency Supply Kit?

The Indiana Department of Homeland Security is encouraging Hoosiers to consider giving home Emergency Supply Kits as gifts to their friends and relatives during this holiday season.

"We know that the ability of individuals and families to be self-sustaining for at least three days would be vital during the response to a large scale disaster or emergency," said Indiana Department of Homeland Security Executive Director Eric Dietz. "Emergency Supply Kits in households are an important part of this preparedness. If you know of a family or individual that does not already have an emergency supply kit, this would be a great gift idea."

An Emergency Supply Kit is a collection of basic supplies that are stored together in case of an emergency.

Recommended items to include in a basic Emergency Supply Kit include:

Water: One gallon per person per day for at least three days, for drinking and sanitation.

Food: At least a three-day supply of non-perishable food items. If items are canned, a can opener will also be needed.

Battery powered radio and a NOAA Weather Radio with tone alert and extra batteries for both.

Flashlight and extra batteries. First aid kit.

Whistle to signal for help.

Dust mask to help filter contaminated air, and plastic sheeting and duct tape to shelter-in-place.

Moist towelettes, garbage bags and plastic ties for personal sanitation.

Wrench or pliers to turn off utilities.

Local maps.

Other items such as medicines, extra clothing and pet care items might also be included in a kit. The items should be stored together in a container. Even if you cannot assemble all of the items as part of your gift, you can purchase the container and some of the items to at least help get the kit started. You can then include a printout of other items that can be included in the kit. This information, including a printable checklist, can be found on the U.S. Department of Homeland Security's official preparedness Website, at www.ready.gov.

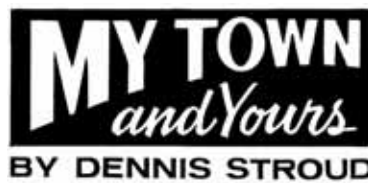

When David Finkle bought the mill it was in good condition and was doing a profitable business. The product manufactured from the mill was always excellent. Mr. Finkle worked tirelessly at the mill and his sons Henry, John, and Jacob grew up working in the mill and eventually became millers like their father. Henry owned a mill in Pennsylvania, while John and Jacob became partners with their father on the Salamonie River. The firm had become David Finkle and Sons and later the sons inherited the mill.

In the 1913 flood, the McCoy mill was extensively damaged and was no longer used. Around 1919 the McCoy mill was sold, disassembled and floated downstream. The timbers and material were used to construct the five story building that became known in later years as "Salamonie Mill." The company reorganized in 1921

and became the Finkle Milling Company. This mill was state of the art, for its time, utilizing water turbines that operated in horizontal position rather than the traditional vertical one.

The company was not too successful the first few years and the mill was passed into ownership by Milton Anderson who kept it until he sold to Thomas Nutter in 1930. Nutter ran the mill for only a few months and leased it to Fred Clark and later sold it to Emery Smyth in 1932. In 1947 James Arthur McDaniel and LaMonie McDaniel became owners and incorporated the mill as Salamonie Mills, Inc. From 1955 to 1970 there was many improvements and additions made to the mill.

On April 12, 1976 Warren lost a well known landmark. A disastrous fire destroyed the five story wooden structure known as Salamonie Mill. The fire was discovered at six in the morning and by the time the firefighters got there it was fully ablaze and there was nothing they could do to save the structure. PUMPKIN IN THE KITCHEN

It's Pumpkin Time!! I absolutely ADORE pumpkins and this time of year... yay! But did you know that besides the glorious beauty of these great big squash (yes, they are a type of winter squash), they are also massively nutritious? You could ostensibly eat the big old pumpkin you bought your kids to carve—or not. The big guys are rather stringy, the smaller sugar pumpkins, the kind used to make pies, are better. But why go to all that trouble? I say forget it—what a colossal mess! Life is too short for that kind of gourd surgery. Why not just get 100% pumpkin in a can and call it a day? That's easy button easy and it won't bend your budget out of place either.

What to do with that canned pumpkin, you say? Well, you can make a delicious cream of pumpkin soup, add some pumpkin puree to your beef stew or chili (really— it's good, try about ½ cup—just mix it right in) or try my absolutely delicious pumpkin bread recipe.

How ever you get your pumpkin, just make sure you get it. Pumpkin is chocked full of phytonutrients, magnesium, potassium and vitamin C. Pumpkin is one of nature's best sources of beta carotene - you can tell by the bright orange color.

Here's the pumpkin soup and pumpkin bread recipes—enjoy!

Smashing Pumpkin Soup
(from *Saving Dinner* by Leanne Ely-Ballantine)

Serves 6

1 onion — chopped
1 tablespoon olive oil
4 cups chicken broth
2 cups pumpkin puree
¾ cup green onions — chopped
1/8 teaspoon nutmeg
1/2 teaspoon curry powder
2 cups milk
salt and pepper — to taste

In a soup pot, heat oil over medium high heat and saute onions. Cook till very soft and add remaining ingredients, except milk. Cook uncovered for 15 minutes. Add milk and continue to cook (but not boil—it will break) for another 5 minutes.

SERVING SUGGESTIONS: A huge green salad and whole grain rolls is all you need.

Pumpkin Bread
1/2 cup honey
1 cup canned pumpkin puree (aka 100% pumpkin; NOT pump-

kin pie filling)

1/4 cup safflower oil
1 teaspoon vanilla
2 eggs
1 1/2 cups whole wheat pastry flour
1/2 cup coarsely chopped pecans
2 teaspoon baking powder
1/2 teaspoon ground cinnamon
1/4 teaspoon salt

Heat oven to 350 degrees. Lightly grease an 8" or 9" loaf pan. In a large bowl, blend honey, pumpkin, oil, vanilla and eggs. Stir in remaining ingredients. Pour into prepared loaf pan. Bake 50 to 60 minutes or until toothpick inserted in center comes out clean. Cool 10 minutes. Loosen sides of loaf from pan; remove from pan. Cool completely on wire rack before slicing.

Makes one 12-slice loaf. Per slice serving: 116 calories, 5g fat, 2g protein, 16g carbohydrate, 4g fiber, 16mg cholesterol, and 69mg sodium.
