meal in the warmth of the heated building.

POLAR PLUNGE

Brave souls and warm hearts from the Fort Wayne area are preparing for an icy dip as the 2010 Polar Plunge to benefit Special Olympics Indiana returns for the third year to the University of St. Francis campus. On Saturday, February 13, participants will "take the Plunge" into Mirror Lake, raising vital funds for Special Olympics Indiana athletes in their community and throughout the state.

As Special Olympics Indiana's signature fundraising event, the Polar Plunge invites Hoosier residents to be "freezin' for a reason" by raising funds and awareness for adults and children with intellectual disabilities. Beginning the last weekend of January and continuing throughout the month of February, 10 Polar Plunge events will be held across the state. Dozens of local residents and students are expected to turn out this year for the wintry event, which was first introduced to the Fort Wayne area in 2008.

In order to plunge, participants must raise a "bear" minimum of

\$75 (\$50 minimum with a student ID). Awards are given for those who raise the most funds for Special Olympics Indiana. This wet and wacky event also includes prizes for the best costume, incentives for dollars raised and an After Splash Bash. As the University of St. Francis event is one of four Polar Plunges to be held on a college campus this year, the Plunge will feature a Campus Challenge, in which a special award will be given to the largest campus group of Plunge participants (i.e., fraternity, sorority, sports team, club, etc.).

"People all over Indiana are fans of Special Olympics," said Michael "the Icicle" Furnish, president / CEO of Special Olympics Indiana and veteran Polar Plunge participant. "They know about our program and believe in our cause. An event like the Polar Plunge presents people with an opportunity to make their support official by getting involved in a fun activity that really makes a difference in the lives of our deserving athletes."

Participants are urged to pre-register online for the Polar Plunge at www.soindiana.org. Walk up registration will begin at 10:30 a.m. at Mirror Lake Park located on the campus of the University of St. Francis in Fort Wayne. The Polar Plunge will kick off at 12 p.m. (noon) outside with Opening Ceremonies featuring a costume contest. After the ceremony, participants will take to the water.

Plungers are invited to warm up immediately afterward at the After Splash Bash party located at Hutzel Athletic Center. While complimentary hot food and beverages will be available for

Plungers, a nominal \$5 fee will be charged for guests to partake of food and beverage.

The 2010 Polar Plunge events also feature another new prize, introduced in honor of the Indiana Knights of Columbus' continued support of Special Olympics. An award will be given to the Indiana Knights of Columbus district(s) in each of the following categories—most Plunge participants overall and most funds raised overall. In addition, the Super Plunger program will return for the second year, daring Plunge participants to go beyond the call of duty by raising a minimum of \$4,000 and participating in at least two Plunges at different sites, including the Indianapolis Plunge on February 27.

Talking with your kids about alcohol can be a challenge—you may feel nervous and fidgety and your kids might roll their eyes and wish they were somewhere else. Get some help with this important conversation with free online publications from the Century Council and the Federal Citizen Information Center.

Studies have shown that kids can start drinking as early as twelve years old. More than 10% of 13 and 14-year-olds say they've tried alcohol in the past month. For this reason, the online publications What You Don't "No" Can Hurt You and How to Talk to Your Adolescent About Alcohol are both aimed at younger kids in grade school to prepare them for when they get older.

Ninety-two percent of kids surveyed said the most trusted information they get about alcohol comes from their parents, with mom as the number one source. These free materials help you facilitate conversations with your children by using educational cartoons and testimonies from other kids and by discussing smart techniques to help escape peer pressure situations. They also include a set of kid's coupons good for a dinner of their choice or "getting out of chores" when they complete the activities. And there's a contract that both you and they can sign that promises mutual respect and openness when discussing alcohol.



Ella married Harry Blair and moved to Warren. Mrs. Blair started as night operator in 1914 and retired 59 years later. Since baby sitters were unheard of back then, Ella would take her two boys to work and

would lay them down, for the night, in a bed supplied by the company.

Babies have the habit of coming in the middle of the night and many Warren citizens were ushered into this world by a doctor summoned by Ella Blair. Warren citizens expected the town operators to do everything. Besides connecting some 1300 exchanges by memory, the operators gave the time, made wakeup calls, summoned the police, firemen, doctors and relatives when there was an emergency and they were, also, company for the lonely.

I remember when I was in the service at Fort Knox, Kentucky our telephone number was 150R and it was a chore calling home. I tried to call at the same time so I could get the same operator and wouldn't have to explain to them that was all the number I had. One night I got through to the Warren operator, gave her my number, and Ella told me she had talked to my mother earlier and they were going to be at my grandparents that night and she would ring me out there. I am sure everybody can remember their number back then and would have some memories of Ella and other Warren operators. The Citizens of Warren found a lot of comfort in knowing there was someone with sound judgment at the other end of the line.

After retiring Mrs. Blair worked on her handicraft work. Through the years she had helped many young people who would go to her home for help with crafts. Her fascination with the switchboard operator's job prompted her to construct her own miniature switchboard with dolls as operators. Mrs. Ella Blair, one of many great people from the Warren Community.

WHAT'S COMING THIS YEAR?

A look back to 2009 brings to mind plant diseases which affected many folks in the area. Those rainy periods last year certainly had an effect on plant health.

An area farmer might remember last year because of the Gibberella Ear Rot in his corn fields. A homeowner, on the other hand, might have had late blight that wiped out her tomato crop.

So, will these problems return next year? Gail Ruhl, a Plant Disease Diagnostician from Purdue University, recently held a video-conference with Agricultural Extension Educators from across the state to discuss the "hot" plant diseases of the past year. Ruhl uses a triangle drawing to describe how a disease develops in plants in her presentations. In other words, each of the three sides of the triangle represents something, which must happen for a disease to take hold in a plant.

The first side of the triangle is "susceptible host plant", which means that a plant must be prone to getting the disease. The second side is "active pathogen" – this is what causes the disease (ie. fungus). The third side of the triangle is "favorable environment for infection" – note that this usually means experiencing warm and damp weather.

Rule specifically mentioned the outlook for late blight (a fungal disease) in tomatoes in 2010. She felt that the commercial tomato plant growers who supply retail outlets will be very careful this year. You may recall that the general consensus among university specialists was late blight was widespread in 2009 because of infected tomato transplants from the eastern

U.S.

Rule anticipates that the combination of factors that brought late blight in '09 will not occur in 2010. She did, however, mention that potato volunteers that grow in a garden this year may harbor the disease if it was found in the '09 tomato plants. This is because late blight can affect both tomatoes and potatoes. Note that this disease was confirmed in 30 Indiana counties in 2009 including Huntington.

Rule also discussed fire blight, a bacterial infection found in apple and pear trees. This disease was prevalent in Huntington County last spring. If you had fire blight infected trees in 2009, it is recommended to prune out diseased branches in late winter during dormancy. The branches can be removed 10 to 12 inches below the visible margin of cankers or blight.

Another suggestion by Rule was to be on the lookout for scab in apple and crabapple trees this spring. If scab was noticed last year, it is important to rake and destroy fallen leaves. Both pruning and spraying fungicides early in the spring are also recommended.

Redesigned myBMV.com Web site allowing customer to update insurance information, mailing address, confirm license plate registration fees and pay BMV reinstatement fees online.

To encourage customers to use a Customer Choice option for registration renewals, the 2010 registration renewal notice highlights all of the options with simple instructions.

Beginning this year customers can renew their vehicle or watercraft registrations by phone through the BMV Call Center at 1-888-myBMV-411 (1-888-692-6841). A customer will need to have his/her driver's license number, Social Security number and ZIP code. Payment is by credit card or e-check.

Customers will also be able to renew their driver's licenses online through myBMV.com. This option is only available for renewal customers who do not have any change in personal information or address and do not require any testing. A customer will need to have his/her name, date of birth, legal address and Social Security number. Payment is by credit card or e-check. A customer can renew his/her driver's license online every other time the credential expires. Miller emphasized that the online renewals will be issued as non-SecureID driver's licenses.

Miller also announced that AAA Hoosier Motor Club offices will begin renewing driver's licenses and identification cards in March as an expansion of the partnership between AAA and the BMV re-established in August, 2007 for the processing of titles and registrations.

Commissioner Miller explained, "We launched our Customer Choices initiative two years ago to provide ways for our customers to do business with the BMV without visiting a license branch. We knew that there were simple transactions that could be completed through new technology at home or at business locations partnering with the BMV. Over the past two years more and more of our customers have

used our Customer Choices. In 2009, over 46 % of all registration renewals were completed outside of a license branch. These include mail-in, online, or at a self-service terminals located at 35 license branches. Other renewals were completed at one of the 356 auto dealerships, five Old National Bank branches, seven AAA offices and seven Clean Air Check locations that are all official BMV service partners. Our goal is to have 65% of all registration renewals completed outside a branch in 2010."
