COUNCIL NOTES

The Warren Town Council met at 4 p.m. Monday, July 27 in Assembly Hall. President Bill Cartwright conducted the meeting.

Bob and LuEllyn Pond, representing Knight-Bergman Civic Center, were in attendance. They requested a letter of support from Council for agrant application to replace the heating system at the Center, the electrical system upgrade and to install handicap approved restrooms. Council agreed to supply the letter.

A citizen in attendance commended Council and employees for supplying support for the Festival, for quick response in a power outage and the general appearance of the downtown area. They also commended Council for mosquito spraying.

The 2010 budget was given initial approval by the State and will be advertised.

Zoning Ordinance 2009-2 for control of adult businesses was introduced at the meeting.

Curt Day announced plans for major paving project next spring. This will include Salamonie Heights, portions of Grover Street, as well as other others that may be in need of work.

Marshal Spitler reported that the bullet proof vests have been received. They were purchased through the Department of Justice Grant Program.

Many of the early hermits lived in the desert. The hermit is known in many cultures to adopt a solitary life for personal reasons or from a need to do prayer and penance.







FIELD DAY

Purdue Extension will be hosting an annual field day for farmers and livestock producers on Aug. 20 at the Northeast-Purdue Agricultural Center (NEPAC) in Columbia City, Ind.

Registration will start at 8:00 a.m.

"The field day is a good way for farmers to learn about what they can do to improve their own business," said Ed Farris, educator, Purdue Extension Huntington County.

The field day will include four sessions on management issues. Christian Krupke, Purdue entomologist, will discuss scouting corn and soybeans for pests such as western bean cutworms and soybean aphids as well as strategies for managing these pests.

Shaun Casteel, Purdue agronomist, will address late season stresses with soybeans. He also will be highlighting updates from the World Soybean Conference, held in China this year.

Fred Whitford, Coordinator of Purdue Pesticide Programs, will discuss safely using tie-downs when transporting pesticides and farm products.

Keith Johnson, Purdue agronomist, will discuss how to manage hay crops and double crop forage options. He has planted test plots for participants to view during his talk.

An update of the farm bill will be presented by U.S. Rep. Mark Souder and the strategic plan for agriculture in Indiana will be briefly outlined by Anne Hazlett, director of the Indiana State Department of Agriculture.

"Having both Hazlett and Souder present is a good opportunity for farmers to hear about what is current within the state and in Washington, D.C.," Farris said.

Continuing Education Credits for the Private Applicator Recertification Program will be available for a \$10 fee. The program has also been approved for commercial applicator and crop advisor credits.

companies and agriculture organizations.



Is Insurance Necessary?

If you have ever wondered if it is worth paying those insurance premiums month after month, just ask someone diagnosed with a terminal illness or someone whose home has been ravaged by a natural disaster ... the answer is a resounding yes.

While you hope that you will never need insurance, it protects you from personal loss in the event of a catastrophe. When shopping for insurance, be sure you match your benefits with the premiums you are asked to pay. The Federal Reserve Bank of Dallas has some suggestions to help you in your search for the insurance policy to cover your needs.

Auto Insurance - State law requires that all motor vehicles have liability insurance to cover property damage or injury to other people. If you have a loan on your vehicle, your lender also requires that you have collision insurance. Premiums are generally lower if you select a higher deductible, meaning you pay more out-of-pocket before the insurance policy kicks in.

Homeowner's Insurance - This insurance covers your home and possessions. Your mort-gage lender will require this type of insurance until you pay off your home loan. As with auto insurance, you can select a higher deductible to save money on your premiums. Standard home-owner's insurance policies protect the owner from loss in fires and theft. Flood insurance generally requires a special rider on your homeowner's policy.

If you rent, you need renter's insurance on your personal items. The landlord's policy will cover only damage to the building itself, not your personal property. You may also want to

consider liability insurance in the event that someone is injured while in your rental property. You would be responsible, not your landlord. With the appropriate level of auto insurance, your insurance agent probably offers a reasonably priced umbrella policy that covers all types of liability.

Medical Insurance - While medical insurance will pay for part of your hospital stays, doctors and prescriptions, there is also a deductible for which you are financially responsible. A serious illness without insurance can cause significant debt if you do not have health insurance or do not have adequate savings to pay out-ofpocket costs. Although they may cost extra, you should consider whether you will come out ahead by purchasing dental and optical insurance.

Those who have insurance through their employers should also consider participating in a flexible spending account (FSA) if offered. This option allows you to save pre-tax dollars to pay for those expenses not covered by insurance.

If you do not have access to such a plan at your work, you might consider setting up a health savings account (HSA) at a bank or other financial institution to pay for healthrelated expenses. An FSA requires you to spend all of the money in your account by March 15 of the following year. With a HSA, you can roll it over from year to year.

Disability Insurance - Statistics indicate a high risk of becoming disabled before the age of 65.



This type of insurance helps pay your living expenses while you are out of work for an extended period of time and is offered for both long-term and short-term disability.

Life Insurance - This insurance will pay benefits to your designated beneficiary in the event of your death.

Long-Term Care Insurance -This relatively new insurance policy will pay for health-related items such as nursing home care, assisted living or in-home care. These policies are somewhat expensive. When shopping for this type of insurance, be sure to take your time and research several policies to decide which policy is right for you. Generally it is not cost-effective to purchase this policy until age 50, but each person's circumstances and needs may differ.

The National Association of Insurance Commissioners has a website called "Insure U", with several sources of information regarding all types of insurance.

Begin your research on the best type of policy for you by going to www.insureuonline.org. While insurance premiums can be high, the cost of not having insurance can be catastrophic.

5 FOODS THAT FIX BAD BREATH

What to do when your breath has been turned toxic by smelly foods? Since brushing constantly is impossible, try countering offending foods with what's likely to be the handiest: Other foods.

- 1. Lemons suck on a lemon wedge or nibble on the rind, or even lemon flavored hard candies - they work just as well.
- 2. Parsley and other green garnishes chewing on a sprig after eating garlic laden dishes will release the parsley's pleasant breath freshening oils. Garnishes of fresh basil and rosemary work well too.
- 3. Apples and other crisp fresh foods (firm pears, carrots and jicama) - they are high in fiber, all that chewing ups saliva production and the two together act like a scrubbing rinse for
- 4. Mint sprigs or cinnamon sticks either of these deliciously potent flavors will squelch the sulphurous scent of onion or garlic. Plus an essential oil in cinnamon kills a nasty type of oral bacteria. Cinnamon or mint gums are just as effective, pick a gum with Xylitol - it will freshen breath and help reduce cavities.
- 5. Berries and Yogurt eat for prevention consuming a half cup of plain sugar free yogurt twice a day can lower mother levels of hydrogen sulfide. Berries, melons and other fruits high in vitamin C also deter stinky mouth bacteria. Start and end the day with a fruit cup topped with a big dollop of yogurt and you might never have to worry about bad breath again.
