LILLY SCHOLARSHIPS

The Huntington County Community Foundation is offering free college educations to two Huntington County residents.

The four-year, full-tuition scholarships will be awarded through a program sponsored by Lilly Endowment Inc. The Huntington County recipients will be two of more than 216 Indiana students who will be selected as Lilly Endowment Community Scholars.

Each scholarship will fund tuition and required fees, and will also include an \$800.00 per year allotment for books and equipment.

The program is open to all students who will have graduated from an accredited Indiana high school by the end of June 2006 and who have been accepted to a full-time baccalaureate course of study beginning in the fall of 2006 at an accredited Indiana public university or private college.

The program is also open to non-traditional applicants - those who have graduated from high school prior to June 2006, are not currently enrolled in a post-secondary education institution and who have not earned more than 30 credit hours toward a four-year degree.

Scholarship applications are available at Huntington North High School Guidance office and at surrounding area high schools which may have Huntington County students enrolled.

BE A "LONGER LIVER"

GUARD YOUR LIVER AND IT WILL SERVE YOU WELL

Though they don't get a lot of attention in the press, liver diseases are the fourth leading cause of death in Americans between the ages of 15 and 65. The diseases can strike anyone regardless of age, sex, race, or economic status.

The liver is the largest organ in the body, weighing 3 to 4 pounds. It takes blood from the stomach and intestines and cleanses it by freeing the blood of waste matter and poisons. Its work is basic to health and longevity.

The American Liver foundation says these are some things you can do to protect your liver.

- Avoid taking too many medications or mixing medicines without the advice of a doctor. Street drugs can scar the liver permanently.

- Don't have more than a couple of alcoholic beverages per day.

- Be careful what you breathe. Bug sprays and other chemical sprays can harm the liver.

- Watch what you get on your skin. Many sprays and chemicals can be absorbed through the skin.

- Take precautions against hepatitis C. Use protection with intimate contact. Hepatitis C can be spread through blood and body fluids, tattoos, body piercing, or drug injection.

- The hepatitis B virus also lives in saliva and can be transmitted easily. Untreated hepatitis Band C viruses are the most common reason for liver transplants.

- Since everything you eat must be processed by the liver, eat a well-balanced diet. Increase your consumption of fruits, vegetables, and whole-grains and other high-fiber foods.

- Avoid obesity, which can increase gallbladder and liver disorders.

NEW STUDIES SHOW

ASPIRIN HELPS TO PREVENT WOMEN'S FIRST STROKE

Physicians have long known that taking aspirin helps to prevent a second stroke. But most studies were done predominantly on men. Women metabolize aspirin differently.

A new 10-year study of 40,000 women shows that, for them, aspirin statistically prevented many first strokes. Those taking a placebo suffered 17 percent more TIAs (transient ischemic attacks), which are warning sign of an impending stroke, and they suffered 22 percent more strokes.

Study authors reporting in The New England Journal of Medicine say the finding is significant, especially since a greater proportion of women than men have strokes.

Participants in the study took 100 mg of aspirin every other day, alternating with vitamin E.

Unfortunately, the study failed to show that taking aspirin resulted in fewer heart attacks for women.

Study participants filled out an annual questionnaire that enabled researchers to further investigate those who reported a heart attack or stroke and those who died from other causes.

Any man or woman considering aspirin therapy should consult a doctor before beginning. The doctor must consider the risk of GI bleeding. The risk of hemorrhagic stroke in hypertensive men and women is also considered.

Doctors say that you should remember that aspirin is a drug, and that you should not medicate yourself.

Usually, there is no charge or out-of-pocket expense for the power wheelchair, including shipping and delivery to the home by a technician, who makes the final adjustments to fit the individual and shows them how to use and maintain it. No deposit is required and there is no obligation for determining if they qualify.

Electric wheelchairs are provided to those who cannot walk and also cannot operate a manual wheelchair sufficiently or safely enough to care for themselves in their residence. They do have to be able to safely operate a joystick controller on the armrest and understand the basic instructions.

There are additional qualifications including that their doctor

BBB HOT TOPICS

Hot Topics from the Better Business Bureau for the month of October include:

1. The Bankruptcy Abuse Prevention and Consumer Protec-

tion Act of 2005 goes into effect October 17, 2005. It will now be more difficult for consumers to file bankruptcy. Under this new law, all individuals who file bankruptcy on or after 10-17-05 must undergo credit counseling six months before they file bankruptcy and must complete a financial management instructional course after they file bankruptcy. The office of the U.S. Trustee must approve credit counseling agencies and providers of financial management instruction.

2. Hurricanes Katrina and Rita—Economic losses are expected to top \$100 billion, with private insurance estimated to cover less than 25 percent. It's clear that government and private donations are hugely important. The desire to help others is one of the great characteristics of the American people; but unfortunately, every time there is a disaster, con artists try to swindle consumers out of their money. Some tips – DON'T respond to unsolicited emails or phone calls requesting donations. DON'T give to people collecting door-to-door. DON'T donate to organizations with which you are unfamiliar. And DO contact the BBB to check any charity asking for donations. Go to www.give.org.

3. Indiana State Police Alliance is soliciting for donations, stating the money will go towards public awareness, youth programs and funeral assis-

tance. Consumers have told the BBB that when solicited they were told that the donation is tax deductible; however, the printed material states that contributions are not tax deductible. According to their 2004 tax return, the professional fundraiser took 79%. The BBB standard states that no more than 35% of related contributions be spent on fundraising.

4. Indiana Restoration Program is sending a mailer to Hoosiers, which looks like it's coming from a government agency promoting "grants" for home repairs. The mailer only gives a PO Box in Chicago. Dale Ellis a/k/a Dayton Vickers-Ellis, owner, reached an agreement with the Illinois Attorney General's Office not to do business in Illinois. It appears that Ellis targets the elderly with high home equity. Beware of this guy. He appears to be using the same tactics against Indiana residents—collecting the money and not doing the work. Thanks to Indiana Legal Services for this tip.

5. Perfect Ten Models, an Indianapolis company, hires models to do contract work, promoting products such as make-up or liquor at restaurants. Models are complaining that they have done the work, but have not been paid. The company is not responding to BBB complaints.

6. NationalWay Healthcare Association is soliciting by fax in Indiana. Shame on them. In March 2004, the Federal Communications Commission issued an official citation against this

company for sending unsolicited faxes. They sell an \$89.95 monthly membership for health care discounts. This is not insurance.

7. When Gas Prices are high, the number of "gas-saving" product scams increase. The Environmental Protection Agency has evaluated or tested more than 100 alleged "gas-saving" devices and has not found any product that significantly improves gas mileage, and may damage the car's engine. Some of these products include Air Bleed Devices, Vapor Bleed Devices, Liquid Injection, Fuel Line Devices, Mixture Enhancers, Internal Engine Modifications and more.

8. Sky Flex Systems, an Indianapolis company, sells shoes on line. Consumers are complaining that they have not received the ordered shoes, and the company is not returning phone calls or emails.

9. Nationwide Mortgage Protection is sending flyers to Hoosiers regarding a bi-weekly mortgage program. 141 complaints have been filed against this Ohio company. They also entered into an Assurance of Voluntary Compliance with the Ohio Attorney General's Office.

10. Warrior Custom Golf contacts consumers to offer a 45-day free golf club test program to test top-notch custom golf clubs. Customers are asked for a credit card number to be used as a security deposit. Customers are told they will be charged only if they decide to keep the clubs. Instead, their cards are charged upon shipment. Over 100 complaints have been filed.
