CELEBRATING 11 YEARS

"ANNIE JR." Marks 11 Years of School Shows at the Pulse Opera House. 4-H ENROLLMENT

Recruitment for the 2014 Huntington County 4-H program is underway. Four-H is a volunteer youth development and education program coordinated by the Purdue University Cooperative Extension Service. Its primary objectives are to assist young people in acquiring knowledge, skills, citizenship, and leadership opportunities. Youth participants and adult volunteers are the most important assets of 4-H.

Youth interested in joining 4-H may enroll at the Extension Office or online at the Purdue Extension - Huntington County website: www.extension.purdue.edu/huntington.

Four-H is one of the largest youth development organizations in the world. Today's 4-H is for all youth, regardless of urban or rural residence. socioeconomic status, or racial or cultural background. Last year in Huntington County, 1,058 youth in grades K-12 were involved in community based 4-H clubs, which emphasize practical, hands-on activities as key aspects of capturing and retaining lifelong interests. A wide range of learning opportunities are available, including such topics as aerospace, agriculture, consumer clothing, computers, electricity, foods, home environment, photography, reading, shooting sports, and woodworking. In Huntington County, nearly 50 projects will be offered for 2014, including a new project, Microwave Foods! A chief characteristic of 4-H is its corps of caring and capable volunteers. 4-H volunteer club and project leaders form the backbone of the educational mission of the 4-H program. Through these committed adults, youth are offered opportunities to develop practical competencies and life skills such as leadership and teamwork.

Youth are helped to establish goals, think intelligently, and become contributing citizens to their communities. Through activities that are typically conducted in the homes of members or leaders, churches, or other community facilities, 4-H'ers are encouraged to

examine problems in their communities and participate in their solution. Competence and knowledge developed through 4-H work often lead to career choices.

Surveys of graduating 4-H members both locally and nationwide have repeatedly reported participants' acquisition of life skills such as personal responsibility, leadership, motivation, formation of friendships, and practical and vocational skill development as some of the most valuable outcomes of their 4-H experience.

The program combines the resources of Huntington County government, Purdue University,

MEMORIES OF DONALD D. (TONY) CHAMBERS

Tony Chambers was a farmer, a friendly neighbor, business owner & successful entrepreneur. More important than any of these, Tony was a devoted husband to Norma Gale, his wife of 52 years. Tony was a loyal and special friend to many, including me. I was truly honored one day when Tony told me that he and Norma Gale thought of me as "their kid". The fondness was mutual. One trait which always stood out about Tony was his unique ability to capture and appreciate what counted most in life.. simple things like watching and marveling at nature or savoring and enjoying Norma Gale's home cooked meals. Tony always seemed to understand and value what truly mattered.

When Tony was just a boy he fell from a tree. The fall resulted in the loss of his arm. This event for Tony never proved to be the source of limitation or restriction of any kind in living his life. Others may have felt Tony was handicapped or disabled, but Tony never felt that way. Over the course of the 50 years of our friendship, I never once heard Tony complain about the loss of his arm. Fact is, Tony almost never mentioned it. Tony did tell the story about a little boy in the playground at Heritage Pointe one day asking him across the fence, "What happened to your arm?" Tony simply replied to the boy with advice to be careful when climbing trees. George Huffman once said that Tony could dribble a basketball as fast as anyone and could shovel as much corn in a day as any man with two arms. George was not alone in this assessment for many others have offered similar stories as a compliment to Tony. Tony Chambers chose not to be defined by any single event or loss in his life. Instead, Tony chose to be defined by opportunities he sought out, embraced and enioved in life.

Tony was very intelligent and he maintained an active interest in politics and current events. He had an inquisitive mind and enjoyed discussing what was going on in the news of the world. Tony was also very resourceful. He once learned from a road building contractor about their need to be able to scalier sand on roadways immediately after they sealed the roads with tar. Tony designed special equipment and had it installed on one of his lime trucks to spread the sand for the contractor. When Tony went back to the contractor with the news, they offered to buy the truck and special equipment. Tony declined and instead offered to lease the truck and a driver. That driver was Tony. This contract kept Tony very busy for several long, hot summers. Always looking for ways to save his customers money, Tony devised a way to spread stone on driveways just where the tires treaded. The answer was to wedge a log in the dump bed over the area of the drive where stone wasn't needed. When the dump bed was raised, the stone would fall into the tire track areas and none would fall in the center. The design was simple, yet very ingenious. That was Tony.

Tony Chambers will be truly missed by each of us who knew him. No one will miss Tony more than Norma Gale. "We had a good life" Norma Gale recently said. She can now take solace in the memories of a joyful and rich half century with a fine man. The good news for the rest of us is that Tony lived his life as an example on how to

From A10s to **F16s**

The Air Force announced today that the 122nd Fighter Wing, Fort Wayne Air National Guard Base was selected to receive 18, F-16, Block 40 Fighting Falcons to replace the A-10C Thunderbolt II aircraft they currently fly and maintain. The Pentagon's proposed March 4 budget for 2015 includes cutting the A-10, leaving the F-16 as its replacement. The 122nd Fighter Wing previously flew the F-16 at Fort Wayne from 1991 until 2010 when replaced by the A-10C.

Returning to the F-16 allows the 122nd to remain in fighters until the unit can vie for the F-35 Joint Strike Fighter. Col. David Augustine, 122nd Fighter Wing Commander, said, "Our strategic goal remains to bring the JSF to Fort Wayne. Although we'll hate to see our A-10s depart, this is the right mission at the right time to bridge us to the Joint Strike Fighter! Our rich history in the F-16 will once again return."

Mike Pence, Governor of Indiana said, "I'm determined to focus our energy on the future of the 122nd Fighter Wing and the men and women that serve our state and our nation. The F-16 is a perfect bridge mission to the Joint Strike Fighter, which Indiana is determined to bring to Fort Wayne."

"For nearly seventy years, Fort Wayne has been home to fighter planes and I'm proud the F-16's will keep it that way," said U.S. Congressman Stutzman. "Thanks to Governor Pence, General Umbarger, and Hoosier leaders, we made the case that the 122nd righter Wing's battle-tested capabilities are a cost-effective and strategic asset. I'm pleased that the Air Force agrees."



Women can choose their own adventure at an outdoor sports workshop with courses ranging from shotgun shooting to canoeing.

The 20th annual Becoming an Outdoors-Woman is May 2-4 at Ross Camp in West Lafayette. The workshop is open to women ages 18 and older and limited to around 100 participants.

Registration begins March 1 at IndianaBOW.com. The cost for the workshop is \$185 and includes all equipment, meals and lodging.

The program is designed for women to learn outdoor skills in a relaxed, low-pressure environment. Participants will choose four activities from more than two dozen offerings, including fishing, kayaking, archery, out-

door photography, wild edibles, wildlife tracking, shooting muzzleloader guns and outdoor cooking.

The workshop is for women who have never tried these activities, but have hoped for an opportunity to learn; who have tried them but are beginners hoping to improve; or who know how to do some of the activities, but would like to try new ones.

Women who enjoy the camaraderie of like-minded individuals and who seek time away to reconnect with nature are also prime candidates for BOW.

RISE ABOVE POVERTY

The latest installment of an online series on challenges and opportunities facing rural Indiana highlights Purdue Extension community programs that are helping to lift people out of poverty.

The article, posted Tuesday (Feb. 25) on the website of Agricultures magazine, is the sixth of the seven-part "Giving New Life to Rural Indiana" series by the Purdue University Department of Agricultural Communication.

The article includes the experiences of a woman from Hunting-

ton, Ind., who attended a Purdue Extension class that showed her how to create a budget for her family, fine-tune her resume, interact better with people and use other resources so she could build a better life. The class, called Getting Ahead, helped her to regain her sense of self-worth, and she successfully completed her nursing assistant certification. She now works in home health care and is financially stable.

The woman also is co-leading classes with Karen Hinshaw, Purdue Extension health and human services educator in Huntington County.

Hinshaw, a native of Huntington, saw the needs of her county swell as factories and companies moved away, leaving the community of 38,000 about 20 miles southwest of Fort Wayne strapped for jobs.

Nearly 1 million people in Indiana are living in poverty, earning an annual income of less than \$11,000 for an individual, \$15,510 for a family of two and \$19,530 for a family of three.

Hinshaw notes that local Purdue Extension offices have resources that people need to become financially stable.

"To watch people come in feeling worthless and be able to encourage and empower them to figure out who they are, what they want, and how to get there there's nothing more rewarding than that," Hinshaw said.

SURVEY SAYS

(Huntington, IN) A recent survey of homeowners in Huntington County, Indiana found an overwhelming 90% believe that wind energy should play a role in providing electricity for the nation. The results of the independent telephone survey also suggest that up to 75% of Huntington County property owners would support a wind energy project located in rural southeastern Huntington County. Apex Clean Energy is currently leading the development of the Plum Tree Wind project in this area, a \$195 million project under consideration near Warren, Indiana.

This statistically valid study was conducted by an independent research firm that surveyed 300 randomly selected Huntington County homeowners.

Plum Tree Wind is expected to generate \$4.26 million in new property taxes in just the first ten years of operation. The total economic contribution over its 25-year lifetime is estimated at \$100 million. Eighty-three percent of survey respondents said the com-

munity would benefit from these new sources of revenue.

"We are very pleased that so many Huntington County residents believe a wind energy project can benefit the community, and this encourages us to continue exploring the possibilities for Plum Tree Wind," said Rob Propes, Apex Clean Energy Development Manager.

The survey also reveals that a strong majority of Huntington County residents believe that it is a property owner's right to decide whether or not to host wind energy facilities on his or her private property. Seventy-nine percent of the homeowners interviewed said that farmers should have the right to use their land for wind energy if they so choose. "This, too, is an encouraging response," said Propes. "It shows that even those who may not want a turbine on their own property still respect the rights of their neighbors to benefit from wind energy facilities."

Complete survey results can be found at www.plumtreewind.com, a newly launched website with information about wind energy, Apex, and the Plum Tree Wind project. Visitors to the site will find facts about the project and credible information about wind energy.

"We hope visitors will use our site to learn more about Plum Tree Wind, give us their feedback, and ask any questions they may have," said Mr. Propes. "We plan to share as much information as we can so the community can judge the benefits of this clean, renewable, homegrown form of energy for themselves."
