Treva's
Recipe Box

I think this is my favorite holiday dessert of all time. Now mind you there's not too many desserts I don't like and it definitely shows, but this one knocks it out of the park. It's very Christmassy and has just the right amount of peppermint to give you the coolness of the mint and a feel for the winter. Eli's, a company in Chicago makes a wonderful peppermint cheesecake but the price is anywhere from \$35 to \$50.00 per cake. So I found a very close recipe that I use and it's just as good, plus it's homemade and you can't beat homemade taste.

- Peppermint cheesecake**

| 12 oz. chocolate sandwich cookies, crushed | 2 Tbsp flour |
| 3 Tbsp. butter, melted | 1 tsp. vanilla |
| 1 1/2 # cream cheese at room temp | 1/2 tsp. peppermint extract |
| 3/4 c. sugar | 1/2 tsp. salt |
| 1/3 c. sour cream | 1/3c. crushed peppermint candy |
| 4 eggs | |

Combine crushed cookies and the melted butter till well mixed. Place in the bottom of a buttered spring form pan. Press crumbs into the bottom of the pan and bake in a 300 degree oven for about 10 minutes. Remove from the oven.

In a bowl beat the cream cheese and sugar until well blended. Add sour cream then add the eggs one at a time, beating to blend after each. Beat in the remaining ingredients except for the crushed peppermint candies. Pour over the prepared crust and bake until the edges are just golden brown and center jiggles, about 1 hour. Run knife around the edge of pan rim. Cool completely in the pan. Cover and chill until cold, at least 4 hours. Run knife around the rim again then release from the pan. Top with crushed candy. A little white chocolate is good with it by making some fancy shapes out of white chocolate on some wax paper and chill till hard then peel from paper and decorate your cheesecake. Pipe some whip cream around the edge and place your white chocolate decorations on top. They will never know you didn't buy an Eli's cheesecake.

Now when it comes to fruit cake, you can't beat the great taste of a Collins street bakery fruit cake out of Corsicana texas. These are the best fruitcakes I have ever had, they don't taste like that nasty stuff, these are the best. So if you like fruitcake it's worth the money. When I was on one of

COUNCIL VACANCY

Due to a resignation effective December 31, 2021, a vacancy will exist on the Warren Town Council as of January 1, 2022. The person selected will be appointed to fill the remaining two years of that term. As per Indiana State Statute, the Town Council will fill the vacancy by act of the Council. Written notice of interest in the position along with a short resume will be accepted until Monday, December 13, 2021 at 4:30 PM. To be considered, a person must be a resident of Warren and a registered voter and at least 18 years of age. All Warren Council members serve at large so there are no districts. The Council will review and discuss any letters received in an Executive Session following the regularly scheduled Council Meeting of that same date and, a Special Session will be scheduled immediately after that Executive Session to possibly consider appointment. If mailing, direct the letter to Town Hall, PO Box 477, Warren, IN 46792. If by email, direct to warren@citiznet.com. Letters may also be dropped at Town Hall, 132 N. Wayne Street. 

Some people have asked "where do I get my information?" Some information comes from people whose relatives lived in Warren years ago. Some information I get from the stories people tell at the museum. But most of my information comes from the old newspapers. The museum has about every Warren paper that was printed and I do a lot of reading.

The first copy of the Warren News was printed in 1878. Mr. Carl Sinnigar was the publisher for two years. The paper was then sold to John Surran, who ran the paper until 1902. Mr. Monroe Wiley bought the Warren News in March of 1902 and

later merged with A. W. McCulloch who ran the Warren Tribune. They were together for four years and Mr. McCulloch moved to Alabama and sold his interest to Mr. Wiley.

Monroe Wiley was born in Warren in 1874 and graduated from Warren High School. He attended Danville Normal School for eight weeks and Indiana University for four weeks and then taught school for ten years in Rock Creek and Salamonie Township and Warren Schools.

Monroe took a prominent part in public, church, lodge and political affairs in Warren for many years. Monroe wrote a weekly column called "Sundry Subjects" that appeared in the Tribune. He also wrote subjects of historical interest about the

pressure of an unfair financial burden.

Here's another suggestion: Try to avoid keeping financial secrets from your partner. That means disclosing your debts, hidden funds or uncommon investments. These types of surprises can lead to difficulties and mistrust. Even if you're entering the relationship carrying something like a heavy student loan, it's best to get it out in the open right away so, together, you can strive to gradually eliminate it.

Of course, there's also a practical side to not keeping secrets. Your large student loan could affect your credit rating – an issue that may arise when you and your partner are seeking a mortgage or some other type of loan. Clearly, you both should be aware of this potential stumbling block before you begin the application process.

Now, let's consider your investments. You each may have your own IRA and 401(k) or similar employer-sponsored retirement plan, but you might also share a joint investment account. However, you might not share the same risk tolerance – perhaps one of you tends to be more aggressive, willing to take more risks in exchange for potentially higher returns, while the other is more conservative, preferring to keep down the risk level of a portfolio, even if it means lesser capacity for growth.

Again, neither you nor your partner is necessarily "right" or "wrong" in your views on investing – and nobody's feelings about risk should be ignored. But once you've clearly identified your retirement goals and estimated their cost, you may find that compromise is possible. In other words, perhaps the conservative partner will realize that a too-cautious approach could hinder progress toward the desired retirement goal, while the partner who focuses on maximum growth

will learn that a somewhat less aggressive approach can still yield the desired results. This type of compromise may affect the investment choices you make in your individual accounts as well as your joint accounts. And the way you choose your investments may even change over time, especially if your financial goals evolve. Ultimately, communication is the key. As long as you're talking to each other and openly expressing your wishes and concerns, you and your partner can find a way to keep moving toward your mutual goals.

RECEIVES "A" GRADE

Five Parkview Health hospitals received an "A" Leapfrog Hospital Safety Grade for fall 2021.

The "A" grade was awarded to Parkview Regional Medical Center (PRMC) and Affiliates, which includes Parkview Hospital Randallia; as well as Parkview DeKalb Hospital; Parkview Huntington Hospital; and Parkview Whitley Hospital. Parkview Noble Hospital was awarded a "B" grade. The national distinction recognizes the hospitals' achievements in protecting patients from harm or error.

This is the first "A" grade for Parkview Huntington Hospital and Parkview Whitley Hospital, which were previously not eligible to receive a grade based on patient volumes. The fall 2021 grading period also marks the fifth consecutive "A" for PRMC and Affiliates, and the third consecutive "A" for Parkview DeKalb Hospital. A Safety Grade was not calculated or reported for Parkview LaGrange Hospital or Parkview Wabash Hospital because the Leapfrog Hospital Safety Grade does not assess critical access hospitals.

said Doug Selig, president of Parkview Huntington Hospital. "We constantly monitor our operations to make sure we're maintaining safe conditions and protecting our patients' well-being.
