PIONEER BOOK AVAILABLE

At the time of Blackford County's Sesquicentennial, Francois Godfrey Chapter, NSDAR sponsored a Pioneer Certificate project honoring individuals who settled in the county prior to 1888. The application for a certificate consisted of a biographical outline of the pioneer, along with a lineage chart tracing the lineage of the applicant back to the pioneer ancestor. Applications were received from throughout the United States as well as many Indiana counties, documenting the presence of 159 early settlers.

Information from applications filed at that time has now been compiled into book form and is being offered in a limited print run available through Old Richardville Publications, Kokomo-Howard County Public Library, 220 North Union Street, Kokomo, Indiana 46901-4614. (Telephone: 765/457-3242). The price of the 660 page, hard-cover book is \$50.00 for Indiana residents and \$47.75 for non-Indiana residents, including postage and shipping. NOVEMBER IS NATIONAL DIABETES MONTH

Insulin Resistance Prevents Unlocking of Key Receptors

As more people are classified as overweight, diabetes is projected to be the next lifestyle epidemic. The percentage of Americans who are roughly 30 pounds over recommended weight has soared. Today, close to one in five of us fall into that category.

Type 2 diabetes used to strike after age 40. Now, the Centers for Disease Control and Prevention says that among people in their 30s, the number of cases went up nearly 70 percent between 1990 and 1998. Doctors are even more alarmed about the big increase of cases in children 10 to 18 years old, making the term "adult-onset diabetes" obsolete. Among people in their 40s, the incidence of diabetes increased 40 percent from 1990 to 1998.

In type 1 diabetes, the pancreas produces little insulin or none at all. It's an entirely different disease and cases have not increased.

Type 2 is the problem. People who are overweight and seldom exercise usually develop insulin resistance. To do its job, insulin must fit like a key into receptors on the outside of cells. Once inserted, insulin activates an enzyme that allows glucose to enter.

With insulin resistance, instead of entering the cell, glucose builds up in the blood. The pancreas pumps more and more insulin, but glucose, the food for all cells, cannot enter.

There may be no outward symptoms of insulin resistance, but it is characterized by high circulating insulin levels, and sometimes impaired glucose tolerance, which can be measured through a glucose tolerance test. Nearly everyone with type 2 diabetes is insulin resistant. (The American Heart Association says people with insulin resistance also have a great risk for heart disease.)

When diabetes is diagnosed and controlled, it takes decades for it to cause blindness, heart disease, kidney disease, and other problems. When people develop type 2 in their teens, 20s, or 30s, they have to cope with it for many more years than if it comes to them in their 40s or 50s. That means more years of expensive medical care and pain.

It would be better to lose some weight, exercise a few times a week, and stay healthy, don't you think?

ADOPT-A-CHILD MONTH

In an attempt to encourage awareness of the need for "forever families" for children in foster care, Governor Frank O'Bannon has proclaimed November "Adopt-A-Child Month" in Indiana. Although 1,133 children were placed in adoptive homes in 1999, there are still more than 1,000 children in the state who need a family to call their own.

The proclamation is especially meant to highlight the need for permanent families for children in foster care. These children are considered "special needs" children because they are older and may have physical or emotional disabilities often due to backgrounds of abuse and/or neglect.

Activities planned by Indiana's Adoption Initiative for "Adopt-A-Child Month" include an Adoption Success Party on November 4 for families who adopted special needs children and sibling groups. 
