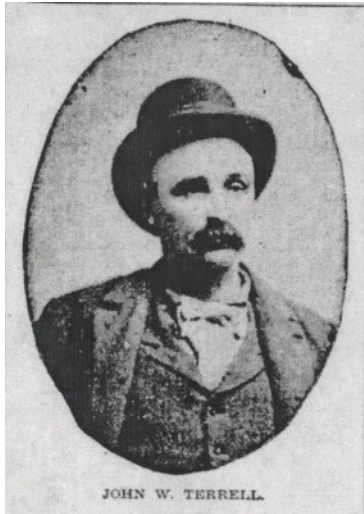

The outage will begin at 12:30 PM and last for approximately four hours. This outage affects Town of Warren Municipal Electric Utility customers only and will affect ALL users of the Warren system. The outage is necessary for I&M to replace a failed metering system into the Town of Warren system.

### HISTORY COMES ALIVE AT THE PULSE OPERA HOUSE

#### "OF SOUND MIND" - AN ONLINE MINISERIES

On July 12, 1903 John W. Terrell went to a birthday party, played with his grandchild in his backyard and shot his son-in-law Melvin Wolfe. When that shot only wounded Wolfe, Terrell followed him to the doctor's office in Petroleum, burst down the door and finished the job as Wolfe lay on the operating table. Newspaper reporters from Bluffton and beyond covered the case in great detail, including testimony from local citizens, stories from inside the jail cell and lots of local history. The newspapers were full of eyewitness reports of the shooting and Terrell's trip to Petroleum, shotgun in hand and hair wild and waving in the wind.

These accounts are brought to life by Pulse Opera House actors in the online miniseries "Of Sound Mind." After 118 years, local farmers, oil men, saloon keepers, business owners, attorneys, doctors and other Wells county citizens tell their stories through readings from the local newspapers.

Listeners may hear from their great grandparents or learn what really happened in historic local buildings.

In addition to the trial and aftermath (which included three Indiana Governors and changed Indiana law), this is a look at life during the oil boom. It was a time when great change came to the area, as electricity, telephones, cars, running water, the interurban, and trains became a part of every day life. People became connected in a way unlike any time in history. News of the Terrell trial spread nationwide and because of the interurban, people were able to flock to the courthouse from all over the state.

There are 55 local and area actors reading for the miniseries. Each episode is a half hour long and is done on a set with

**RANKING YOUR GOALS: A SMART MOVE**

Like most people, you may have several financial goals. But can you reach them all?

It would be simple if you had great wealth. But you'll likely need to rank your goals in terms of their importance to your life and then follow appropriate strategies to achieve them. By doing so, you may end up getting pretty close to covering each of your objectives, in one way or another.

When prioritizing your goals, consider following this process:

\* Identify goals as "must have" or "nice to have." Making sure you don't outlive your resources is a must-have goal, so you need to be as certain as possible of achieving it. On the other hand, a nice-to-have goal might be something like buying a vacation home. If you don't attain the money needed for this goal, you do have room to compromise, perhaps by scaling down to a smaller home in a different area or just renting a place for a few weeks a year. Having this flexibility can provide a psychological benefit, too. Since this goal doesn't have an either-or outcome, you won't have to feel that you failed if you don't get the big vacation home – instead, you can still enjoy the results of your investment efforts, even at a more modest scale.

\* Put "price tags" on your goals. You need to know what your goals will cost. Even if you can only make an estimate, it's essential to have some figure in mind. As time goes by, you can always revise your projected costs. To arrive at these price tags, you may want to work with a financial professional who has the tools and technology to create hypothetical illustrations and scenarios.

\* Follow an appropriate strategy. The nature of your goals and their estimated cost will drive your investment strategy. So, for example, using the must-have goal mentioned above – the need to avoid outliving your money – you'll want to balance your growth objectives with your comfort with risk, as well as maintain an appropriate withdrawal strategy when you're retired. However, for a nice-to-have goal, such as your large vacation home, perhaps you don't need the same urgency – consequently, with part of your portfolio, you might be able to take more risk in hopes of greater returns. And if you fall short, you can always go with Plan B – i.e., the smaller home or the rental experience. But if your "nice to have" is closer to a "must have" in this area as well, you might want to focus less on achieving greater returns and instead look at ways of adjusting your budget to save more. Monitor your results. As you pursue your goals, whether must have or nice to have, you'll want to check your results regularly. If you think you're not making enough progress toward your desired goal, you may need to make

**COUNCIL NOTES**

The Town Council of the Town of Warren met Monday, August 9 July 26, 2021 in a Regular Meeting at Assembly Hall, Council Meeting Room, 131 N. Wayne Street, in accordance with rules of Council and applicable law.

Those present were: Town Council, Ethan Stivers, Carrie Miller, Steve Buzzard, and Tavis Surfus by pho: Clerk-Treasurer, Marilyn Morrison, Employees, Dennis Spitler, Brian Sills: others.

President Stivers opened the meeting at 6:00 PM and announced the opening of a scheduled public hearing on Ordinance 2021-17, An Ordinance to approve a budget for 2022. Morrison summarized the current budget, 2021, by reviewing financial data noting that it was well in order for this time of year and then reviewed the 2022 budget as proposed. Requesting public comment and hearing none, the Public Hearing was closed.

\* Buzzard moved, seconded by Miller, to adopt Ordinance 2021-17, 2022 Municipal Budget. With no further Council comment,

the ordinance was adopted by a vote of 3-0.

\* Ordinances 2021-18 through 26 were submitted in introduction by Kim Hostetler of the Huntington Council Department of Community Development related to various wording amendments within the Town of Warren Zoning Ordinance as detailed in attachment. As no discussion, Miller moved, seconded by Buzzard, to approve consideration of adoption of an ordinance at time of introduction. The motion was approved 3-0. Buzzard moved, seconded by Miller, adoption of Ordinances 2021 – 18 through 26. The motion was carried 3-0.

\* Members of Board of the Warren Conservation Club and members of the Salamonie Summer Festival were present for discussion with Council. Following discussion, it was consensus of Council and those present that the Conservation Club Lease Agreement with the Town be rewritten and brought up to current standards of terms and that the new lease would set forth that when a Town

Wide event is scheduled for Tower Park, such as the Festival, no activities would be scheduled at the Club which would interfere with such an event except that which would be determined between the groups. Other items discussed.

\* Daryl Lahr, 826 Nancy Street, was present as a result of being cited under the Town’s nuisance violation code under Town Ordinance. After discussion, it was determined, by consensus of Council, that Lahr report back to Council on September 13th to discuss progress on clean up with further considerations at that time.

\* No update requiring Council action on Scout Cabin situation.

\* Morrison submitted a payment voucher in the amount of \$36,575 for work completed on the well portion of the Water Project.

The monies have been approved for distribution from the State Revolving Loan Fund. Manager Sills reported that work on the well portion of the Water

Project had begun but that more planning was needed with the subcontractor.

\* Data continues to be gathered for implementation of a Stormwater Utility.

\* As to contracting for a study of the Electric Distribution System, no Council decision was held.

\* As Salamonie Township has not yet made a payment to the Town for 2020 Fire Protection shared costs under contract terms, Council, by consensus, directed that the Township Trustee be contacted about the overdue status.

\* Council has been contacted by AT&T for placement of a generator at the Eleventh Street Tower Site as noted at a previous meeting. Council deferred making a decision noting that discussions should be opened regarding the lease payment agreement.

\* The Accounts Payable Register in the amount of \$99518.57 was approved by consensus.

He was preceded in death by his parents and sister, Lois Clark of North Manchester.

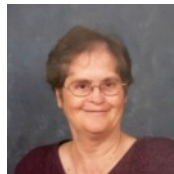

Obanion, and granddaughter, Naomi Daugherty.

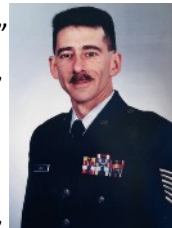

and, in some cases, tragic consequences, so we're asking everyone to plan ahead if they know they'll be out celebrating," said Huntington County Sheriff Chris Newton "These tragedies are preventable, and we don't want to lose anyone this year."

About 28 people die in the U.S. in drunk driving crashes every day. That's approximately one person every 52 minutes and more than 10,000 annually, according to NHTSA.

In Indiana, drunk driving has been on the rise. Of the 898 traffic fatalities that occurred last year in the state, 151, or 17 percent, were alcohol related. That's up from 130 in 2019. During Labor Day weekend alone, there were 12 fatal collisions with one involving a driver over the legal limit.

"Impaired driving continues to take a terrible toll on our state and nation," said Devon McDonald, ICJI Executive Director. "While these overtime patrols are effective and will undoubtedly save lives, we can't enforce our way out of this issue. It's up to everyone to drive sober and make smart choices behind the wheel."

In Indiana, it is illegal to drive with a BAC of .08 or higher. In addition, drivers

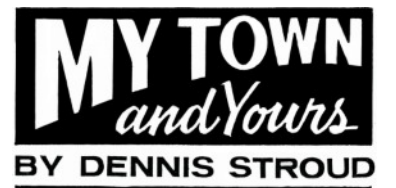
under 21 with a BAC of .02 or higher are subject to fines and a license suspension for up to one year.

However, impaired driving includes more than just alcohol. Drugs and even some over-the-counter medications can also cause impairment and can slow coordination, judgment and reaction times on the road.

Officers will be on the lookout for all forms of impairment, in which the consequences can include thousands of dollars in legal fees, increased insurance rates, loss of license, a criminal record and possible jail time.

To avoid those, plan a safe and sober ride home before going out. Even if only one drink is consumed, designate a sober driver or plan to use a rideshare service, public transportation or taxi. Motorists that encounter a drunk driver on the road are encouraged to call 911.

AS GOOD AS THE BEST AND BETTER THAN THE REST. TRY A BOTTLE AND GIVE IT A TEST. This was the slogan for the Refreshu Bottling Company in Warren, Indiana. It was Jim Schemerhorn's bottling works.

Jim started his bottling works in 1911, where the Church of Christ now stands, he then moved next door and not staying in those locations for more than two years, he decided to build on the side of his barn across the road from the trailer court. Cleaning and capping the bottles was all done by hand.

The pop was delivered on a wagon with a flat bottom bed, and a team of horses to pull the delicious flavors of orange, grape etc. Pop went to points such as Plum Tree, Majenica, Mt. Etna, Dillman, McNatt, Montpelier and Van Buren. Refreshu sold for 50 cents a case of 24 bottles. The Kolotona they bottled was 60 cents a case. What was Kolotona? A doctor, over at Huntington, gave Jim the recipe. He wanted Jim to mix up the celery flavored

### A MISSISSIPPI RIVER BOAT TRIP DAY 2, PART 1

We were awakened one hour early by the hotel's clock radio that someone else had previously set!

There was no more sleep that morning. The day was partly cloudy as the bus departed the hotel in route back to LeClaire, IA.

Our tour group and other travelers boarded the fuel-powered boat named, the "Twilight" at 7:45 am. This three-decker boat accommodated 140 passengers. There was plenty of outdoor seating. Another river cruiser left just before us. Everybody was northbound toward Dubuque, IA. Baggage was nonexistent. The suitcases were trucked to Dubuque by the cruise line. This way our bus driver and tour guide could enjoy a day off and the river ride. A breakfast was served on board and inside the main area which continued to be excessively cooled by A/C throughout the day. Burr! It was "chilly" inside for meals during this two day, 166 mile, round trip excursion.

We were informed that the Mississippi River in this area was not "muddy" but quite clear. Sand covered the bottom—a lot of sand. This shifting silica had to be dredged regularly to maintain passage for vessels! A 9 foot deep channel is ideal and 5 feet is the minimum. Red buoys marked the current passageway. The captain announced that the channel location is slowly moving toward the Illinois side of the river. He said that some water levels measure only two feet and people can actually walk across sections of the river. He also reported that the water level was low now in July.

One piece of information that I did not know was that the Mississippi River is several miles wide in places.

Also, many variable sized islands, approx. 600, inhabited the river. The captain added that this section of the river hardly ever floods. Apparently the width of the expanse accommodates the excess water.

We saw several barges being ushered down steam by tug boats. One combination of 12 barges was attached to the David Evans tug boat. The captain announced that these carriers contained 60 acres of grain—corn, wheat, soybeans and would reach New Orleans in two weeks. Most is shipped overseas. Amazingly, all 12 barges can be unloaded onto ships in 20 minutes. More later.
