There is an old joke that really isn't funny. "If I lie down and close my eyes maybe the thought will go away, or better still not come at all."

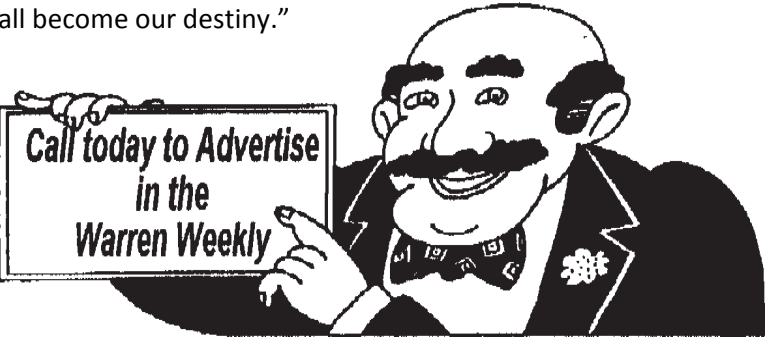
There is an old adage - life is a grindstone, it either grinds you down or polishes you up. It depends on the stuff you are made of.

### ADULT EXHIBITS

Entries are now being accepted for the Open Class Adult Exhibit to be held during the Huntington County 4-H Fair in July. The exhibits, sponsored by the Huntington County Extension Homemakers, are open to any

resident of Huntington County (18 years and older) or any member of a Huntington County Extension Homemakers club. The exhibits are open to amateurs only. Professionals are defined as those receiving \$1,200 or more per year in a specific category.

Each exhibitor may enter one item per division. All items must have been completed after August 1, 2009. No exhibit can take more than 36 inches of table or floor space to display. There is a fee of \$1 per entry. Registration fees and entry forms are due in the Huntington County Purdue Extension Office by June 30, 2010. Late entries will not be accepted. Exhibits will be entered in the Family Living Building at Hier's Park between 4-7pm on July 22 and 7:30-8:30am on July 23, 2010. Exhibits will be released between 5-6:30pm on July 29th. Each entry will be awarded a blue or red ribbon. Judges may also award a Best of Show in each division and honorable mention upon discretion.

Divisions include: fruit pies, cakes, cookies, candy, yeast breads or quick breads, canned jelly, jams or preserves, canned vegetables, fruits or pickles, sewing, wearable art, jewelry, embroidery or crewel, counted cross-stitch, scrapbooks, recycled items, fine arts, basic crafts, flower arrangements, woodworking, quilts, quilted items, amateur photography color and amateur photography black and white.

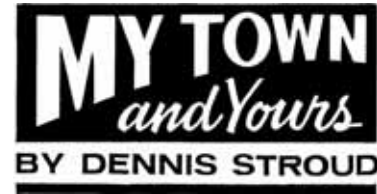

East on Second Street was Jeff McElhaney's Creamery and Confectionary Store in the three story building. Next door was the Telephone Office managed by Bob Laymon. Continuing east across Main Street Lester Dyson had a garage at the old interurban station. Going east on third street, beside the Standard station, was a cream station run by Clifford Ruse.

North of the Church of Christ was E.J. Ellerman's Chevrolet Agency and across the street was Arthur Soulen's Garage, Radiator and Battery Shop. On the corner [where Accent Interiors is] was Alf Thompson who operated a restaurant. In the rear of the building, Dewey Taylor operated a barber shop. Next week we will go down the west side of Wayne Street.

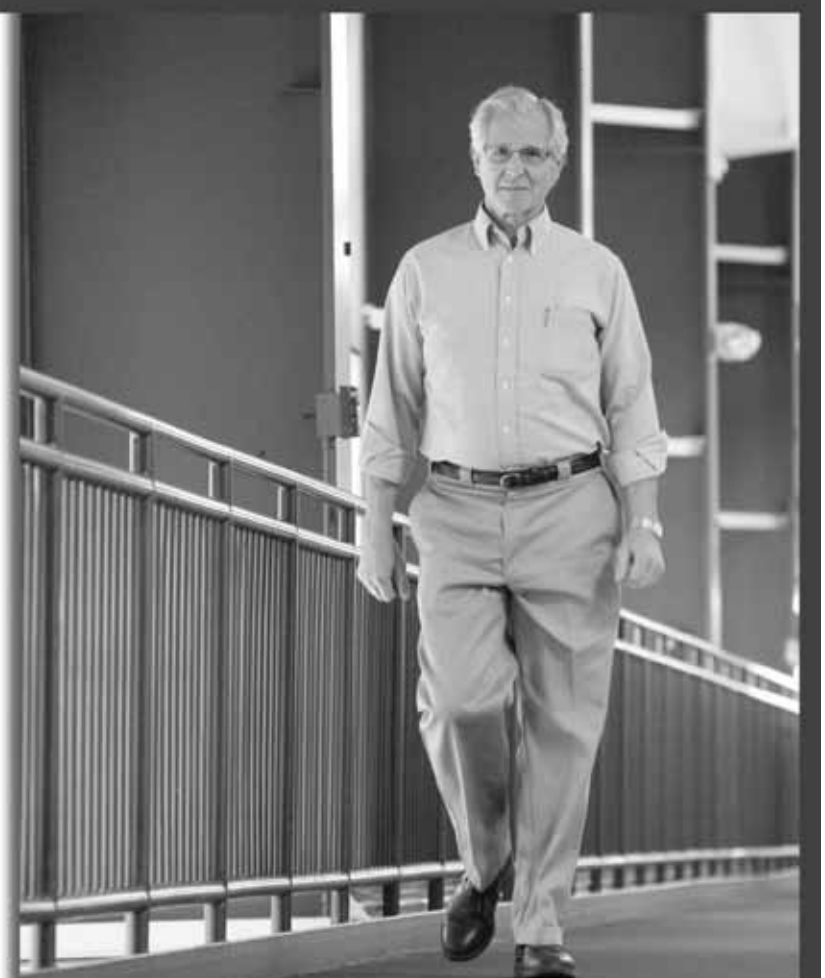
