### FATHER'S DAY, ITS HISTORY AND ITS MEANING FOR TODAY

As compared with other holidays, Father's Day is a relative newcomer on the calendar. The first known celebration was initiated by Sonora Smart Dodd of Spokane, Wash. Her father was a courageous, selfless, and loving man who raised five children after the death of his wife. Sonora's father was born in June, so she chose a June day, June 19, 1910, to celebrate the first Father's Day.

Apparently it was an idea whose time had come because other communities, then other states, picked up on the celebration and held their own Father's Days. In 1926, a National Father's Day Committee was formed in New York City. Father's Day was an unofficial observance held annually until Congress gave it national recognition in 1956. In 1972, President Richard Nixon established an annual national observance to be held the third Sunday of June each year.

Dr. George A. Parks, co-founder of the Seattle Men's Wisdom Council, says our fathers will forever live inside us as our first image of men and masculinity. Our inner relationship with our fathers will persist for the rest of our lives. It will influence our sense of identity, our intimate relationships, and all our relationships with men, especially those in positions of power and authority.

When we honor our fathers, says Dr. Parks, we can more deeply honor ourselves. So the act of honoring our fathers may be as important for us as it is for them.

Sometimes true bonding with one's father doesn't occur until very late in his life. That means a great deal of time and love goes unexperienced. Don't wait, honor your father and show your love this year on Father's Day.

**KUDOS, KICKS & KARATS**

**A CHALLENGE TO FATHERS ON FATHER'S DAY.**

Dear Fathers,  
 Where have all the heroes gone? As a youngster, I had positive sports heroes and others to look up to and model. On this Father's Day I want to challenge all fathers, including myself to step up to the plate and be a hero and role model for a young person today.

As the father of a son who had an alcohol problem as a teenager, I encourage you to talk to your children and other teens about making responsible choices, especially concerning underage drinking issues. My son was expelled from school and dealt with other consequences because of his underage drinking. I know firsthand the devastating effects alcohol can have on a teenager and family.

And while talking to our children does not mean that they will always make the best choices, we must give them our best effort and at the very least let them know where we stand. Our children are valuable and we must take the time to make them aware of the dangers of underage drinking and the consequences of their choices.

Why should you be concerned? Alcohol kills six times the number of teens per year as all other drugs combined. Forty-one percent of drivers under 21 years of age who were killed in traffic accidents in Indiana tested positive for alcohol.

Binge drinking is defined as five or more drinks in one sitting for a male or four or more for a female. Over a period of two weeks, binge drinking was reported by 15.2 percent of Indiana 8th graders, 25.6 percent of 10th graders, and 30.8 percent of 12th graders.

Children who begin using alcohol before age 15 are more likely to be heavy users or alcoholics later on in life. In fact, 40 percent of those who start drinking at age 14 or younger develop alcohol dependence, compared with 10 percent of those who begin drinking at age 20 or older. Alcohol use at an early age also appears to have a greater negative and permanent effect on the brain.

Fathers, take the opportunity today to talk to your children and other teens about the consequences of underage drinking. Be a role model. Our kids need heroes in their lives. You can be one of them.

**FLAG DAY, JUNE 14**

**HONORING OUR NATIONAL SYMBOL**

The idea of an annual day to honor the U.S. flag is believed to have originated in 1885. B.J. Cigrand, a school teacher, arranged for the pupils in his Fredonia, Wisc., school to observe June 14 (the 108th anniversary of the official adoption of The Stars and Stripes) as "Flag Birthday." In many magazine and newspaper articles over the following years, Cigrand enthusiastically advocated the observance of June 14 as Flag Birthday, or Flag Day.

Gradually, the idea was adopted in many areas. Inspired by decades of state and local celebrations, Flag Day was officially established by a proclamation of President Woodrow Wilson in 1916. But it was not until August 3, 1949 that President Truman signed an Act of Congress designating June 14th of each year as National Flag Day.

In his writing about the U.S. flag, Charles Evan Hughes says: The flag is the symbol of our national unity, our national endeavor, our national aspiration.

It tells of the struggle for independence, of union preserved, of liberty and union one and inseparable, of the sacrifices of brave men and women to whom the ideals and honor of this nation have been dearer than life.

## AREA NEWS

### NEW POSTAL RATES

The US Postal Service Board of Governors voted to modify some postal rates and fees effective July 1, 2001. The rate adjustment DOES NOT affect the price of a First-Class letter, which remains 34 cents. However the additional ounces will not cost 23 cents.

The adjustment is a modification of the rates that took affect on January 7, 2001. The adequacy of these rates has been in dispute between the Postal Service and the independent Postal Rate Commission. In short, the Postal Rate Commission granted approximately \$1 billion less in revenue than the evidence provided by the Postal Service indicated was needed to cover the cost of operating our nation's mail system. The Governors have the authority to override the Postal Rate Commission with a unanimous vote.

Additionally, there have been significant increases in the costs of doing business-costs such as fuel, transportation, utilities, salaries and health benefits. The Postal Service receives no tax subsidies to operate. Without increases, the USPS faces significant losses, and that could adversely impact the nation's mail service.

The Postal Service also continues to focus on cost reductions. However, like any business, the pressure of inflation causes costs to rise. In Fiscal Year 2000, significant cost reductions were made to national programs and initiatives and in April, Postal officials announced a second round of budget cuts and actions aimed at stemming a projected loss that could exceed \$2 billion for fiscal year 2001. The USPS has committed to reducing costs by \$2.5 billion by 2003 and, over the next five years, plans to cut 75,000 work years, squeeze administrative costs by 25 percent, and reduce transportation costs by 10 percent.

Every year the Postal Service delivers to 1.7 million more addresses than the year before. Automated mail processing has helped keep the cost of mailing a

First-Class letter today less than the cost in 1971 when indexed for increases in the cost of living. Additionally, in 1971 the Postal Service delivered 87 billion pieces of mail, compared to the 208 billion pieces of mail delivered last year. The volume of mail has grown 139% yet the number of employees has increased just over 23% during that period.

The Indiana Dental Association recognized an area dentist at the 143<sup>rd</sup> IDA Annual Session.

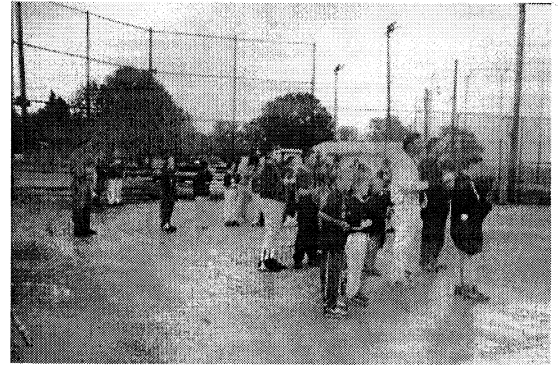
During an awards ceremony in Indianapolis on May 31, the IDA recognized retired general dentist Dr. James W. Mott of Warren as a 50-year member of the association.
