PUBLIC HEARING

Notice is hereby given by the Clerk-Treasurer of the Town of Warren, Indiana, that on the 23rd day of October, 2006, in the Council meeting room in the Town's Assembly Hall located at 131 Wayne Street in Warren, Indiana, starting at 8:00 am there will be a public hearing on the matter of whether to adopt, certain proposed changes in the rates and charges of the Town's water utility.

ity.

Payment of hydrant availability charges for municipal fire protection now paid from Warren's general fund will be transitioned over a three (3) year period to be recovered from and included in the basic rates of water utility customers.

At a duly called and held Town Council meeting on October 9, 2006, previously introduced Ordinance No. 2006-2 was amended and is presently under consideration as amended. That Ordinance, exclusive of the whereas clauses, recitals of adoption, and proposed signature block, reads as follows:

"1. For the billings rendered in calendar 2007, one-third of the then applicable §52.50(C) charges for each municipal (not private) hydrant shall be included in the monthly basic rates charged to the customers of the water utility,

2. For 2008 two-thirds of that then applicable charge shall be included in such basic rates.

3. For 2009 and thereafter all of that then applicable charge shall be entirely included in the monthly

OFFER NEW MAJORS

The Huntington University EXCEL program for adults is offering two new bachelor's degree programs and soon will offer two more.

The program stresses skill development in the areas of management, decision-making, business communications, managerial accounting and finance, managerial economics and marketing. The emphasis in this program is on developing the quantitative skills necessary to be successful in the professional world.

ANNUAL CONVENTION

A wide range of speakers, breakout sessions, tradeshow activities and special events are planned for the Indiana Farm Bureau annual convention, "Partnering for Progress."

The convention is set for December 8 and 9 at the Indiana Convention Center in Indianapolis.

"Indiana agriculture is changing, from the rapid expansion of biofuels facilities to increased opportunities in livestock production," said Kim Vail, IFB director of field services. "The convention programs are designed to help farmers take advantage of these changes and enable them to be a part of the progress."

Friday's general session, "Food, Fuel and Security for America," will feature Wally Tyner, professor of agricultural economics at Purdue University, and Daniel De La Torre Ugarte, University of Tennessee Agricultural Policy

Analysis Center, discussing how alternative energy sources like biofuels relate to economic and national security.

"Energy is big," said Tyner. "When you think about the size of the energy market compared to the food market, it's enormous. If the top three oil companies chose to, they could buy the entire U.S. corn crop with their profits in one year—just their profits. So if we do choose to develop ag-based energy sources, the potential market is enormous."

Eight breakout sessions are offered on Saturday. One \$250 Visa cash card sponsored by Farm Bureau Bank will be offered as a door prize at each session. Morning session topics include rules for driving farm equipment on the road, identity theft, a review of the 2006 election and easements. 

TIPS FOR TEENS

(ARA) - Before he was even in high school, Zach Friesen had bad credit.

Now a 20-year-old college student at the University of Colorado, Friesen's identity was stolen when he was just 7 years old. The thief used Friesen's personal information to buy a \$40,000 houseboat, then defaulted on the debt. Friesen didn't discover the theft - and resulting damage to his credit - until he applied for his first job at age 17.

"My story isn't that uncommon," says Friesen. "In fact, the largest target for identity thieves is young people, ages 18-29, according to a 2003 Federal Trade Commission study."

"Teens are targeted because they have clean credit and don't check their credit reports," says Melodi Mosley Gates, director of risk management and chief information security officer for Qwest Communications. Friesen now works with Qwest to raise teens' awareness of the threat of identity theft. Through Qwest's awareness program, he urges teens to visit AnnualCreditReport.com, where they can obtain free copies of their credit reports once per year. He also visits high schools across the country to share his story, tips and to gather information about teens and technology.

Teens are also at risk for identity theft because they use the Internet and aren't careful enough about the type of personal identifying information they give out online.

At www.incredibleInternet.com parents and teens can learn how to use the Internet safely and effectively and find ways to protect themselves from identity theft. There, teens can also take an online credit report tutorial to understand how to read a credit report.

"Qwest was among the first to recognize that young people are the number one target for identity

½ cup evaporated milk, I use Milnot

2 tablespoon butter

½ cup hot milk

½ cup brown sugar

¼ teaspoon salt

1½ teaspoon cinnamon

½ teaspoon nutmeg

¼ teaspoon ginger

1/8 teaspoon cloves

1 9-inch unbaked pie shell.

Combine pumpkin corn syrup eggs and evaporated milk, mix well. Stir butter into hot milk let melt. Combine sugar, spices and salt and add all ingredients together and pour into the pie shell. Bake in hot oven 450 degrees for 15 minutes and reduce heat to 350 and continue baking for about 35 minutes or until a knife inserted in the middle of pie comes out clean.
