This spring weather is great hope all of you are enjoying it.

In my "uptown garden" green onions, lettuce and garlic have appeared and are looking good. Sure will be glad when I can have for lunch a lettuce and peanut butter sandwich.

My dad always tried to plant potatoes on Good Friday and I try to follow his way of gardening. Those fresh dug potatoes will be a real tasty treat later this summer.

Soon I will have the beans and tomatoes and the acorn squash along with cabbage and bell peppers in the ground.

In the sunroom I have a small greenhouse Wayne made for me which I really enjoy. I call it my winter sanity saver. This year I nurtured about 3 dozen geraniums over the winter, even had some blooming at Christmas. Sure makes the gloomy days of winter brighter. Now they are all moved outside to harden off for outside planting. I also start a few of the garden plants in the unit also.

The Spring Pantry Farmers Market was a busy place for the April market.

All of us are looking forward to the May 12th market at the Pulse building. Thanks Ron and Cynthia for use of the lobby. If all goes well there will be fresh asparagus, lettuce and spinach along with the regulars. The 4-H club will be also selling geraniums. Watch the Warren Weekly for further news.

With all those golden dandelion booms in yards and fields I will share a recipe we have at our house a few times each spring.

#### Fried Dandelion Blossoms

About a quart of blossoms 1/3 cup flour  
 1 teaspoon season salt 1 egg  
 1/2 teaspoon powdered garlic butter and oil for frying.

Soak the blossoms in salt water about 1/2 hour. Drain and rinse several times and drain well. Spread on paper toweling to absorb the moisture as much as possible.

Beat the egg add the blossoms mixing the egg well into the blooms. Combine the dry ingredients in a plastic bag add the blooms and shake to coat the blooms well. Fry in a mixture of 2 tablespoons butter or margarine and about 2 tablespoons oil. Fry until well browned. Be sure to pick blooms that have not had chemicals on them.




For those of you who find this gross here is another spring time dish.

#### Asparagus Quiche

10 inch deep dish Quiche pan or pie dish line with pie crust and bake at 350 for 15 minutes. Let cool. For the filling: in a blender combine 1 1/2 cup cottage cheese, 2 tablespoon flour, 4 eggs, 2 cups milk, 1 teaspoon mustard, dash of Tabasco sauce. Mix well and pour into crust. Top with 2 cups of 1/2 inch pieces asparagus and 2/3 cup grated Swiss cheese. Bake at 375 for 25 minutes. Let set for a few minutes before serving.

### TARGETING FIREWOOD

This year the DNR, at all state-owned properties with campsites, will be on the lookout for firewood being brought in from quarantined counties. Last year the limitation of firewood was imposed only at Pokagon State Park in Northeast Indiana. The quarantines, currently in nine Hoosier counties, have been imposed because of confirmed emerald ash borer infestations.

This year, campers entering state parks, state forests, state reservoirs and state recreation areas will be asked if they have brought any hardwood firewood from any of the quarantined counties in Indiana, Michigan or Ohio. Any firewood from one of the quarantined counties will be collected by the park staff and immediately burned.

"The emerald ash borer has the potential to destroy all of Indiana's ash trees, which would be a tremendous esthetic and economic loss to the state," says Kyle Hupfer, director of the DNR. "This insect only travels about a half-mile annually on its own, but can be carried anywhere in our state in infested firewood. We want campers who enjoy our Hoosier natural resources to help us conserve those resources, and this is one very important way they can assist us."

The new policy will limit all hardwood firewood from the lower peninsula of Michigan; 13 quarantined counties in Ohio including Auglaize, Defiance, Erie, Fulton, Hancock, Henry, Huron, Lorain, Lucas, Ottawa, Paulding, Sandusky and Williams counties; and seven quarantined coun-

ties in Indiana including Steuben, LaGrange, Randolph, Huntington, Adams, Marion and Hamilton counties.

Pokagon State Park, located in Steuben Co. on the Michigan/Indiana border and in the center of one of Indiana's emerald ash borer infestations, restricted hardwood firewood in 2005.

"Our campers were very cooperative," says Ted Bohman, Pokagon property manager. "Our visitors don't want to lose our shade-producing ash trees to this insect any more than we do, and they realize that not moving infested firewood is an important key to keeping those ash trees."

Campers can also help by burning all of their firewood, regardless of where they purchased it. And the new policy doesn't limit the building of campfires.

"Camping just isn't the same without a campfire," says Dan Bortner, director of the DNR's division of state parks and reservoirs, "and we want our visitors to continue enjoying a crackling fire as long as weather conditions permit. We just ask that they not purchase or bring firewood from any of the quarantined counties into any of our state parks, reservoirs or state forests. They should purchase their firewood only in counties or states that do not have any quarantines, or from vendors with stock that has been certified by the U.S. Department of Agriculture."

### THEATRE CAMP

Are you looking for a different kind of summer camp? This coming July the Huntington University Department of Theatre Arts will host its inaugural Huntington University Summer Theatre Youth Camp. From June 26 to July 21, campers ages 6 to 15 will learn basic theatrical training from theatre professionals and perform a fully produced musical theatre production. This summer's performance will be a junior version of the "Music Man" in which every camper will have a part.

The camp will run Monday through Friday from 8:30 a.m. to 12:30 p.m. in the Huntington University Merrillat Centre for the Arts, with performances on July 22. There will be no camp session on July 3 or 4.

Cost is \$175 per camper with a late registration fee of \$25. Space is limited to 50 campers. Brochures and registration forms will be given to area elementary and middle schools and will be available at the Merrillat Centre for the

Arts Box Office after May 1.

For youth ages 16-18, an apprentice program also will be offered at the same time. Apprentices are students with theatre interests that assist with facilitating the camp. They will work more closely with the camp directors and serve as assistant directors, assistant choreographers, stage managers, and assistant designers. The cost, dates, and times are the same for the apprentices as they are for the younger campers.

This year's Summer Theatre Youth Camp will receive funding from the local Huntington community with a \$2,500 grant from Ecolab and a \$3,000 grant from Cinergy Corp.

Ecolab in Huntington offers non-profit organizations the opportunity to apply for competitive grants once a year, awarding \$25,000 per year in grants. The Cinergy grant comes as part of the corporation's community development program. A group of area citizens along with representatives from Cinergy review areas of the community that could use grants to provide momentum for further development and community enhancement.

"The arts camp appealed to the organizations because of the potential impact on both youth of the community, and the greater Huntington community as well," said Troy Irick, Huntington University vice president for advancement.

In addition to receiving funding from the local community, the theatre arts camp also is building strong relationships with the Huntington County Community School Corporation and the LaFontaine Arts Council (LAC).

"These groups see the need for a strong arts oriented summer program in Huntington County," said Mike Burnett, assistant professor of theatre. "They have offered valuable advice to us as we have proceeded on this first camp. Future plans hopefully involve opening up the camp to the visual arts as well as other performing arts. Both LAC and the school corporation are excited about that

possibility and how it can strengthen the youth of the Huntington area."

David and Kristi Shamburger, Huntington University theatre faculty, will serve as co-camp directors. The Shamburgers created and directed summer youth musical theatre camps in Georgia and have experience with the Nevada School of the Arts youth theatre programming. Mike Burnett, assistant professor of theatre at Huntington, has worked in youth programming throughout the United States and will serve as camp technical director. In addition, four Huntington theatre students will serve as mentors.

After six years of running a theatre arts camp while teaching at Middle Georgia College in Georgia, the Shamburgers came to Huntington and were surprised to find that the University did not have a similar program.

"We have the facility, the means, the personnel to do a top-notch arts camp," said David Shamburger, assistant professor of theatre. "It's a necessity to offer the arts to the community, sort of an outreach program. We want to build a bridge with the community, and the best way to do that is to connect with children."

In addition, Shamburger hopes the camp will help promote the University's Department of Theatre Arts, assist Huntington theatre students by providing camp positions, and most importantly, impact the local community for Christ. "We are a Christ-centered university, and everything we do is through Him," he said.

While in Georgia, Shamburger and his wife Kristi, a member of the University's adjunct faculty, led campers in full-fledged productions of musicals such as "Music Man," "Guys and Dolls," "Fiddler on the Roof," "Wizard of Oz," and "Lil' Abner." Intensive rehearsals taught children to sing, dance, and act.

Shamburger says the Huntington University camp will be a great opportunity for youth to work with real theatre profession-

als. "Both my wife and I are actor union members and professionals, and Mike and Ella Burnett are also professionals in the field. It's great for kids to not only do theatre, but to do theatre with professionals."

In addition to helping run Huntington's first Summer Theatre Youth Camp, the Shamburgers also plan to travel to Tennessee this summer to help with another camp. "It's sort of become our way of reaching out to children and the community," Shamburger said.

Shamburger most enjoys the enthusiasm and passion of the young actors. "To them it is magic," he said. "I always try to get my actors to return to a sense of play. The children still have that and it's nice to work with."

In our home we do not have a linen closet, thank goodness. I used to have one in the house where my son grew up. I am going to reconstruct the stuff I

had stashed in its shelves.

The very bottom of this closet contained our return air duct. The closet door was louvers that allowed the air to flow. On the bottom shelf about two feet off the floor was my fabric stash. I used to sew all the time. This shelf was crammed full of fabric that I was never going to use. Did you know that fabric will dry rot? Not to mention get dusty and dirty. On the second shelf were blankets and sheets. Most of which we had gotten for wedding presents that didn't fit any of the beds we had. Why was I keeping them? On the third shelf almost at the top of the closet were the

boxes of keepsake doilies and pillow cases that were handmade by great grandmothers and grandmothers. Also on this shelf were baby blankets that were TOO good to use for everyday that had been crocheted by my grandmother for Justin. Love had been put into every stitch and I shoved it in a closet and never used it to bless my son. I had also stuff at the top of the closet because I had no other place to put it my father's Marine dress uniform in a suit bag.

This closet was so full I hated to open the door. The stuff in there called out to me filling me with guilt and sadness. Why was I

just stuffing it all in this closet? I think it was because I really didn't want to face the stuff. I didn't want to face the money I wasted at the fabric store and all the good intentions I had for doing project. I didn't want to face that my father was dead or all the other people who had given us that stuff. It was good stuff and I just couldn't get rid of good stuff!

I have come to a new way of thinking about this stuff! If you don't use and it doesn't make you smile; it needs to go away. I have quit stuffing my feelings by stuffing my closets full of stuff
