### Warren Baseball Info

The Warren Baseball & Softball League would like to announce that for the 2013 season, the kid's entry fee to the league will be increased from \$20.00 to \$30.00 per child. This is the first increase in three decades and there will still be NO FUNDRAISING by the kids, however another carnival for fundraising with the coach's softball games is in the works.

The Leagues will be the same as last year with 8 – 10 year old

boys playing American Little League, 11 – 13 year old boys playing National Little League, 14 – 17 year old boys playing Pony League, 8–12 year old girls playing Junior Softball and 13-17 year old girls playing Senior Softball. (All 8 year olds who play in the Civic Center League are also eligible for the WBSL.) For your \$30.00 every child will have at least 12 regular season games with a double elimination tourney with trophies and all rain-out games will be made up.

### THE UPTOWN GARDENER by Ruth Herring

OOPS I almost forgot to get the article sent in . Some days I really forget to track what day it is. To a few of my faithful readers it is almost unforgiveable to miss an issue.

I have been just waiting and wishing for spring. I have talked with a few who have already have spring bulbs thru the ground and some with buds forming. A bit early but Mother Nature has control of it. As for me I have not seen any coming up but mine are mostly tulip bulbs.

I have certainly enjoyed the birds coming to the feeders. I have more different ones from what I had in town. I know what time they come into feed so I have my lunch in the sun room at the same time. I guess you might call that party time.

Have you all noticed the daylight time is getting longer We have probally gained at least a half hour or more.

Years back how I looked forward to time when I didn't have get out of a warm bed and eat a fast breakfast and go out and pump wash water in the dark before going to school. Really don't miss any of that. Pushing the dial and getting hot cold or which ever needed is in the washer is a real treat.

Here is a nice healthy breakfast muffin that you might like and easy to prepare.

2 cups Special K cereal, 1/2 cup flour, 1/2 cup whole wheat flour, 2 teaspoon baking powder, 1/2 teaspoon soda, 1/2 cup milk, 2 mashed bananas, 2 eggs, 1 tablespoon sugar, 3 tablespoon brown sugar, 1/3 cup vegetable oil, 1 teaspoon vanilla or cinnamon.

Mix cereal, mashed bananas, eggs, oil and milk together and let set for about 10 minutes. add the sugar, flour, soda and baking powder and vanilla or cinnamon. Here if you wish you could add nuts, coconut, dried fruit such as dried cranberries, diced dried apples or what ever you might want. Fill paper muffin cups 2/3 full and bake at 350 for 20-22 minutes. These keep well bagged in the refrigerator. Just warm then about 10 seconds in the microwave.

### SMALL FARM CONFERENCE

Small farms are a big deal, and a Purdue Extension conference will provide the tools to successfully operate them.

The Indiana Small Farm Conference will take place March 1-2 at the Hendricks County 4-H Fairgrounds in Danville. Sessions will focus on issues related to management, production, processing and marketing.

Registration is \$150 per person for both days or \$100 per person for one day. Fees include a lunch and banquet on March 1 and lunch on March 2, all featuring Indiana-raised foods.

Three keynote speakers are scheduled: David Swenson, Iowa State University community

economics researcher; Michael Hamm, professor of sustainable agriculture at Michigan State University; and Ed Bell, a Hagerstown strawberry farmer who has overcome physical disabilities.

A trade show is planned both days.

### **CROP BUDGETING**

The Purdue 2013 Crop Cost & Return Guide is available for producers to utilize for their farming operations. The guide isprepared by Purdue Extension specialists in Agricultural Economics and Agronomy. It provides estimates of crop income and expenses for low, mediumand high producing soils.

Total variable input costs for the 2013 corn and soybean crops are likely to stay about the same as last year. The variable input costs are items including seed, fertilizer and pesticides that vary directly with the crop grown. Other costs are considered fixed costs, such as cash rent.

While some individual input prices are expected to increase, some will decrease and others will stay about the same. Fluctuations will serve to cancel outone another and to help keep overall variable costs fairly

stable compared to last season. Seed prices will make the biggest jump in the coming year according to Alan Miller, Purdue Extension Economist. Corn seed is expected to increase by an average of 5-7 percent, and soybean seed prices are likely to increase more than corn.

"The drivers of higher seed prices in 2013 are higher commodity prices, tighter seed supplies due to the 2012 drought and prospects for strong crop returns in 2013," he said. "Soybean seed prices are expected to increase more than seed corn prices because the cost of the commodity is a larger component of the seed price."

Fertilizer prices are a mixed bag. Nitrogen fertilizer prices are climbing, although the price of potash is down about 8 percent from last January because of abundant North American supplies. Phosphate fertilizer prices, while down almost 4 percent from last January, are expected to increase as spring planting season approaches.

Prices paid for chemicals, such as fungicides, herbicides and insecticides, are expected to hold fairly steady, Miller said.

The 2013 Crop Cost & Return Guide can be a useful tool for both farmers and farm land owners. If there are substantial changes in market price forecasts and/or projected expenses as the 2013 planting season approaches, then the guide will likely be updated.

### **N**UMBER **P**LEASE

(article written by Suzanne Slater Boeing, now deceased) Because I grew up in a small Indiana

farming town, content that progress should passitby, I grew up with an institution that not many of my contemporaries enjoyed, and that succeeding generations would not comprehend.

When we picked up the telephone in Warren, Indiana, we did not hear a dial tone. We heard the voice of Ella Blair, also known as "Central". She would say, "Number Please", and we would reply with a number, never larger than three digits. "One Seven", we would say, or "Three Two One". If the person we were calling was on a party line, it would be, "Three Two One, Ring Two".

Mrs Blair worked the busy late afternoon and evening hours and all night long. Most of the time lived in Warren, there were two other ladies who divided up the day shifts. But we did not say, "Pick up the phone and get Mrs Blair", or "Mill Wilhelm must be out for a moment; She doesn't answer." The women who satif front of the big switchboard lost their personal identity and assumed the corporate identity of "Central".

Central operated out of a small house just off the main street.

She wore headphones to free both hands to service the switchboard that was the communications center of Warren. When "Mrs Smith" wanted to talk to "Mrs Jones", she picked up her receiver at home, or maybe cranked the phone on the wall. This activated a small light on the board. Central picked up a cable with a plug on the end and inserted the plug under the light. Then she said, "Number Please" to Mrs Smith. MrsSmithmightsay"Two Four", or "get me Vera Jones please", (either identification worked just as well). Then central would insert a second plug into the phone jack belonging to the Jones's and activate the ringing switch.

There were advantages and disadvantages to this old system. We young people would have preferred "high tech" dial phones; we feared our friends from the city considered our system "hick". Sometimes central was busy and slow to respond to our signal. Of course the primary disadvantage was the lack of privacy inherent in such a system. We were always aware than central might be listening.

But there were such advantages! For instance, emergency calls. One day at my Grandma's the electric stove sparked and flared nearly frightening Grandma to death. She rushed to the phone, picked up the receiver and shouted, "Send the men, we have a fire!" Then she ran back to the kitchen. Now, she had not given the operator her name or address, but no matter. Central knew every light on her board and within minutes she had notified the fire department and activated the Town siren to call the volunteer firefighters from their places of business.

Fortunately our fire was selflimiting; the last spark was sputtering out when the fire truck pulled up in front of our house.

Central also functioned as a telephone directory. If you wanted to order groceries, you picked up the phone and said, "Give me the Sanitary Market". No need to look up the number. And if there were an important call to a busy number, Central would just break in on the ongoing conversation and place the call. Today we have to pay extra for call waiting. Central

also worked at putting through long distance calls. She would stay on the lines all evening if necessary, sometimes using alternate routes to get us to our destination.

Central knew everybody and could find anybody. I remember, sometime in the early 60s, trying to call my mother who was visiting a friend in Warren. I placed the call with the St Louis operator (that's where I was living at the time) and then listened while she called the Warren operator and said "This is St Louis calling, I have a person to person call for an Elizabeth Slater at number Three One." I heard the phone ringing, and then heard central say, "Operator, that number does not answer." Before my operator could pass on this message, Central came on the line. "Suzanne, is that you? Are you trying to reach your mother?" I said, "Yes, She's supposed to be at Lucy's." Central said, "Ithink she and Lucy are over at Beunah's playing cards. Let me call over there." The St Louis operator said nothing. So I talked to my mother, and if Central were listening, I didn't care.

The last time I called someone in Warren, Mother and I were visiting a friend in that town. I asked the friend if I could use her phone. She said, "The phone's over there, but you'll need the phone book in that drawer. You know, we have to dial our numbers now." Mrs Blair had retired, taking into retirement with her a system we can find now only on re-runs of the Andy Griffith show.

## **D**EDUCTIONS THAT COULD DRAMATICALLY CUT YOUR TAX

BILL

(BPT)-For all the talk about taxes during the "fiscal cliff" debate at the end of 2012, many people are still left wondering what it means to them as the April 15 filing date approaches.-

""Is it a big deal? Or is it business as usual?' are questions I'm hearing," says Scott Halliwell, a certified financial planner with USAA. "While many issues were resolved, a lot of taxpayers still aren't sure how their tax returns and deductions are affected." If you're one of those people, brush upon these 10 deductions before tackling your tax return. They are worth reviewing, as they could lower your tax bill.

1. Traditional IRA contributions. You have until April 15 to contribute up to \$5,000 to a traditional IRA for 2012 and, if you qualify, deductit on your tax return. Here are some guidelines:

If you were 50 or older on the last day of 2012, you can contribute up to \$6,000.

If you (and your spouse if you're married) weren't covered by an employer's retirement plan in 2012, you can generally deduct your contribution in full.

If you were covered by an employer plan, you can only take a full deduction if your modified adjusted gross income was \$58,000 or less (\$92,000 or less for married couples filing jointly). Your deduction is reduced if your modified adjusted gross income is higher. If your spouse was covered by a retirement plan at work but you weren't, you're eligible to take a full or partial deduction if your combined adjusted gross income was below \$183,000. See IRS Publication 590 for more details.

- 2. Self-employed retirement plans. If you work for yourself, you can open a Simplified Employee Pension IRA by April 15 and deduct your contribution on your 2012 return. SEP IRAs may be an easy way to create your own retirement plan, and they can allow much higher contributions than traditional IRAs. Contributing to a SEP IRA does not exclude you from making an IRA contribution, but it may affect whether you can take a deduction for it. (A SEP IRA is considered an employersponsored plan).
- 3. Mortgage interest. You're allowed to deduct interest paid on your primary mortgage, as well as home equity loans, home improvement loans and lines of credit. In general, you may deduct interest on up to \$1 million of primary mortgage debt and up to \$100,000 of home equity balances.
- 4. State and local taxes. The federal government generally allows taxpayers to deduct property and income taxes paid

to state and local governments.

- 5. Sales tax. If you didn't pay much state income tax-or live in a state that doesn't tax income at all-you may be able to choose to deduct sales tax instead. And you typically don't need receipts simply calculate an assumed amountusingan IRS table or online calculator.
- 6. Charitable gifts. Make sure you have the right documentation. Cash contributions regardless of the amount require a canceled check or dated receipt. Any contribution of \$250 or more requires bankor payroll deduction records or a written acknowledgement from the charity. Noncash contributions valued at more than \$5,000 generally require an appraisal.
- 7. Education costs. Up to \$2,500 in interest on loans for qualified higher education expenses may be deductible if your adjusted gross income is less than \$75,000 (\$150,000 if you're married and filing a joint return). A portion of your tuition and fees may be deductible if your adjusted gross income is \$80,000 or less (\$160,000 on a joint return).
- 8. Medical and dental costs. You may be able to deduct these expenses if they exceed 7.5 percent of your adjusted gross income.
- 9. Health insurance. In general, self-employed taxpayers may be able to deduct all of their health insurance premiums.
- 10. Health savings accounts. If your family was covered by a high-deductible health insurance plan in 2012, you may be able to contribute up to \$6,250 to a health savings account (\$3,100 if it only covered yourself). Contributions are deductible, and similar to IRAs, you have until April 15 to contribute for the 2012 tax year.
