A LITTLE MORE HISTORY

Upon reading the April 1 edition of the Warren Weekly, I notice what I consider to be a glaring error by the author of the "My Town and Yours" column. I would like to correct the error.

The column's author discusses the Cline-Click Lumber Co., located on N. Nancy St. To my knowledge most of the column is correct, however the column totally eliminates any mention of what I believe to be the longest tenured employee of the "Cline-Click" family.

My father, Hugh Sills, graduated from Bluffton High School, while working for Cline Lumber during his school years. He continued working for Cline following his graduation in approximately 1936, at or near the top of his class. Following his marriage to Jeanne Davenport in 1937, he continued to be employed by Cline Lumber in Bluffton. In approximately 1944 he was promoted to Manager of Cline Lumber in Liberty Center. At that time my parents resided in what is currently the first house north of the railroad tracks in Liberty Center, on the west side. The Lumber Co. was on the south side of the tracks. In 1948, Hugh was promoted to the Manager position at Cline-Click Lumber Co. in Warren. At that time my parents decided to build a new home just south of Warren, where the Shuttleworth's currently reside. My sister and I rode back and forth from Liberty Center to Warren to attend school, while our house was being built. We usually rode back and forth to school with the mailman. Our house was completed in about 1950, and we became permanent residents of Warren.

My father was thus employed as Manager of Cline-Click Lumber, in Warren, from 1948 until his death in 1966 from Hodgkin's disease, thus ending almost 20 years of employment as Manager at Cline-Click in Warren, along with approximately 33 years employment with the Cline Lumber family. My father greatly respected the Cline family and I believe that they

MY TOWN and Yours

In last week's article about Cline Click Lumber I made a mistake and left out one manager. His name was Hugh Sills and he was manager from 1948 to 1966. (see page 2)

In 1915, Floyd Tuner, his wife Audrey and their five year old son Eugene lived in Marion. Floyd worked in a factory and part time in a grocery store. That year, Harry Green, who owned a grocery store in Van Buren, purchased a store in Warren. He asked Floyd if he would be interested in being the manager of the Warren store. After a couple of days he said yes; and they opened Sanitary Market in Warren. Their first store was two buildings south of Kriebaum Hardware.

At first they were not welcome in town because there were six other businesses, in town, that sold groceries. To their advantage there was a hitch rail in front of their store where people would tie their horses too. Twice that year the hitch rail was cut down in the middle of the night. Once a customer wanted a box of post toasties and the Sanitary Market was out so Floyd sent young Eugene to another store to buy a box. Eugene could see the boxes on the shelf but the store owner, recognizing the competitor's son, told him they didn't have any. But in time, they were accepted into the community.

After being at that location for two or three years they moved to the three story building at the corner of First

and Wayne Streets. Floyd let Eugene and the youth of the community play basketball on the third floor of that building. Sometimes he would have to go up and ask them to tone it down a little. In time the third floor became unsafe and they had to remove it. In the summertime, the dirt streets would get real dusty so they had to hire a man with a water wagon each day to settle the dust. Each business would have to pay twenty-five cents a week for this service.

Back in those days most all merchandise would come to the store in bulk. Coffee, beans, rice and crackers would have to be weighed on the balance scale and packaged separately. James Johnson was the only employee they had and his job was to package some of the products for sales when they would get busy. All customers would call him Mr. Johnson for he was unique. Mr. Johnson was blind. Customers would come to town, drop off their eggs they would trade, and then do other town business. Mr. Johnson would count the eggs and little Eugene would write their names on them. Sanitary Market paid twenty-two cents for eggs and thirty cents for butter.

With bulk food in those days, there were some problems. In the summertime crackers in barrels would not stay fresh too long. Cheese cloth had to be put over each barrel to keep the flies out. One time they kept a barrel of flake hominy in the same place in the store and E. P. Miller would dip in for a handful to eat while he visited the store. One day they moved the hominy and replaced it with soap flakes. The handful that day that Mr. Miller took did not cure him of taking a handful but he looked before he dipped from then on.

In 1930, the Sanitary Market moved north to their familiar spot beside the old post office. After struggling during the depression, they started carrying fresh meat. In 1940, Floyd was able to buy the fixtures and stock. Floyd passed away in 1948 and Eugene became the store manager and ran it for his mother. His mother passed away in 1952 and Eugene took over the business.

In the beginning the customer would bring a list in and the Turners would fill what they wanted while they waited or did other shopping. Through the years they changed to self service and found out the customer would buy things that weren't on the list. The bulk goods soon became packaged goods and in the old days you had thirty days to pay for your order. A few years later they took a check when you placed an order. In 1965, Eugene bought the building and after ten more successful years, in 1975, he would retire and sale the Sanitary Market of sixty years to Gene Cady.

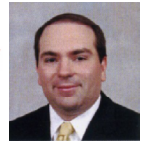

respected him. During his years in Warren, my father employed some very good people, including Dean Cassiday and master millwright Roy Click. Martin Zezula worked part-time, particularly when someone was needed to unload a cement truck or a boxcar of lumber. Elbridge Wooster was made manager at some point, following my dad's passing. Dean was also Manager of Liberty Center, after we moved to Warren.

Following the closing of Cline-Click, I was given the 'office' desk by Bill Cline, which had been made by my father and Roy Click, with a little help from me. After realizing that the desk simply would not fit in my office, I contacted a steward of the Civic Center to ask if they could find a use for it. I was informed that they would love to have it and could use it and a "plaque" of some sort would be provided for it, denoting it's heritage. However I do not know what has become of it since.

I am extremely proud of both of my parents. My Mother, Jeanne, passed away in 1972, after moving back to Bluffton. According to my Dad's W-2's, he made \$1,226.00 in 1940, \$1,800 in 1945 and \$3,600 in 1952, raising three children and enjoying many fishing trips during that time. My Dad was always willing to interrupt his meals and weekends to open up the lumber yard to

allow people to get "one more bag of cement or a couple of 2x4's" to finish their project. He was a member of Kiwanis and President of Kiwanis in 1955. He was an avid fisherman and took a yearly trip to Ontario, Canada with his fishing partners. He was an excellent artist and craftsman, building all of his own boats over the years.

At his death, according to the Register, over 400 people visited the funeral home to show their respect for my Father. Among those visitors were the entire Cline family and extended family, whom my Dad loyally supported over his tenure with Cline and Cline-Click Lumber. Therefore I do not feel that his life should have been totally omitted, when discussing Cline-Click Lumber Co.
