#### FARM BUSINESS PLANNING

Family farmers can get tips from Purdue University specialists on business communication and dealing with accounting and legal issues during a succession planning program.

"Cultivating Strong Indiana Farm Family Relationships for Today and Tomorrow" will be offered in March. The program is presented by Purdue's Women in Agriculture and Farm Succession Planning teams in partnership with the North Central Risk Management Education Center.

The program will be held on March 21 and 28, from 10 a.m. to 2 p.m. at the Purdue Extension Allen County office, 4001 Crescent Ave., Fort Wayne.

Kelly Heckaman, Purdue Extension educator in Kosciusko County, said Indianafarmers and farm wives have asked educators for advice on handling their family businesses.

"In order to get estate planning started in families, they need to be able to communicate about it. And it's an emotional topic, so it can be hard to get those conversations started." Heckaman said. "The workshops will give families ideas on improving their conversations and skills to help them work through their problems and keep their families intact."

Purdue Extension presenters include Janet Ayres, agricultural economist; Angela Gloy, farm business planning specialist; and members of Purdue's Farm Family Succession Planning Team.

Heckaman said the program is a collaboration between Extension and local communities, as organizers will invite local accountants and attorneys to speak on financial strategies. It is being offered at nine other locations in Indiana.

The first-session agenda topics are: "A Great Year to Farm: New Farmer Financial Skills," "The Team Approach: Working Together Through Transition" and "Communicating for Success."

The second session's lineup is "Business Structure and Taxes," "The Truth about Pre- and PostNuptial Agreements" and "Strategies for Managing Conflict."

Registration is \$50 for individuals or \$100 for families up to four members.

January has really flown by and really wondered where it went, but it makes it that much closer to spring time. I was surfing the net one day when I was trying to entertain myself and came across a web site that had lots of

interesting things to check out. I wrote it down and now have misplaced it but I think it was called all about. There was a good garden site there and kept me entertained for quite a while. One that got my attention was a video about starting plants. This person would start cuttings in seed starter or well balanced soil he used a mix of potting soil and added extra peat moss. Instead of dipping the cuttings in rooting compound he dipped them in honey. Naturally I had to get right at it and try it. I took some geranium cuttings and tried it and seems they are doing very well. I used only seed started for the soil. I also started some begonias and they are also doing well. Now I am trying to find room for all of them this when I miss my little greenhouse I had at the other house, but I'm sure I will

I had Wayne's mothers cookbook out and was thinking about finding something unique for the cooking part. She had a Farmers Guide book as my mom did, they are almost like a museum piece in itself with the add ins and personal memos. It covered every thing from beverages to making yeast, beauty and health secrets how to set a proper table. She had cut many things from newspapers and magazines which are now yellowing with age but are priceless to me. Someday I will give my girls each of the books and hope they might pass it on to their daughters. The book was published in 1927 so it is getting some age to it.

One recipe that was hand written and pasted in was Jean's Neighbor's Cake. I have wondered for a long time who Jeans neighbor was. I figured since the recipe was pasted in and very secure it must be a good one. I will try it the next time I have company. Here is the recipe for you to try.

Jeans Neighbor's Cake

1 cup Spry (for us old timers it was like Crisco), 1 2/3 cup sifted sugar, blend it together, 2 cups cake flour sifted 3 times( here my mom said to sift flour once measure out the amount needed and sift 2 more times) add in the flour and 5 eggs one at a time mixing well,1 teaspoon vanilla. Bake in a greased tube pan 1 hour 30 minutes at 325° Then it said wax paper in the bottom greased on both sides. Good luck if you try it, it sounds like it may be similar to a pound cake. I will try it and make a lemon pudding and when cool add in whipped cream to put over it. Enjoy!

#### **COUNCIL NOTES**

The Warren Town Council met Thursday, January 17 in the Council Room in Assembly Hall. President Julia Glessner opened meeting at 5:30 p.m.

Local Scouting Coordinator Christy McCarver was in attendance. She gave a report on Scouting programs and continued upgrades to the Scout Cabin. There was concern about the lack of parking area around the Scout Cabin. Council requested Day to get quotes for gravel and measure the area. Volunteers were to be available for spreading the stone and gravel. Town equipment and personnel were expected to be available to rebuild a hill behind the cabin. In order to meet

Scouting requirements, community service projects are to be made available to the Scouts.

AT&T had submitted an agreement for placement of additional infrastructure and upgrading existing to infrastructure to the Eleventh StreetTower. Afteradiscussion of the situation Council agreed to notify AT&T that placement of additional equipment would result in amendment to the current \$990 per month. Morrison is to contact the company requesting an offer.

Council accepted an offer of \$5000 for the purchase of property at 126 East First Street. Julia Glessner was appointed to the Huntington County **Emergency** Management Advisory Council. Marilyn Morrison has been appointed to Region III-A Board of Directors.

Council agreed to renew the employee benefit insurance. The renewal will show a 6.1 percent reduction in medical premium cost. A \$1500 HAS to each employee to cover the deductible costs.

Ethan Stivers reported the second Chamber of Commerce Expo is scheduled to be held at Salamonie School, The Chamber and Salamonie PROS will work together to schedule a fund raiser during the Expo.

Marilyn Morrison reported that work has been done in the record room on the second floor in preparation for the disposal of non-permanent records. Application must be made to the County committee. A County committee as well has notification to the State Archives before such record may be

removed. The process is expected to be completed during 2013. After discussion, Day was asked to get quotes for new doors on these rooms. He is also to get quotes for the exterior door in the second floor council room which is used by auditors and replacement is to be done by a contractor.

Council approved a quote from Funk in the amount of \$2000 for Fire Station upgrades. This includes drywall and new lighting. Also approved was the payment of \$2000 for replacement of hose and maintenance for some tools on the Rescue Truck. Salamonie Township will share in the cost.

Day reported that Arrow Fence has started work on the replacement and upgrade of the diamond fencing at Tower Park.

According to reports approximately \$5000 damage had been done to a pole at Eighth and Wayne Streets, caused by a semi truck. Because of equipment on the pole, T&B was asked to replace the pole without interruption of power to one third of users.

Marshal Spitler gave the December activity report.

A WHARMM meeting was to be held January 22 in Andrews.

The next Council meeting is scheduled for February 11. An executive meeting was set for 1:15 on Monday, January 21.

#### FLU SEASON

Winter is the season for influenza, and as the flu season continues, State health officials want to remind Hoosiers this is also norovirus or "stomach flu" season. Norovirus is not actually influenza, however, both may be prevented by taking measures to protect yourself.

This season, health officials are reporting that a new strain of norovirus has appeared. This new strain, called GII.4 Sydney, originated in Australia and has been detected throughout Europe and the United States. This strain is overtaking others to become the dominant strain in areas where it has been found. Most people will be susceptible to this new strain; however, it does not carry worse symptoms than others.

Health officials confirm the new GII.4 Sydney strain of norovirus has reached Indiana and say they will continue to investigate outbreaks and monitor disease activity.

"With so much discussion regarding this flu season, it is important for Hoosiers to understand there is a difference between influenza and what is commonly called the stomach flu," said State Health Commissioner William VanNess II, M.D. "Knowing the difference can help prevent both illnesses." Norovirus infection, also known as viral gastroenteritis, is not the flu at all but a viral infection of the intestinal tract. It is spread

through eating or drinking contaminated food or drink or by close contact with an infected person.

Norovirus is more common in the late fall through winter, but infections and outbreaks can occur any time of year. This virus is very contagious and easily spread by infected people, contaminated food or drinks or touching contaminated surfaces. Norovirus can survive on surfaces for up to 72 hours. Symptoms occur about 24 to 48 hours after exposure and include sudden onset of nausea, vomiting diarrhea. Other symptoms may include fever, headache and body aches. Most people recover fully within one to two days without complications.

"Flu shots do not protect against norovirus," said Dr. VanNess. "However norovirus prevention is similar to flu prevention in the need to frequently wash hands, disinfect contaminated surfaces, wash soiled clothing and avoid preparing food if you're not feeling well."

Influenza, by contrast, is a viral infection of the respiratory tract. It is spread by respiratory droplets from close contact with infected persons or contact with contaminated surfaces or objects. Infection can occur when influenza viruses contact the eyes, mouth or nose, and possibly through inhaling droplets from a sneeze or cough. Sometimes people may become infected by touching surfaces or objects contaminated with influenza viruses and then touching their eyes, mouth or

#### **TUITION FREEZE**

Huntington University today announced a tuition freeze for the 2013-14 academic year. For the second time in a decade, the university's Board of Trustees approved a zero percent tuition increase. The tuition freeze will apply to all incoming and returning students, including traditional undergraduates, adults enrolled in professional programs, and graduate

"In these uncertain economic times, students and parents will have one less worry," said President G. Blair Dowden. "While the cost of higher education has escalated across the nation, Huntington University is holding the line on tuition. That's one reason Huntington was listed as a regional best value for five of the past six years. We have worked hard to keep costs competitive while delivering outstanding value and excellent educational results."

Huntington University will also continue to safeguard its students' financial success through its innovative Loan Repayment Program (www.huntington.edu/loans). The program reimburses all or part of a graduate's loan payments if their employment income falls within certain thresholds. Loan repayment assistance was first piloted by Huntington in 2009 and has continued each year for all incoming undergraduate students, regardless of academic major.

"First through its innovative loan repayment plan, and now by freezing tuition, Huntington is making a strong statement on its commitment to afford ability and educational value," said David L. Warren, president of the National Association Independent Colleges and

growing number of private colleges have taken innovative steps to keep students' out-ofpocket costs as low as possible and remain a great value for the dollar. Huntington has been at the vanguard of that movement.

Huntington was one of the first universities in the region to respond to concerns over the cost of higher education by adopting a tuition freeze for the 2004-2005 school year. Room, board and fees will rise slightly to bring the total sticker price to \$32,200, or an overall increase of 1.6 percent. This figure includes a new technology fee which will underwrite a campus wireless and cloud printing initiative (Learn more www.huntington.edu/2013wireless-network).

"Due to generous institutional aid through scholarships and grants, the average student only pays about 60 percent of the full tuition amount before other sources of financial aid, such as state and federal grants and loans, are factored in," said Jeff Berggren, senior vice president for enrollment management and marketing. He also noted that more than 90 percent of undergraduates receive financial aid in the form of scholarships,
