TRI KAPPA WEEK

In recognition of the many contributions that Tri Kappa has made throughout the state of Indiana, "Tri Kappa Week" will be February 18-24, 2001. The Warren Gamma Upsilon Chapter of Tri Kappa will be joining 280 chapters in 148 towns across the state of Indiana in a celebration of 100 years of service to the citizens of the Hoosier state.

Tri Kappa is a unique philanthropic organization because it exists only within the boundaries of Indiana, and thus, all of its contributions benefit the residents of Indiana. The organization was founded in 1901 in Indianapolis by a group of seven young women at the Classic Girl School owned by May Wright Sewall. Each was to begin a chapter in her hometown. From these humble beginnings, Tri Kappa has thrived to 148 active chapters and 132 associate chapters with almost 11,000 members.

Each Tri Kappa Chapter has special projects in its community for charity, culture, and education. Local projects include: Scholarships, Salamonie Eighth Grade Recognition, Washington D.C. Trip, Victims Assistance, Thanksgiving Cheer Baskets, Knight Civic Center basketball and baseball programs, Small World Nursery School, Pulse Opera House, Salamonie Summer Festival and Fireworks, Red Cross and volunteer time to Warren Recreation Program.

Local chapters also support statewide projects. The James Whitcomb Riley Hospital for Children has received contributions of over a half million dollars for equipment and thousands of Riley dolls since it began in 1922. Chapters have collected white towels for the Ronald McDonald House That Love Built. Donations are made annually to the Mental Health Association of Indiana, Indiana Association for Retarded Citizens, Indiana Special Olympics, and many other charitable causes.

Scholarships of over \$5 million have been given since 1913 in the areas of academics, fine arts, journalism, and to non-traditional students. Tri Kappa also maintains an emergency fund for students-in-need at twenty-seven Indiana colleges and universities.

Tri Kappa supports Hoosier Salon and awards fine arts scholarships. The Tri Kappa Art Collection, with almost 100 paintings by artists from Indiana, is on permanent loan to Rose-Hulman Institute of Technology in Terre Haute, Indiana.

Gifted and talented programs at Purdue University, Indiana State University, Rose-Hulman, and the Indiana Academy at Ball State University receive support from Tri Kappa. The expenses are paid for the winning team of the state competition for "We the People" to attend national competition at Washington D.C. This program is designed to engage high school students in a rigorous six-week study of the Constitution and the Bill of Rights.

Each year local chapters and state Tri Kappa give over \$1.3 million to its endeavors of charity, culture and education. For the past 100 years Tri Kappa members have donation untold volunteer hours and millions of dollars to projects in the state of Indiana.

Tri Kappa members will gather in Indianapolis for a Centennial Celebration in April of 2001 during its State Convention.

WWII VETS TO BE HONORED

The French government, in coordination with the secretary of Veterans Affairs and the Indiana Department of Veterans Affairs, has announced they will be issuing a THANK YOU AMERICA CERTIFICATE to veterans who participated in the landing at Normandy and/or in the liberation of France during World War II.

The certificate is meant to express the gratitude of the French people to the veterans who participated in the Normandy landing and/or the liberation of France between June 6, 1944 and May 8, 1945 either on land, on the water or in the air.

Certificates will be issued to eligible Huntington County WWII veterans through the French Consulate in Chicago. Tom Applegate, the Huntington County Veterans' Service Officer, has coordinated with the liaison at the French Embassy and has developed a procedure for veterans to follow.

The French government prefers the certificates not be issued on an individual basis. Certificates

should be requested through the county Veterans' Service Office and will be presented to the veterans in a special THANK YOU AMERICA ceremony to be held at a later date, most likely an upcoming Veteran's Day program. The French government feels it is important that the certificates be presented during an official ceremony. Veterans who see advertisements and applications in various magazines published by veterans organization such as The American Legion and the VFW, are encouraged to send their application through the Veterans' Service Office rather than directly to the French Consulate.

Veterans' Service Officer, Tom Applegate, reminds those veterans who were honored with the Normandy Medal at the Veteran's Day Program in 1993 that this is the certificate which was promised by the French government then, but it must be applied for again at this time.

All WWII veterans who feel they are eligible for this certificate are encouraged to apply. Applications are available at the Veteran's Service Office in the Courthouse Room 106 or by calling the office at 358-4863. Proof of service in France during the designated period of time is required. WWII Army and Air Corp/Force veterans were issued a VWD AGO Form 53-55 Report of Separation. Navy Veterans were issued a NAVPERS-553 form. Both are commonly referred to as a DD Form 214 although that form was not used until the Korean War.

**FEBRUARY IS AMERICAN HEART MONTH
 FOOD FOR THE HEART**

The American Heart Association is changing the way it makes diet recommendations. No more mystifying percentages. The doctors are simply telling us which foods are good (or not good) for heart health.

Fish is a lifesaver. For the first-time, not one but two 3-oz. servings of fatty fish per week are recommended. Whether fresh or canned, tuna, salmon, and mackerel have high levels of desirable omega-3 fatty acids.

- Avoid trans fatty acids found in partly hydrogenated oil. Check labels for partly hydrogenated oil, often found in baked goods, fast foods, and some margarines.

- Eat five fruits and/or vegetables a day. Start with apples, pears, oranges, peas, celery, Brussels sprouts, and squash. Except for cabbage and cauliflower the more colorful, the better.

- For protein eat beans, fish, skinless poultry and lean meats. Six ounces a day is usually enough to keep your muscles healthy.

- Get the right fats and oils. Olives, walnuts, avocados, and canola and olive oil can help raise levels of HDL, the "good cholesterol". All fats should be eaten sparingly.

- Limit processed foods, crackers, and store-bought cookies. They are often made with partly hydrogenated oils that have trans fatty acids.

- Limit fast foods. They are usually high in saturated fats.

- Limit alcohol. Men should have no more than two drinks a day, and women should have no more than one. One drink is 12 oz. of beer, 4 oz. of wine, or 1.5 oz. of liquor.

HOW TO SURVIVE AN UNETHICAL CO-WORKER

It's a pleasure to say that most people we work with are ethical and well-meaning. At some point in your working life, however, you may encounter someone who seems to be sabotaging your career. Here are a few ways to protect yourself.

- Be careful who you trust. Pick your work friends carefully. Even then, don't say anything you wouldn't say to your boss. Be careful with sensitive information. Never share it with anyone.

- Improve communications with your boss. If you have good rapport, a potential backstabber has less room to maneuver. Discuss your workload and ask for more or less work as the situation calls for it.

- Control your reactions. Revenge always makes you look bad. And telling others of the incident is almost as bad. Instead, downplay the attack which may have been simple gossip.

- Confront in private. Keep the talk on the subject, and avoid personal attacks. Ask why the project wasn't working.

SATELLITE PROGRAM

One in ten grandparents in the U.S. have been the primary support of a grandchild at sometime in their lives. Currently six percent of children live in a grandparent headed household. Whatever the reason and situation, these grandparents face a range of difficulties, including legal and policy changes.

Many organizations that provide services for both generations are not prepared to deal with the special needs and situations presented. Legal options are limited and emotionally draining and financially expensive. Few attorneys are familiar with the relevant laws. In most states, statutes are not responsive to the evolving need of grandparents who wish to have more temporary or permanent rights.

A national satellite video program originating from the University of Wisconsin-Extension in Madison, Wisconsin, on February 27, 27, 2001, will examine some of the legal and policy issues that grandparents face and what their options will be. It will also look at ways of improving relationships with agencies and professionals who provide services to grandparents.

The three-hour satellite video, "Grandparents Raising Grandchildren: Legal and Policy Issues" will be broadcast from 1.30 to 4.30 pm. The program will be

available at the Allen County Extension Office, 4001 Crescent Avenue, Fort Wayne IN on the IPFW campus. Cost is \$5.00 (payable on site). Register by calling 219/481-6826. The program will explore the implications of various forms of informal and formal custody arrangements, how laws and policies impact custodial caregivers, ways to improve interaction between grandparents and professionals, including lawyers, medical personnel, schools and social service provider, and how states might design and implement changes in state laws.

The program is sponsored by the University of Wisconsin-Extension Cooperative Extension Service, Purdue University Cooperative Extension Service, AARP, the Brookdale Foundation, Generations United, the Child Welfare League of America and the National Association of State Units on Aging.

"Almost all of us know a grandparent who is caring for a grandchild. Even though it's a common situation, grandparents say they frequently face challenges in obtaining information and services. Their rights as a grandparent are limited, especially for those who do not have formal custody," says Mary Brintnall-Peterson, University of Wisconsin-Extension specialist on aging. "There are a variety of options available, but grandparents need to know the implications of each and what would best fit their situation. Taking legal steps is expensive, and few attorneys specialize in custody options for grandparents."

"Grandparents in several states have found that current laws are not responsive to their special needs," says Dena Targ, human development specialist with Purdue University Cooperative Extension Service. "Many have been successful at designing and changing laws that make it easier and therefore also less expensive for them to receive legal custody. Some of these examples will be shown in the broadcast."

NEW DATES FOR COURSE

The Redirecting Children's Behavior course, originally scheduled to begin February 8, has been rescheduled to begin Thursday, March 8 and continue on Thursdays, March 15 and 22, then April 5 and 12. The course that nearly 1,000 local parents and professionals have taken to learn about children and discipline is celebrating its 10-year anniversary. Classes will meet from 6:30-9:30 p.m. in the 4th floor conference rooms of the current Caylor-Nickel Medical Center.

Redirecting Children's Behavior is designed to help parents, as well as others who work with children of any age. Through five weeks of fun classes, it gives insight into children's behavior, plus tools to redirect it. It shows how to discipline without yelling - how to avoid power struggles - how to get kids to cooperate - how to build self-esteem - and lots more.

Redirecting Children's Behavior is sponsored by Caylor-Nickel Medical Center and Wells Community Hospital. Plus, it has received grants from the Wells County Step Ahead Council and the Caylor-Nickel Foundation. Therefore, the fee for tuition and books is reduced to \$25 for one person or \$35 for a couple who live or work together and share materials.

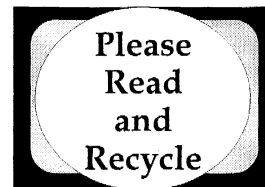
