DOWNTOWN UPDATE

Work began yesterday on the now exterior wall of the NAPA building. The wall will first be prepared by the filling of any holes or penetrations in the wall. As stated previously, an eight foot high level of bricks will be placed first, now that the concrete footers have been poured. The contractor expects the work to proceed very rapidly with the type of scaffolding which is being used. Following placement of brick, the EIFS will be put in place, final leveling of the lots will be done, stone will be placed on the private properties to prevent run off due to rain or snow melt, and the Town property will be prepared for landscaping. Hopefully, the work will be completed within two weeks.

OPENING SOON

Since it was first published in 1885, Robert Louis Stevenson's novella *The Strange Case of Dr. Jekyll and Mr. Hyde* has defied description. Was it a mystery? A detective story? A study of mental illness? A gothic novel? During the late 19th century there was a fascination with the inner conflict between good and evil. Studies had begun on the mental condition which was known as "split personality." What would happen if a man was able to unleash the dark spirits that inhabit his soul?

Shortly after its publication the story hit the stage. There are dozens of stage and radio plays and 123 movies based on the classic tale. In the late 1800's at the Pulse Opera House, traveling theatrical companies and home talent groups performed the show often to the delight of audiences. An article from the January 10, 1895 Warren Tribune stated that "there is horror, remorse, passion, mirth and comedy running through the play that gives to each one of an audience one of their favorite phases of theatrical life."

The current Pulse production is based on a version written by Eberle Thomas and Barbara Redmond in 1990. The framework is a coroner's inquest during which the story is told through a series of flashbacks. Newcomer, the inspector from Scotland Yard, leads the audience through the grim task of finding the murderous man - or is he a beast?

Due to the content of the show, it is not recommended for children age 12 and under.

The Strange Case of Dr. Jekyll & Mr. Hyde runs September 20, 21, 26, 27, 28 & October 3, 4, 5. For online reservations, check out www.pulseoperahouse.org. For phone reservations, call (260) 375-7017 and leave a message. All shows begin at 8:00 p.m. Lobby doors open at 7:00 p.m. and theatre doors open at 7:30 p.m. Tickets are \$12 for general admission. The theatre is located at 127 1/2 Wayne Street in Warren, Indiana.

The Town Council of the Town of Warren met Monday, September 9, 2013 at Assembly Hall, Council Meeting Room, 131 N. Wayne Street, in accordance with rules of Council and applicable law.

to be underway during this week. It is expected that the project will be completed in two weeks. No invoices have been received to date.

In response to a request by Blake and Michelle Woody to close an unimproved portion of Hendricks Street and upon recommendation by Utility Manager Poulson, preliminary approval was given to the closing of the West side of the Street. The other side will remain under ownership of the Town to allow access to utilities.

Ordinance 2013-5, an Ordinance submitted for consideration by the Department of Community Development which would amend the jurisdictional area of the Town for zoning and planning was presented for consideration of adoption. Glessner moved, seconded by Trosper, to adopt. The motion was approved unanimously.

Trosper moved, seconded by Glessner, to accept a quote from Power Line Supply in the amount of \$12,287.25 for replacement of forty five lights on the Tower Park ball diamonds. The motion was approved unanimously.

In continued discussion regarding Well #3, a report from Peerless Midwest was reviewed. A repair to well could be done at the cost of \$7,959 with no guarantee that the leak would be fixed due to the amount of erosion. Option #2, at the cost of \$18,231, is to pull the pump and install a new adapter which comes with a guarantee. Following discussion, Trosper moved, seconded by Brown, to approve Option #2. The motion was approved unanimously. Phase II of the work on Well #3 will begin in the next two weeks.

Reviewed were the situation of the two properties, one at Third and Nancy and one on Grover Street. As the Grover Street property is in litigation, Council, by consensus, determined that a house inspection be requested from the Department of Community Development for the

Third/Nancy Street Property.

Fall Clean-Up has been set for the week of October 7-12.

By consensus, Trosper was appointed to serve on the Chamber of Commerce Park Committee.

Discussed was a request from Mike Haggerty to lease the Municipal Parking Lot for one year to set a monument business. Pros and cons were discussed. It was determined, by consensus, that preliminary approval be given with Morrison to meet with Haggerty and work out details of a proposed lease and report back to Council.

Upon recommendation, Dave Swanson, 146 Dogwood Drive, was appointed to serve on the Warren Public Library Board of Directors.

Christy McCarver, representing the Warren Scouting Program, updated the program and status of projects at the Scout Cabin. Brian Justice will become Cub Master in September.

Utility Manager Poulson reported that the recent odor problem was due to a pump failure at Hy-Line Hatchery which has been rectified. The Boy Scouts, as part of a Community Service Project, will be asked to place sidewalk bricks on palettes for storage until the Chamber park project is completed. A residential surge protector program was discussed which would make units available for home owners for additional protection. More information is needed before a determination is made. Ben Adams, Engineer, will be on site to review projects and to finalize the Langton Estates Cul-de-Sac project. Glessner announced that there are no plans to hire another employee at this time. A paving project will be prepared for bid to be completed in the Spring. Included will be some alleys. Lights on the tennis courts have been repaired and have been restored to a timer system set to turn off at 11:00 pm.

Poulson, reporting as Fire Chief, reported that the department

has been reviewing various air packs. The average retail cost of one Pack is \$6,000.

Marshal Spitler submitted the Monthly Activity Report.

CCC MEMORIAL

A planned memorial to the Civilian Conservation Corps at Ouabache State Park received a boost recently from the Modern Woodmen of America.

The fraternal organization donated \$2,500 to the Friends of Ouabache State Park group to help fund a bronze statue honoring the CCC, which helped build the park more than 80 years ago.

The MWA donation matched funds already raised through Bluffton businesses and the Wells County Historical Society, bringing the memorial fundraising account to around \$5,000. The memorial is expected to cost around \$21,000 and will be funded through donations.

Friends group president Myra Myrtle said she was inspired to bring a CCC memorial to the park so that young people understand the contribution of men like her 90-year-old father, Wayne Lydy, a CCC veteran.

"For so many young people today, when you say CCC, they don't know what you're talking about," Myrtle said.

The CCC was a government work program that provided jobs to young, unemployed men during the Great Depression. The workers developed parks, built roads, trails and fire towers, planted trees and more.
