Rich Apple Cake

2 cups diced peeled apples, 1 cup sugar, 1 cup flour, 11/2 teaspoon cinnamon, 1 egg, 1 teaspoon soda, 1/2 cup chopped nuts.

Combine apples and sugar let set till the sugar is dissolved add in a beaten egg then the sifted dry ingredients and nuts. Bake in sprayed 8x8 pan bake 35-40 minutes.

While baking make a sauce of 1/2 cup brown sugar 1/2 cup granulated sugar. 2 tablespoon flour blend well and add 1 cup water cook till thick and clear. Stir in 1/4 cup butter, 1 teaspoon vanilla stirring till butter is melted. Take cake from oven and pour over the cake the sauce.

PLATELET DONORS VITAL TO PATIENT CARE

"You're golden."

That's what platelet donors hear most every time they come to help save a life through the American Red Cross. And that's because these tiny gold-colored cells in blood are constantly needed by hospital patients with lifethreatening illness or injury.

"Platelet donors are highly valued by medical professionals and by hospital patients and their families," said Sharyn Whitman, CEO for the Indiana-Ohio Blood Services Region of the American Red Cross. "These donors play a vital role in ensuring an adequate supply of a very fragile resource is available when it's most needed-which is literally every day."

Platelets are the clotting components in blood that control bleeding. Patients with serious health conditions like leukemia, cancer and aplastic anemia can't produce enough platelets of their own and often need platelets to survive or to improve their quality of life. Platelets are also essential for many surgeries, trauma care and during the course of chemotherapy.

Platelets for patient care come from volunteer donors make and keep appointments through special Red Cross collection sites. Platelet donations can take from 90 minutes to two hours and involve the use of a cellseparating machine that removes platelets and a small amount of plasma from whole blood, then returns remaining blood components to the donor. Donated platelets only last for five days, and are always in high demand. Donors can give platelets up to 24 times in a 12-month period. Donors can also give blood after waiting a certain number of days between donations and meeting eligibility requirements.

"When you give platelets, chances are someone very sick needs your donation almost immediately," said Whitman. "And since you may be eligible to give platelets more often than you think, you could help save lives throughout the year by simply rolling up your sleeves."

Please bring your Red Cross blood donor card or other form of positive ID when you come to donate. Platelet donors should also be aspirin-free for 48 hours.



HOW TO ROAST AND USE PUMPKINS!

Peter Piper Picked Profoundly Plump Pumpkin --Now what does he do with it? How to Roast a Pumpkin

You can only do this with a freshly carved pumpkin! Do not use on a pumpkin that has been carved and sitting out for several days.

To bake a fresh 6 to 7 pound pumpkin, halve the pumpkin crosswise and scoop out the seeds and strings. Place halves, hollow side down, in a large baking pan covered with aluminum foil and add a little water, Bake, uncovered, at 375 degrees for 1 1/2 to 2 hours or until fork-tender. Remove. When cool, scrape pulp from shells and puree, a little at time, in food processor or blender. Mix with a little salt. To freeze pumpkin puree. Put 1-2 cups in freezer bags along with spices and use in pies.

To use pumpkin puree for recipes: Line a strainer with a double layer of cheesecloth or a flour sack dish towel and let the pumpkin sit to drain out the extra moisture BEFORE cooking with it. Pumpkin is very moist, so in order for your recipe to come out correctly, you MUST strain it.

Roasted Pumpkin Seeds

Boil seeds in water for 5 minutes. Drain well. Sprinkle with salt or seasoned salt. Place a thin layer on a cookie sheet. Bake at 250 degrees. Stir after 30 minutes. Bake 1/ 2-1 hour more or until crunchy.

*Squash seeds may also be used.

WHY LIMBS FALL IN YOUR

Travel around a neighborhood after a storm and you will see tree limbs, large and small, scattered about the ground. Why do some limbs fall in high winds or after ice storms while others merely bend? Should you worry about that large limb overhanging your driveway?

"One reason trees fail is weak branch unions," says Tchukki Andersen, BCMA (board certified master arborist) and staff arborist with the Tree Care Industry Association. "Homeowners can educate themselves about tree limbs, but they should call a professional arborist if they are worried about overhanging branch."

Trees may suffer from naturally formed imperfections that can lead to branch failure at the union of the branch and main stem. There are two types imperfections that create weak unions: a branch union with included bark and an epicormic branch.

Weak unions

Branch unions can be characterized as strong or weak. Strong branch unions have upturned branch bark ridges at branch junctions. Annual rings of wood from the branch grow together with annual rings of wood from the stem, creating a sound, strong union all the way into the center of the tree.

A weak branch union occurs when a branch and stem (or two or more co-dominant stems) grow so closely together that bark grows between them, inside the tree. The term for bark growing inside the tree is "included bark." As more and more bark is included inside the tree, the

weak union is formed that is more likely to fail.

In storm damage surveys conducted by the University Minnesota's Forest Resources Department, 21 percent of all landscape trees that failed in windstorms failed at weak branch unions of codominant stems. Some species are notorious for having included bark: European mountain ash, green ash, hackberry, boxelder, willow, red maple, silver maple, Amur maple, cherry and littleleaf linden.

Epicormic branches

Epicormic branches (also called water sprouts) are formed as a response to poor pruning practices, injury or environmental stress. Epicormic branches are new branches that replaced injured, pruned or declining branches. Commonly, epicormic branches form on the stems and branches of topped trees. When old, large epicormic branches are growing on decaying stems or branches, the epicormics are very likely to fail.

Epicormic branches, by their very nature, form weak unions because they are shallowly attached instead of being attached all the way to the center of the stem. Epicormic branches grow very quickly so they become heavy very quickly. After a time they lose their connection to the main branch and may fall to the ground because the underlying wood cannot support their weight.

"If a weak union is also cracked, cankered or decayed, the union is likely to fail, causing the branch to fall off the tree," says Andersen. "Sometimes, ridges of bark and wood will form on one or both sides of a weakened branch union in order to

stabilize the union. The branch is very likely to fail when a crack forms between the ridges."

Find a professional

A professional arborist can assess your trees to determine whether pruning or removal of limbs is warranted. SAFETY FIRST ON

HALLOWEEN

Just because Halloween celebrates all things scary doesn't mean you want any safety scares of your own this year. Use these tips from USA.gov to make sure you and your family have a fun and safe holiday.

Pick visible costumes. When you're costume shopping, encourage your kids to pick brightly colored costumes. That way it will be easier for cars to see them on dark roads. If they insist on wearing dark colors, stick some reflective tape on the costumes to help them be more noticeable. You can also put reflective tape on their candy bags and give your children flashlights to carry.

Use face paint instead of a mask with your children's costumes. Face paint may work better than a mask when it comes to visibility. If you decide to paint designs on your kids' faces, follow the directions on the face paint packaging closely. You may want to test the face paint a few days before Halloween to make sure it doesn't irritate your children's skin. And make sure to avoid their eyes when you apply it.

Don't snack while trick-ortreating. Wait until you get home so that you have a chance to inspect your children's candy. To prevent snacking, give your kids a small meal before they head out. When they get home, toss out any candy with opened or damaged wrappers and homemade treats, unless you know the giver personally.

Consider using a glow stick or battery-powered lights instead of candles in luminaries or in jack-olanterns, especially around little kids who could get burned or drapery that could catch fire. Make sure your kids Halloween costumes are flame resistant in case a cape or other part of the costume comes near an open flame.
