Background: Beginning January 1, 2006, a new program will provide prescription drug coverage under Medicare. It will be a voluntary program, which provides Prescription Drug Insurance for all people who are eligible for Medicare. It will be administered through dozens of Insurance Companies and hundreds of different plans. Not everyone will need this coverage. Those who already have Prescription Drug coverage through their employer or retirement plan may not want, nor need, this coverage. People who have both Medicare & Medicaid will be automatically enrolled in a plan! Enrollment will not begin until November 15, 2005.

As with any Insurance plan, there will be Premiums, Deductibles and Co-pays. For now, the important thing to do is to become informed about the program and whether or not you should choose to enroll in a plan.

If you are a Medicare beneficiary with limited income and resources, you may be able to get extra help paying for prescription drugs under this program. You will need to apply now to Social Security to see if you qualify for help paying for your monthly premiums, deductibles and co-payments under this new prescription drug program. The Social Security office in Wilkes Barre, PA has mailed out millions of applications to Medicare recipients, which it believes might qualify for extra help. If you have received an application and think you might qualify for this assistance, you must fill out the 5 pages & 16 questions and send it in. This does not enroll you in a Medicare Part D program. It will only allow you to know if you qualify for help paying for your monthly premiums, deductibles and co-payments.

VOLUNTEERS NEEDED

The Huntington County 4-H Program is looking for additional adult volunteers to assist with leadership and guidance with local and township 4-H clubs and Mini 4-H groups. 4-H Club members range from 3rd grade to high school aged young people and typically meet 1-2 times a month from January through the end of summer. Mini 4-H volunteers will help youth in grades kindergarten, 1st and 2nd grades and this involvement runs from May through July.

All potential volunteers must complete a 4-H Volunteer Application Form and proceed through a screening process to ensure an appropriate placement as a volunteer with the Huntington County 4-H program.

Volunteers within the 4-H program have an opportunity to interact with youth, providing guidance and support as the youth people learn a number of life skills such as responsibility, time management skills, dedication, determination and cooperation. There is also a need for individuals to share their talents with youth by assisting with project work and serving as a resource as 4-H members gain knowledge and skills through their project work.

VOLUNTEER RECRUITMENT

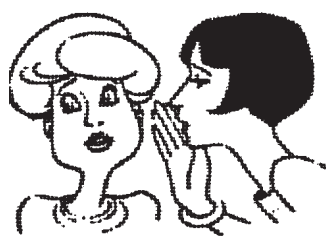

JURY SCAM

Scammers will try anything to steal your identity. They'll even act like they work for your local court. In a new twist, scammers are using "jury duty" to commit identity theft.

Here's how the scam works. The scammer calls, claiming to work for the local court, and claims you've failed to report for jury duty. He tells you there's a warrant out for your arrest. The victim most often says they never received jury duty notification. That's when the scammer asks for the victim's confidential information for "verification" purposes. The scammer asks for the victim's social security number, birth date, and sometimes even for credit card numbers or other private information. It's easy to see why this scam works. The victim is clearly caught off guard, and is understandably upset at the prospect of a warrant being issued for his or her arrest. So, the victim is much less likely to

be vigilant about protecting their confidential information.

In reality, court workers will never call you to ask for your social security number or other private information. In fact, most courts follow up through the mail and rarely, if ever, call prospective jurors.

This jury duty scam is the latest in a series of identity theft scams where scammers use the phone to try to get people to reveal their personal information. Protect yourself. The Better Business Bureau warns: Never give this personal confidential information out when you receive a telephone call.

Here are some other steps you may not have ever thought of, to help protect yourself from Identity Theft:

- When you order checks have only your initials (instead of your first and last name) put on them. If someone takes your checkbook, they will not know if you sign your checks with just your initials or your first name, but your bank will know how you sign your checks.

- When you write checks to pay on your credit card accounts, DO NOT put the complete account number on the "For" line. Instead, just put the last 4 digits. The company knows the rest of the number.

- Put your work phone number on your checks instead of your home phone.

- Use a Post Office box instead of your home address if you can.

- Place the contents of your wallet on a photocopy machine. Copy both sides of each license, credit card, etc. If you lose your wallet, you'll know what you had in your wallet and all of the account numbers and phone numbers to call and cancel.

If your Identity is stolen, file a police report immediately in the jurisdiction where it was stolen, this proves to credit providers you were diligent. Also, call the three national credit-reporting organizations to place a fraud alert on your name and Social Security number. (You can also get a free credit report once a year through each of these companies). They are:

RANKED TENTH

Raabs Ray of Hope Farm, Warren, ranked as tenth largest in registering the most Angus beef cattle in Indiana having recorded 55 head of Angus with the American Angus Association during fiscal year 2005, which ended September 30, according to John Crouch, executive vice president of the American Angus Association.

Angus breeders across the nation in 2005 registered 324,266 head of Angus cattle compared to 298,770 in fiscal 2004. "The year-end statistics with an increase of more than 8 1/2 percent from a year ago, indicate a strong demand for Angus genetics in commercial herds as producers continue to focus on end-product quality and its effect on their bottom line," Crouch said.

The American Angus Association, headquartered in Saint Joseph, Missouri, was founded in 1883. It is the largest beef registry association in the world in terms of both annual registrations and active members. For more information about the Angus breed go to www.angus.org.
