The Van Buren Town Council met on Wednesday, August 3 in the Council Room at Town Hall. At 7 p.m. president Tony Manry opened the meeting and all in attendance repeated the Pledge to the American Flag.

Officer Pat Collins presented the Police Report. He said that the Department is ready for the Popcorn Festival.

Collins also reported that the Department has received two new computers for the police cars through a grant. The computers had the wrong air cards which had to be replaced.

Superintendent Jim Webb said all meters had been read in July.

In November, Webb will be hosting a training session for North Rural Alliance. The session is to train water and wastewater plant operators.

The next Council meeting will be August 17.

COUNCIL NOTES

The Warren Town Council met on Thursday evening, August 11, in Assembly Hall.

At 6:30 p.m. president Julia Glessner called the meeting to order.

Following the pledge, a moment of silence was held in memory of Ronald Boxell, who passed away on Wednesday, August 3.

Mason Floor of Markle was

scheduled to clean carpets at Assembly Hall on Friday, August 12.

An invoice in the amount of \$954 was submitted for installation of a security system at the garage at 114 East First Street. Council approved the installation.

A resident in attendance inquired about the usage of four wheelers on town streets. Following discussion of the situation, Council determined that the resident would be allowed to use his Polaris as the distance to be covered to leave the town limits was little more than a block. Council determined that an ordinance to allow usage of four-wheelers would not be introduced.

Due to the death of Ron Boxell, steps were taken to fill the vacancy. Anyone interested in the position must submit a letter of interest by August 19. A special meeting will be held August 22 to review the letters and possibly appoint to fill the position.

An application had been made to rezone a section of town on State Road 5 across from the Fire Station and several other businesses to General Business Retail from R4. Morrison reported that the Warren Plan Commission gave a favorable recommendation, voting 6-0 following a public hearing. Ordinance 2011-4 was introduced. A Special Meeting is set for Thursday, August 18 to consider adoption of the Ordinance. The Warren Zoning Appeals will meet on Wednesday, August 17, at which time they will consider a request of variance for the same location regarding number of parking spaces.

Council had received photographs of the roofs at 118 N Wayne and 124 N Wayne. Both photos showed problem areas. The photo at 118 N Wayne showed exposed rafters. A discussion was held and Council decided that a letter should be sent to the owner of 118 N Wayne expressing their concern about the hazards presented by the building which has also been seriously damaged by fire. A certified letter was to be sent

to the owner stating that action is being considered due to the condition of the building. The property at 124 N Wayne Street is scheduled for September 29 tax sales. Action will be considered following that date.

Council had received a letter from Larry Owen, Wells County Highway Engineer, stating intent to apply for a grant through Transportation Enhancement to establish a public access site along the Salamonie River. The Town is being invited to participate in the project, to establish an access site also.

Council is considering an area around the Scout Cabin for installation of a boat ramp and recreational area. That concept had been discussed previously. Morrison is to contact Owen in regard to the time table and information needed for submission.

Council voted to donate \$700 to the Huntington County Sheriff's Department to help with the purchase of a police dog. This will replace a police dog retired in 2005. Marshal Spitler reported on recent need for use of canine units from the State and from the City of Huntington.

Ordinances 2001-1, 2 and 3 were introduced, concerning wages and benefits. The wages section showed a .58 increase as previously discussed by Council. The Clerk-Treasurer increase was reflected in the fixed wages of the elected and appointed officials ordinance.

Council requested that Morrison contact the owner of the (old) Fire Station, adjacent to the Police Station to ask the selling price of the building. The building is now listed for sale. Council will then decide whether to move forward with appraisals of the building for consideration of purchase.

Morrison said the Clerk's Office will now be listed as the contact site for the Indiana Main Street Program. Jeff Souder, Warren Area Chamber of Commerce, agreed to make the necessary changes.

There will be a special meeting on September 19 for consideration of adoption of

the 2012 budget. Also, The Clerk's office will be closed September 20 for computer software training by Keystone.

Utility manager Day reported that tree trimming and removal project is continuing on Wayne Street.

Quotes were submitted for a long reach chain saw for use in the bucket trucks: American Safety, \$1,847.34 and WESCO \$1176. Reed City had been contacted but need not supply a quote. It was voted to purchase from WESCO.

Quotes were submitted for reroofing the Scout Cabin with steel: Zeller Construction \$7350; Kiel & Sons \$7600 and Widmeyer Construction \$6972. The Widmeyer Construction quote was accepted.

June and July reports were submitted by Marshal Spitler. He requested two AED units (Automatic External Defibrillator) for placement in the primary police vehicle. The matter had been discussed previously but no decision made. Requested was Zoll AED's to be compatible with the other units being used in the county by medical and law enforcement units. The units would be made available by American AED Inc. at the same price as quoted for the purchase of a unit for the Electric Utility, \$1,399 each. Council agreed to the purchase.

Day reported that an area of the Park has been selected as a possible smoking area if Tower Park is made non-smoking. Council has requested that an ordinance be prepared for consideration.

There will be no fee to take the exam at the three aforementioned testing locations, however, no walk-ins will be accepted. There will be a limit of 100 registered individuals at each site.

Those who wish to sign up for the program can find a complete up-to-date list of contact information for the exam sites at the following Web site: <http://www.ppp.purdue.edu>. A draft manual for Category 14 can also be found at this site. It is important to read and review this manual in advance of taking the exam.

The new rule called "Certification for Distributors and Users of Fertilizer Materials" takes effect on January 1, 2012. The Category 14 certification was initiated by the Office of the Indiana State Chemist (OSIC) to license individuals who must comply with the new rule.

There are two basic parts to the rule:

- Those hired to apply, handle or transport fertilizer for agricultural purposes within Indiana must become certified through the OSIC by Jan. 1, 2012.

- Anyone applying manure from confined feeding operations must become certified through the OSIC by Jan. 1, 2012.

A state law in 2009 was passed by the Indiana General Assembly to create the rule. It is administered through the Office of the Indiana State Chemist (OISC). Note that for the purposes of this rule

"fertilizer material" is defined to mean both commercial fertilizer and manure from a confined feeding operation (CFO).

CFOs are livestock facilities that house at least 300 cattle or 600 swine or sheep or 30,000 fowl, such as chickens, turkeys or other poultry. There are about 1,500 CFOs in Indiana.

The Category 14 exam consists of about 70 questions. As noted earlier, the exam is free, although remote testing sites operated by a contracted vendor of H&R Block charge a fee. Passing the exam qualifies participants to be licensed. A five-year private applicator license is \$20, while a fertilizer business license is \$45 and good for one year. A one-year fertilizer distributor license is \$45 and requires no certification exam. No extra license fees will be charged to those holding pesticide licenses.

blessed because, not only do these volunteers rescue these helpless critters but they also make it easier and affordable to be a responsible pet owner. They provide help with shots and spay and neutering clinics. We have fewer unwanted animals because these people devote their time and money into saving these happy living things.

My vet, Clyde Brooks who is the Co-Chair of this Fundraising project speculated that it would be nice to not need an animal shelter. Another vet, Dr. McPherson said that he went into schools teaching children what it means to be a responsible pet owner. Several parents would get upset with him because they were being shamed by their children to get their dogs and cats fixed so there would not be any more unwanted puppies and kittens.

This is a big part of being a responsible pet owner. We want to teach our children responsibility by getting them a pet. Our dogs and cats need; food, water, shelter, love, companionship and routines, just like you do. Some of the funniest testimonials I receive have to do with our pets. One lady as she was putting her shoes in the morning, her dog would bring her the leash because shoes had to mean they were going for a walk.

Our homes would not be the same without our animals. When you are ready to get a new pet for your home please check with your local animal shelter. All of my dogs and cats are rescue animals. The first dog I ever got on my own was from a shelter.

His name was Ranger and I believe that dog saved my life when someone tried to rob the store I had opened at the crack of dawn. Some stranger came in the door and every hair stood up on Ranger's back. That dog loved everyone. I just looked at that man and said, I

don't know what you have in mind but if you don't get out of here Ranger is going to attack you. That man hit the door running and Ranger was right after him; keeping him away from the door. The dog didn't attack but I know in my heart that Ranger protected me from evil.

This week I got these two quotes. I don't know who to attribute them to but they are worth sharing. "Until one has loved an animal, part of their soul remains unawakened." The next quote says it all, "To the world, you are just one more rescue person. To a rescued pet, you are the world."

bath," "I thought you were stronger than that," or "Do you know how you make me feel talking like that."

And get some rest. America is a one great collection of sleep deprivation these days and being overly tired puts anyone on the edge of possible depression.

Believe that life is like a balloon. Things go up and things go down and when down days seem ready to take over...believe that like that proverbial door that has just closed...another door will open and there may well be a collection of smiles on the other side.

When the leg hurt and I told myself, "Suppose it didn't hurt because you'd had a stroke and it was paralyzed with no feeling." I did this with every negative and never gave a negative time to grow.

I know this - I get excited when I meet someone who deserves to be in a "Rocky" movie. Someone who accepts the fact that life begins as a blank sheet of paper and that before the final writing, there will be written a large collection of bright and shining joys and darker days of sorrow.
