TELEPHONE PRIVACY

If you are registered for Indiana's Telephone Privacy List. The law is now in effect. The following are answers to three "frequently asked questions" about the Telephone Privacy program. You may find them helpful.

Q: Will the Telephone Privacy law stop all telephone solicitations?

A: No. The Indiana General Assembly did provide exemptions for certain types of calls. Unfortunately, we cannot stop calls exempted by the law. Those calls include:

— Calls made at the express request of the consumer.

— Calls related to an existing debt or contract for which payment or performance had not been completed at the time of the call. (e.g., a debt you owe).

— Calls made on behalf of charitable organizations if the calls were made by employees or volunteers of the charitable organization.

— Calls made by real estate brokers or salespersons.

— Calls made by insurance agents soliciting the sale of insurance products.

— Calls soliciting the sale of newspaper subscriptions if the calls were made by employees or volunteers of the newspaper.

Q: What do I do if I receive a telephone solicitation?

A: Don't hang up. Get as much information as possible before terminating the call. In particular, we need the following from you in order to pursue your complaint:

— Name of the firm making the call.

— Date and time of the call.

— Product or service offered.

— Telephone number. (While this is not always possible, please make every effort to get a telephone number)

— Your participation. We ask that you be prepared to testify in court and obtain phone records from your telecommunications carrier.

Q: How do I file a complaint?

A: Filing a complaint is simple. Just visit our website:

www.in.gov/attorneygeneral, download and complete a complaint form, and mail it to the address noted on the form. If you do not have internet access, you can call 1-812-355-5915 to request a complaint form. Please note that this number is different than the number used to register for the Telephone Privacy List.

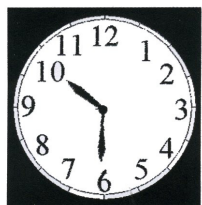

BAYVIEW READING

Bayview Reading Club met October 9 at 2 P.M. in the Calico Room of Heritage Pointe. Enjoying the gathering were six regular members and two guests, Jane Garrison and Joyce Shepherd. After the group's reading of the Collect, minutes of the September meeting were read and approved as corrected.

The report of the treasury, also approved, acknowledged the gift given to Heritage Pointe's United Methodist Memorial Foundation Fund in memory of a loved member, Iva Mae Wygant. President Lilly Nutter reported on get well cards sent out during the past month, and also that the Warren Library would be happy to receive archival materials from Bayview happenings in past years. The Bayview Club gave deep interest and support to the establishment of the library: the first library board met in 1916.

Margaret Bell asked members if they would accept as program in December a book review from a book she enjoyed, appropriate to the Christmas season — How Far To Bethlehem. The group approved.

Program contributions from recent reading began, with Helen Stokes, who shared an article entitled "Our Bright Future" by Jim Flinch, senior editor of Guideposts. The author noted he was the father of a 4-year-old daughter and is deeply concerned about environmental changes and what they will mean to his daughter when she is grown. An example of problems ahead is evidenced in the fact that of the 150 glaciers in the National Park 100 years ago, there are now 27. He quotes a Middlebury, VT professor, a man of science and faith, who sees the church as a source of different lifestyle, with a role in our society's economics and community living.

Helen Jo Strassner read an entertaining piece of fiction entitled "Husbands," in which women are offered an opportunity at a very

unusual shopping center, open only to women to choose one floor on which to shop. All 5 floors are stocked with men, each one better than the last, as one goes up. But, she may choose one floor only! For example, 1st floor offered men who loved kids and had good paying jobs. The "husband shopper" we are observing decided to try floor 2, and found, in addition to the qualities of Floor 1, the men were good looking. Floor 3 had to be seen; it had men who were available who had all the previous qualities plus being housework helpers. The temptation being too strong, the "husband shopper" went up to Floor 4, where men's qualities (as found earlier) included in addition that of good lovers. Oh my, she decided she had to choose the top. Floor 5. Here was a notice: "This is to prove that women are impossible to please!"

Martha Rumble reported a great story from her own life situation. A grandson, Jacob, has been working during his recent leave from the Navy, at Huntington's Lincoln Elementary School. He has been helping with a special training program in team building. Together, the students and leaders use music, active participation, discussion of powers we all have, making choices, developing skills, and becoming life-long good citizens. Jacob is in his last of 3 years in the Navy as an electrician in the Navy's nuclear section — submarines — and a living example of qualities the classes promote.

Bonnie Halvorson provided some light-hearted quotes, such as: "DID YOU KNOW months that begin with a Sunday will always have a 'Friday the 13th?!'" Also, Facing Fears Head-On: The thought of my first airplane trip terrified me. But after the ticket agent quoted statistics proving that flying was safe, I felt much better. "Now take this to Gate 22," he said, handing me my ticket. "That's where we give out the helmets, scarves, goggles and parachutes."

Margaret Bell read a newspaper account of a really useful happening via the new internet feature, "Facebook." Although sometimes derided as no good or harmful, this photo registry of young people on computer, which took colleges by storm a few years ago, served a wonderful purpose for a woman who had given up her son for adoption, when in later years

wished she could locate him. After traditional attempts were unsuccessful, she went into "Facebook" and thought she saw someone with her son's name who also looked like he might look. A further picture seemed even more "right" as well as in a probable location. She called him, and not only was he the one, but he had been looking for her!

Lilly Nutter found interesting reading about the possibilities of the electric wind turbine (looks like a 3-bladed windmill) to produce less expensive energy. These are especially attractive now to farmers, and one is under construction now in northwest Indiana's Benton County — 87 turbines. It will be the state's first electricity generating wind farm, and contracts to sell the power are starting in May. Individual farmers are also putting up turbines for their own use. Iowa has an estimated 600 turbines which could power 140,000 homes. Look for these fields of windmills!

The meeting adjourned after roll call and discussion of today's interesting topics.

FIRE ALARM INFO

Not all Fires are the same — There are slow smoldering fires and fast flaming fires. This depends on what catches on fire. Smoldering fires produce a lot of dangerous smoke before breaking into flames. Flaming fires are very hot, fast moving and dangerous.

Not all Fire Alarms are the same — There are fire alarms that are faster for detecting slow smoldering fires (photoelectric), some that are faster for detecting fast flaming fires (ionization) and some that use both technologies (dual sensor photoelectric and ionization). Neither technology is new but they were equal when we had mostly natural fibers in our homes. Now the difference in technology is very important.

Install Dual Sensor Smoke Alarms — Because the synthetic materials we commonly use in the home smolder longer before breaking into flames, it is wise to use smoke alarms that will alert you as early as possible for either type of fire. This means having two types of alarms or a dual sensor fire alarm.

1. We do not recommend the removal of existing ionization smoke alarms. However, we strongly recommend installing a combination of photoelectric and

ionization smoke alarms in homes, to provide the best chance of escape for all types of fires.

2. It is imperative every resident evaluate his or her smoke detection system to ensure there is sufficient protection in every home.

Test Alarms — Alarms should be tested monthly and batteries should be replaced once per year.

Know how to escape when the alarm sounds — Draw a map of your home, find 2 ways out of each room, practice the plan with everyone in the household using the test button of your dual sensor alarms and decide on a meeting place outside and away from the house. Celebrate when everyone makes it to your meeting place!
