MEMORIAL TO HONOR 16 MILLION VETERANS OF WORLD WAR II

Almost 60 years have passed since the end of World War II. Now the wait is almost over for the 16.1 million people who served. The National WWII Memorial on the Mall in Washington, D.C., will be formally dedicated on May 29.

The four-day event begins with the WWII Reunion on May 27, will mark the dedication of the Memorial. It could be the largest gathering of WWII veterans ever. Open-air and tented attractions are free to the public

A Salute to World War II Veterans, sponsored by the American Battle Monuments Commission, will be held at the MCI Center in downtown Washington. The Salute features armed forces personnel in a musical and narrative tribute to veterans. It will be performed in the afternoon and evening of Friday, May 28 and on Saturday evening, May 29. Pillars of the Memorial represent each state and territory from that era and the District of Columbia. Each is topped with two bronze wreaths. The Atlantic and Pacific arches symbolize the theaters of the war. Inside, each has four bronze columns that support huge American

There were 291,557 battle deaths in World War II and 113,842 nontheater deaths. Today, there are 4.4 million living veterans, but an estimated 385,369 die each year.







BBB LISTS HOT TIPS

FORT WAYNE, Ind. — The Better Business Bureau is sharing information about scams recently uncovered, many in Indiana. Consumers can protect themselves more readily if they are aware of fraudulent practices currently being attempted. If it's too good to be true, it probably is! There are some very serious scams taking place in Indiana—we ask that you use extreme caution. Call Us First!

Credit Foundation of America claims to be "America's first choice for Credit Counseling." They also state, "Be Debt Free. Start today!" "100% Debt Relief." "We consolidate unsecured debt." Consumers have complained about unauthorized bank debits, which in some cases caused overdraft charges, and not paying creditors, which caused declining credit scores and credit reports. An Indiana consumer saw an ad in the newspaper and decided to call the BBB first. Good movel

Debt Management Foundation Services advertises they will "reduce or eliminate interest" and "reduce the term on your debts by 50%." An Indiana consumer received a message on the answering machine and called the BBB to get the scoop and saved herself from being victim of a scam.

Consumer Info.com states you can, "Get your free credit report online in seconds, and it's "Free! Free!" An Indiana consumer signed up for her free credit report, not realizing that she was signing up for a credit report monitoring membership, which resulted in \$238 being taken out of her bank account.

Grant Finders offers to find grants for consumers so they can pay off their debts. Sounds like one embarrassed Greenfield consumer fell for their pitch. The Minnesota Attorney General's Office has filed a consumer fraud lawsuit against this company because of deceptive sales tactics. The suit further alleges the company directed consumers to divulge sensitive personal information, including bank account and credit card numbers. The case is pending.

One National Learning is advertising in Indiana newspapers claiming to be searching for employees to do data entry for insurance companies. The BBB has received numerous calls. The company is not hiring, but instead is selling software for an upfront fee of \$60. This company has the Bureau's lowest rating for misleading advertising.

Member Works operates under 23 names, primarily offering member discounts at participating companies. The cost is typically \$199.95 per year. If consumers don't cancel by the end of the 30-day trial period, the membership is automatically charged to the consumer's credit card, debit card or bank account. Conversations are taped, and the company states consumers are aware of this negative option plan. Consumers have complained about unauthorized billings

900 Direct is an adult 900 telephone service. Consumers have complained about receiving bills for phone calls not made and rude customer service representatives. Some consumers allege they weren't in the house when these phone calls were supposedly made.

Crystal Dreams contacted a Fort Wayne consumer and informed her that she was a finalist in a sweepstakes sponsored by MasterCard And in half an hour. they were going to draw the winner for \$65,000. They asked for a number from the back of her credit card. Well, a half hour later they call, she wins. He gave her his name, private (overseas) phone number of 011-346-281-69318 to contact him. She was to receive cashier's check in five payments. She became suspicious and called MasterCard and they told her that within that half hour of waiting, a lot of activity was going on in her account. After three unsuccessful attempts to draw several thousands of dollars from her credit card account, a fourth attempt to draw \$990 had been cleared from her account by the fraudulent caller

Multi Plays of America publishes a lottery magazine, which sup-

posedly tracks winning lottery numbers and selects "probable" winning numbers. A trial subscription costs \$39.95, with subsequent payments of \$149 per month. Consumers allege high pressure and deceptive sales practices and unauthorized bank or credit card charges.

Warner Health Care sells the product Avlimil on TV. The company claims their product will enhance a woman's libido. 571 complaints have been filed against this company; most are concerning selling practices, contract disputes and unauthorized charges.

Infone Publications markets a phone listing service and sells advertising in their publication. An Indiana doctor's office was invoiced for \$389.95. Now they are being charged an additional \$400 every 6 months. An employee of the doctor's office feels that only a part of the soliciting telephone conversation was recorded to make it appear she was agreeing to purchase the ads.

Ameritek? We received a call from a BBB member in Kokomo regarding a call he received from "Ameritek". He knew the call was suspicious since Ameritek is now SBC. The call location was Cleveland, OH and the number on his answering machine was 216.267.6672. The caller asked him how often he used Yellow Pages and offered him a two-week subscription to the Kokomo Tribune if he answered some questions for her. He declined. He contacted both SBC and the

Kokomo Tribune and neither company had any offers such as the ones the caller described. Thi member asked that other businesses in northeast Indiana be made aware of this possible scam.
