Trees Offered

Once again, the Warren Town Council has entered a program to provide trees to Warren citizens at a reasonable cost through Steve's Landscaping of Bluffton.

The six to seven foot Maple or Summit Ash trees may be ordered through Town Hall and will cost \$25 each. To be available in mid March, the trees will be dry root and will need to be planted soon after delivery and will require some care in growth. Those purchasing trees will be notified by phone as soon as delivery time is known to give time to prepare for planting. Once again, Town employees will deliver the trees to the homeowner. It is requested that in planting trees, consideration be given to location so that in reaching maturity, interference with known overhead or underground utilities and street and alley access will be lessened. Payment for the trees must accompany the order or be made prior to the February 14th deadline.

Adult Day Care Tour

A local group of employers and some service agencies known as the Family and Work Life Task Force have been meeting to discuss the issue of adult day care in Huntington County. The task force recognizes the need for an adult day care facility in our community as does a survey done by the Senior Community Task Force. Much like a child care program, an adult day care provides families a place to take adults who may need supervision during the day. Utilization may be temporary, when someone is recovering from an injury and cannot care for themselves, or more permanent for people with disabilities or older adults who family members don't want to leave alone. The facilities themselves may accept different levels of clients from those just needing supervision and activities to those needing therapy and/or administration of medications.

To help bring this idea to reality in Huntington County the task force is planning a tour of an adult day care facility in Decatur, on Tuesday, February 25, 2003. We hope that an individual or church will want to pursue opening an

adult day care program locally. Anyone who is interested is welcome to attend. The group will be carpooling from the Marsh parking lot at 1:00 pm that day. MARQUARDT SCHOLARSHIP

Applications are now available for the Marquardt Farm Scholarship. The scholarship is open to students studying agriculture at any Purdue University campus. Applicants must be residents of Wells Adams, Allen, DeKalb, Huntington. Noble, or Whitley counties. Approximately 50 - 75 scholarships (\$300 - \$500) will be awarded.

The scholarship fund was created by Bert Marquardt, a farmer in Allen County who donated his 210 acre farm in 1974 to Purdue University so that 50% of the yearly profit could go to School of Agriculture scholarships.

Through the years, several hundred students have benefited from the scholarship fund thanks to the vision and foresight of Bert A. Marquardt.



DNR SEEKS INPUT





To open the Settings for High Contrast dialog box, open Accessibility Options, click the Display tab, and then, under High Contrast, click Settings.

If you try to change the visual style for windows and buttons by using the performance options in the System tool, Windows XP may not apply the change.
