SKATE BOARDING PROBLEM

There is growing concern for the safety of local skateboarding enthusiasts in the downtown area of Van Buren.

On any rainfree day a stop at the intersection of First and Main Streets, a number of skateboard enthusiasts may be seen participating in the event.

While skateboarding is a popular sport a number of accidents can happen. Those participating in the activity frequently ride into the street into the path of oncoming vehicles.

This raises the question, should skateboarding be allowed in the

downtown area? An injured skateboarder could prove costly to the town. Providing a restricted area for the sport would also be costly.

Is your child an avid skateboard fan? As a parent have you advised them about safety practices. Wouldn't it be wiser to advise a child how to avoid serious injury?

These skating fans are not all children.

Council has discussed this problem and plan to have an Ordinance soon. When that is in force, Police Officers will be authorized to enforce the Ordinance.

It has also been noted that not only have skateboarders been a problem in the downtown area, but they are abusing the local park. They have been reported to be skating on equipment. There is an Ordinance in that area.

DIARY OF ANNE FRANK

Most everyone knows the name Anne Frank. Either you read her diary or studied it in school. But do you really know Anne Frank? Join the Pulse Opera House, Warren, as they give her a voice in the performance of "The Diary of Anne Frank." The show opens Friday, September 26 and runs weekends through October 11.

In July of 1942, Anne and her family went into hiding to avoid Hitler's persecution of the Jews. For two years Anne wrote about growing up as well as the fear of being discovered. In August of 1944 they were found and only her father, Otto Frank, survived. But her diary and her hopes and dreams live on. Anne wrote in her diary that she wanted to be a published author and her father fulfilled that wish when he had her diary published in 1947.

This show is highly recommended for audiences of all ages. The drama reminds us of the freedoms we often take for granted. It is also a lesson on the virtues of life.

The show features a veteran cast of actors that bring the story to life. Seeing, hearing and experiencing Anne's words on stage brings new meaning to their poignancy. "Nobody need wait a single moment before starting to improve the world" Anne Frank.

And a special thank you to the enthusiastic and supportive parents who brought in donated food items, gave of their time during the meal, and recruited family and friends to attend.

Throughout the meal, many individuals asked for copies of the two breakfast casseroles served. We're not sure of the original origin of either, but they are favorites of those at the First Baptist Church in Warren.

Sausage & Egg Casserole (Julie Trout shared this recipe)

- 1 lb. sausage, browned & drained
- 7 slices of bread, cubed
- 6 eggs, beaten
- 2 c. milk
- 1 tsp. dry mustard
- 1/2 tsp. salt
- 1/4 tsp. pepper
- 1 c. grated cheddar cheese

Mix eggs, milk, mustard, salt & pepper. Put bread in bottom of greased 9/13 pan. Layer sausage over bread. Pour egg mixture over all. Refrigerate overnight. Add cheese before baking. Bake @ 350 degrees for 45 minutes.

French Toast Casserole (Emily Bothast shared this recipe)

- 14 slices of bread, cubed
- 8 oz. cream cheese, cubed
- 8 eggs
- 1 c. milk
- 1/2 c. maple syrup
- (blueberries, cinnamon, powdered sugar— optional)

Arrange 1/2 of the bread cubes in a greased 9x13 pan. Top with cream cheese cubes, then remaining bread cubes. Whisk eggs, milk & syrup together. Pour over bread. Cover with foil and refrigerate overnight. Remove from refrigerator 30 minutes before baking. Keep covered and bake @ 350 degrees for 30 minutes. Uncover and bake 30 minutes longer.

What the heck is 'cupping'? Coffee has many flavor, body and aroma characteristics that vary from origin to origin. The art of distinguishing these subtle nuances is referred to professionally as "cupping".

TOOTH TIPS

WHAT IS PULP CAPPING??

Damage to the pulp (nerve) of a tooth by decay or trauma does not always require treatment as radical as a root canal or extraction. If damage to the pulp is very slight, and recent, your dentist may choose to treat it with a process called "pulp capping". When trauma or removal of decay exposes the pulp, the dentist might apply a protective layer of calcium hydroxide over the pulp, and can fill the tooth with a temporary cover or a permanent filling. If the dentin next to the pulp is not completely destroyed by decay, an indirect pulp cap would be indicated. That too, involves a thin layer of calcium hydroxide and a temporary or permanent filling. If a temporary filling is placed, the patient will return in 4-6 weeks for an x-ray and clinical exam to determine if a permanent filling will be the treatment of choice. If the pulp appears unhealthy (ex. bleeds heavily) or symptoms such as pain (nocturnal), prolonged discomfort on exposure to hot/cold or both and biting pressure, root canal or extraction would be indicated.

WARREN'S CHURCHES IN WW-II

Life in a small, midwestern farming community during the early 1940's was not exactly a "sheltered" life, but it did not offer the diversity in religions that those in the larger cities saw. I have often recounted to people that I, being a "bible-belt Methodist", did not interface or come in contact with people of some religions until I was drafted into the Army.

Even though I, as a teenager, was aware that there was a large Catholic Church in Huntington, I had no contact with those who attended that church. It wasn't that I didn't want contact...it's just that one could live his life in Warren without the necessity to seek it out. And I have related to my children that I didn't interact with those of the Jewish Faith until I was in the Army in my early 20's. Again, I didn't feel like I lead a sheltered life...I just lived a normal life in a small Indiana town.

When I went to write this chapter on the Churches of Warren during WW-II, I was sure that I should review copies of the Warren Tribune of those years. I remembered that they always included in each paper a listing of all the Warren churches and their schedules for the week. So my wife and I scheduled a visit to the Warren Library to do some more research.

We drove to Warren, and arrived before the Library had opened. So we decided to drive around town and review my knowledge of each of the church buildings. I knew that there were six churches in Warren, and one in Jefferson Township across from the old High School. We drove around Warren, and found FIVE, but that's all we could find! I checked my notes, and found that we hadn't seen the Church of the Nazarene. I wondered what had happened. But after more driving up and down streets, I saw their new church up on the hill on First Street heading East out of town.

In 1941, the Nazarene Church was located on College Street. Their Pastor was Edith Hunt. Their Sunday School was at 9:30, and their Morning Worship was at 10:30. They relocated to their new location in 1972. The Church of Christ, located at their present site at Third and Wayne, had as their Minister Carl C. Cole. Ruskin Laymon was the Superintendent. Services were at the same time as above.

The church at the corner of Second and Main was formerly the Congregational Christian Church. In the early 1940's, Reverend W.M. Jay was the pastor; he was replaced by Reverend Roger E. Malsbary in 1941. Paul Riggs was the Superintendent during the War. In 1965, the name of the church was changed to the United Church of Christ.

The Methodist Church continued to be located in its site at the corner of Third and Main; it had as its Pastor during the War Reverend V. O. Vernon. From the records I have found, Curtis Fox was the Superintendent during the early

War Years. The First Baptist Church was located at the corner of Eighth and Wayne Streets. Its Pastor during the War Years was Reverend C. Wilhelm. It has been remodeled and enlarged to become a very beautiful, small-town church.

The sixth church located in Warren during the years of the War was the Wesleyan Methodist Church. It was located at the corner of Sixth and Nancy Street. In early 1941, their Pastor was the Reverend J.C. Picket; and the Sunday School Superintendent was Volney Zent. The newspapers of that time report that later in 1941, the Reverend Glen Appleman became Pastor of the church, and Volney Zent continued as Sunday School Superintendent. Still later, the newspaper reported J.K. Dunn as the Pastor. The Plummer Chapel Wesleyan Methodist Church was also one of Reverend Appleman and Reverend Dunn's churches; Cyril Burns was the Sunday School Superintendent there. Services would be at the Warren Church at 10:30 AM, and at The Plummer Chapel Church at 7:00PM.

While not one of Warren's churches, the Jefferson Methodist Church is included here. Located across from the Jefferson Township School, its Pastor was Reverend Mark Burnett during the early years of the War. He was followed by L. Keith Hanley in 1943. Dan Smith was identified as the Sunday School Superintendent. Another church outside Warren was the Lancaster Brethren Church with Reverend W.C. Stinebaugh as Pastor.

From what I have been able to uncover, these churches remained in their given locations during WW-II. I know, from various news articles in the Warren Tribune, that many of these Ministers remained during and after the War. Perhaps some of my Senior Readers may know of changes that took place later in the War Years; but this summary can sure be a starting point for reminiscing about our Churches many years ago.

There were occasional Revivals at the various churches, usually conducted with visiting pastors from other towns. In addition, the churches were used for meetings such as the WCTU program ... without criticism by organizations such as the present-day American Civil Liberties Union (ACLU). Not everyone in Warren may have had the same religious leanings, but everyone was free to worship as they chose.

I didn't mention the starting times for Services at the various churches. From what I can determine, they all started on Sunday with Sunday School at 9:30, followed by the Services at 10:30. (with the exception of the Plummers Chapel Church. For many, the church was the center of activities not only on Sunday, but also during the week. Summer trips to Church Camps were something for the young people to look forward to. Attendance for the young people was very important, and rewarded in all the churches. And songs were sung from the Hymnals...not from a screen up front!!
