The world will little note nor long remember what we say here, but it can never forget what they did here.

"It is for us the living rather to be dedicated here to the unfinished work which they who fought here have thus far so nobly advanced. It is rather for us to be here dedicated to the great task remaining before us, that from these honored dead we take increased devotion to that cause for which they gave the last full measure of devotion, that we here highly resolve that these dead shall not have died in vain, that this nation under God shall have a new birth of freedom, and the government of the people, by the people, for the people shall not perish from the earth!'

May God bless and protect our troops in Iraq, grant eternal peace and honor to those who have given their lives, and speed the healing of our military casualties.

#### GET READY FOR MEMORIAL DAY: National Safe Boating Week is May 21-27

Just in time for Memorial Day weekend, the unofficial start of summer, we observe National Safe Boating Week.

More than 70 million Americans enjoy recreational boating. Boat registrations have increased steadily to more than 12.8 million. Focusing on safety, the U.S. Coast Guard reports:

- . The number of drownings as a percent of total boating fatalities is about 70 percent. Other causes of fatalities include trauma, hypothermia, carbon and monoxide poisoning.
- . Alcohol was documented in 38 percent of boating fatalities.
- . Open motor boats were involved in 56 percent of fatalities, and personal watercraft were involved in 10 percent.

Wear it!

Life jacket use by all boat occupants can reduce drownings. Coast Guard approved life jackets are now more attractive in appearance and comfortable to wear.

When properly fitted, a life jacket can prevent a tragedy. Don't drink it!

Alcohol use affects judgment, vision, balance, and coordination. In fatalities involving alcohol use, over half of the victims capsized their boat or fell overboard. More than a third of all fatalities resulting from a collision involved alcohol use. Don't drink.

Take a boating education course! About 70 percent of reported accidents could have been avoided by the boat operator. The main causes of accidents are operator inattention, carelessness or recklessness, inexperience, unsafe speeds, and failure to post a lookout to identify hazards.

Boating education courses teach rules for safe operation and navigation of boats.

Get a vessel Safety Check

It's a free public service provided by the Coast Guard Auxiliary and volunteer organizations promoting safety. They check safety equipment and provide information.

#### Wheelchairs Available

Miracle on Wheels makes available Electric Power Wheelchairs to non-ambulatory Senior Citizens (65 years old & up) and the permanently disabled of any age, if they qualify.

Usually, there is no charge or out-of-pocket expense for the power wheelchair, including shipping and delivery to the home by a technician, who makes the final adjustments to fit the individual and shows them how to use and maintain it. No deposit is required and there is no obligation for determining if they qualify.

Electric wheelchairs are provided to those who cannot walk and also cannot operate a manual wheelchair sufficiently or safely enough to care for themselves in their residence. They do have to be able to safely operate a joystick controller on the armrest and understand the basic instructions.

There are additional qualifications including that their doctor approves and recommends their need for a power wheelchair.

Without this awareness and assistance, the senior and their family may prematurely choose a nursing home or take on expensive in-home care simply because they cannot move safely (or quickly enough) from room to room, to get to the bathroom, the kitchen or answer the phone or doorbell.

Also, they might make an unnecessary retail or cash purchase of power mobility equipment, or worse, be sold or pressured into purchasing something that does not properly fulfill their needs.



#### LIVESTOCK ENTRIES DUE

Families interested in showing Beef, Dairy Cattle, Sheep, and Swine in 4-H at the Indiana State Fair, August 10 – 21 must complete an entry form online or print a form and mail it by June 1st

The online entry feature provides a rapid enrollment method for 4-H families who exhibit at the State Fair. The site for enrollment is: http://www.indianastatefair.com.

Families that prefer to use paper forms can download from the state 4-H website at: Find the State Fair icon, and then click on the Entry Forms icon. State Fair Entry Forms are under "S" in the alphabetical listing and mail by June 1st. The entry date is early so that forms can be processed for the livestock shows.

An entry fee of \$15 (per specie) must accompany the entry. A fee of \$50 must accompany entries postmarked June 2 – July 31. Only hand delivered entries will be accepted from August 1 until check-in time and must be accompanied by a \$50 late fee plus an additional fee of \$50 per animal.

The July 1st entry deadline remains the same for 4-H Boer Goats, Dairy Goats, Meat Goats, Dogs, Cat, Llamas, Pigeons, Pygmy Goats, Poultry, Rabbits, and Waterfowl. 4-H Horse & Pony entries are due July 31st or three days after the county fair.

Entry forms may also be obtained at the Wells County Office of the Purdue Cooperative Extension Service located at the 4-H Park in Bluffton, telephone number 260-824-6412. Office hours are 8 AM to 4:30 PM, Monday through Friday.




