### ORIENTATION

Registration dates for Salamonie students will be Wednesday, July 30 from 1-7 p.m. and Thursday, July 31 from 8 a.m. to 3 p.m. Elementary students will be able to pay book rental at that time, middle school students will be billed at a later date. ### 7 TIPS TO EASE YOUR PETS' FIREWORKS FEARS

Westhampton Beach, NY—June 17—While the Fourth of July is a time for fireworks and celebration, for many pets and their owners it can be a nightmare. The loud noises, flashing lights, and smell of sulfur can cause excessive fear in pets. 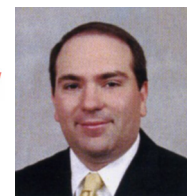

Preferred memorials are to the American Cancer Society in Fort Wayne.

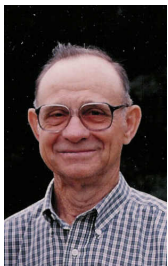

**Warning Signs of Gum Disease**

The fact is more teeth are lost to gum disease (periodontal) than decay. Gum disease is a silent problem that is not always accompanied by pain. There are warning signs and ones that you should be looking for are bleeding gums before, during or after a normal brushing of your teeth, receding gums from your teeth that are red, swollen or tender including pus, bad breath or bad taste. If you notice loose teeth or a change in how your partial denture is fitting. Brushing and flossing regularly is a good first line of defense to help avoid gum disease. You should also see your dentist for routine visits. There are also a number of risk factors associated with gum disease such as smoking or chewing tobacco. ### 4-H LIVESTOCK RULES

The Indiana State Board of Animal Health will not be requiring a "Certificate of Veterinary Inspection" for county and state livestock show this year. This policy was started in 2007 and will continue again this year.

What this means for many 4-H exhibitors is that they will not have to have their local veterinarian look at the animal and write a (CVI) Certificate of Veterinary Inspection as was done for many years.

It will be up to the livestock exhibitors to carefully monitor their animals during the summer months to keep their health in order to exhibit at a fair where they could expose other animals.

Most county fairs will still have a veterinarian at their livestock check in day to view the animals and look for any signs or symptoms of a contagious disease.

County fairs and other livestock shows are now required to record animal identification numbers for cattle, swine, sheep and goats. This is done in order to locate various animals and exhibitors in the event of some type of livestock disease outbreak.

### AMBASSADOR

#### APPLICATIONS

Junior Ambassador, grade 7-9 and Ambassador, grades 10-12 as of January 1, of the current year.

Selection is based on personal interview and overall 4-H record as submitted on the application. Interviews for the event will be held Monday, July 7th, 6:30 PM at the Wells County Community Center at the 4-H park.

The 4-H Ambassador Contest results will be announced at the opening evening events, Saturday, July 12th, 7:00 PM. Applications are due July 1st at the Wells County Office of the Purdue Cooperative Extension Service.

### CALEY AWARD DETAILS

Two Wells County 4-H members will be selected for this year's Caley Memorial Award at the annual 4-H Fair, July 12-17.

4-H members 14 years of age or older can be considered for the award from applications submitted by adults and youth.

Judging is based on the following: 4-H, 45 %; School, 20%; Community Service, 20%; Church or Youth Group, 15%.

The award will consist of a \$300 scholarship. Selection will be

announced on Saturday, July 12th, 7:00 PM on the opening day of the 4-H Fair.

The Caley Memorial Award is presented in honor of the Caley family who were tragically killed in an automobile accident in 1965 on their way to the 4-H Fair. Bill, the father, and four children, Kirby, Kent, Kris, and Kevin were all killed. Their mother, Marge, survived.

Applications for the award are available at the Wells County Office of the Purdue Cooperative Extension Service, 1240 S. 4-H Road, Bluffton, IN 46714. Applications and recommendations are due July 1st.

### 4-H DEADLINE

Wells County 4-H members are busy finishing their project manuals and records (what can be completed) so that they can be checked (reviewed) by the 4-H Club Leader on or before July 1st.

The policy which began in 2003, is part of an effort by the Wells County 4-H Council to encourage members to complete their manual and records.

Once a member has their manual and record checked, the 4-H Club Leader will issue them a signed certificate stating they have completed the required activities. This certificate will be shown upon check in at the 4-H Fair Expo Hall (non livestock projects) and at the 4-H Park West Road (livestock projects).

Dog and Cat exhibits were checked at your June workshop or club meeting.

Members who do not have a signed certificate from their leader will not be able to check their 4-H projects in at the 4-H Fair.

Mini 4-H member rules remain the same. They simply complete their project exhibit and bring it to the 4-H Fair.

Livestock members should complete as much of the feed record sheet as they can. Once the 4-H Auction is finished you will be able to finish your record and turn it in.

Club boxes will be on display in the Community Center for members to turn in the finished Record Notebooks and folders.

The Wells County 4-H Council along with the 4-H Association and 4-H Leaders all endorse the rule which helps encourage youth to complete their entire project.


