WHEN DREAMS COME TRUE

Two years ago a group of young men and three coaches had their goals set on making a trip to Cooperstown Dreams Park. This year, that dream came true. The Indiana Sandlotters, with players from Huntington, Grant and Wells Counties, just finished their season with a record of 42-17. Playing various teams from the states of Indiana, Ohio, Illinois and Michigan during their regular season, the Sandlotters exceeded a lot of people's expectations, except their own. This team went to Cooperstown New York on July 16th and was matched up against teams from all over the country. Highlighting their week was beating a team from Georgia (just outside of Tallahassee, Florida), tabbed as the # 2 ranked 12 year old team in the state of Georgia. The Sandlotters finished their trip to Cooperstown with an 8-2 record and finished 5th out of 80 teams. They also made a trip to Owensboro Kentucky for the BPA World Series and finished with a 2-1 record. Cooperstown Dreams Park is just that, a dream park where kids can make their baseball dreams come true. Given the opportunity and with the right attitude, it's amazing what kids can accomplish. With the confidence of the coaching staff and the support of their families, the Indiana Sandlotters proved that with a little hard work and determination, no hill is too steep, no mountain is too tall.

Some accomplishments of this year's team are as follows. Cameron Gerber broke a Cooperstown record with 32 2/3rds innings pitched for the week and he also matched the record for most complete game wins of 4. Dakota Parker led the team with 15 Home Runs, finishing 5th in Cooperstown in the King of Swat Home Run contest. Conner Stoffel hit 5 home runs in Cooperstown for the week. As a team, the Sandlotters ended up with 60 home runs for the season. Trent Sherman led the team with a batting average of just over .500. Ethan Daggett and Ryan McCarthy had multiple game saving, diving catches. Travis Gray was a vacuum at third, robbing hitters of extra base hits. Chandler Okey had a walk off home run when we had only 8 players. Alex Penrod led the team on defense at second base. Wayne Saalfrank shut down Indiana Express, the team that eventually won the BPA World Series. Boone Searles had 9 homeruns and was the # 2 pitcher on the staff.

A representative of the Fire Department noted that changes are being made at the Fire Station, including additional lights.

A representative of the ambulance crew was concerned about whether the electric breakers were adequate at the Fire Station. It was noted that some people are getting shocked when they get into the ambulance.

In a report on the upcoming Popcorn Festival, Aug. 11, 12 and 13, Council was commended for street paving being done.

Work crews from the Grant County Jail are scheduled to help clear the streets and the Fire Department is scheduled to wash down the streets.

Three reserve officers from the Sheriff's Department are scheduled to help during the Festival.

Council was asked to write letters on town letterheads to help the Lions Club in their efforts to get Grant money for support of the park.

A small park is expected to be established at the site of the recently torn down bank building. Various companies are to be contacted for financial help. Council agreed to donate up to \$500 if needed.

Five junk trucks were reported at the old Fertilizer Plant.

Superintendent Jim Webb said one water leak had been repaired. A new water meter had been installed at Weaver Popcorn.

The wastewater plant was said to be working well. There had been one bypass at the wastewater plant.

Work on sewers and storm drains is underway.

A number of street lights were

reported out and some were going off and on.

Recycling was reported to be going well.

The backhoe was back in operation.

There is a problem with trash at the park. Most of it is caused by people eating lunch there and not cleaning up.

There was still work to be done on sewer lines.

The next meeting will be Aug. 17.

With Premium Forwarding Service, the Postal Service boxes and reships mail to a temporary address for customers who are away from their primary address for at least two weeks and up to

one year.

Forwarding gives customers one more way to enjoy their mail in a timely manner."

Interested customers simply complete an application at the Post Office servicing their primary address. Necessary information including name, address of primary residence, temporary address, contact numbers and start and end dates is required. Premium Forwarding Service is temporary, but it does not replace the temporary or permanent Change-of-Address option.

The Postal Service collects the mail, boxes it and sends it to the temporary address once a week by Priority Mail. Express Mail, First-Class Mail or Priority Mail packages too large to fit inside the Premium Forwarding Service package are rerouted separately at no additional charge.

Premium Forwarding was designed to make life on the road or separation from friends and family a little easier.

"Convenience to the customer is key," said Nick Barranca, Vice President of Product Development. "Whatever your situation may be, the Postal Service has several convenient service options for handling your mail. You may be away from home, but your mail doesn't have to be."

There is a one-time enrollment charge of \$10. Customers are charged \$10 for each weekly shipment during the period they are enrolled in the Premium Forwarding Service. The Postal Rate Commission approved the proposed fee structure in April. Premium Forwarding Service is expected to begin in August.

In addition to Premium Forwarding Service, the Postal Service also offers Hold Mail Service, permanent forwarding and temporary forwarding.
