## CAREFUL WITH FROZEN FOOD

Use precaution when using canned foods that were frozen during this extreme cold weather, according to Beverly Morgan, Extension Educator in Consumer and Family Sciences. Such foods should be allowed to thaw naturally. Home canned vegetables should be checked by tipping slightly to see if liquid leaks from seals that may have been broken by freezing.

If the seals have been broken store the food in the refrigerator and use within two days. Do not taste any vegetable or meat before boiling it for ten minutes. Boil corn for twenty minutes.

There may be texture changes in foods such as fruits and tomatoes. These can be disguised by combining with other ingredients and using these foods in casseroles or desserts. The nutritive value remains essentially the same.

Jars that do not leak should be kept in storage of 45 to 60 degrees. Before using each jar, the food should be checked for signs of spoilage, such as bulging lid, spurting liquid when the jar is opened, or an "off," odor. Do not use any jar that shows any of these spoilage symptoms.

Check your canned foods now. If the seal is found broken a month from now, the food must be discarded.

Similar steps can be applied to commercially canned food that has been frozen. It can be stored

in the refrigerator and then eaten within two days. However if the lids are bulging and it shows any signs of spoilage, do not use.

Potatoes that have frozen and allowed to thaw cannot be used, because they will turn black and have a mushy, soft texture. They can be baked if they remain frozen, allowing a longer baking time. They will taste sweeter and have a more watery texture.

## CPR COURSES OFFERED

Would you know what to do in an emergency? Most people are uncertain, unless they have received proper training. Caylor-Nickel Medical Center is offering CPR classes for anyone who wants that training. All will be in the fourth floor conference rooms in the main Bluffton facility.

The public is welcome to attend any of the three types of CPR classes that are available in the next few months:

Heartsaver Plus - \$20 - covers one-man CPR, foreign body airway obstruction and use of a mask, all on an adult. It will be Thursday, February 10 from 5:00 to 9:00 p.m. or Monday, May 15 from 5:00 to 9:00 p.m.

Healthcare Provider - \$30 - for those who have never taken this level of CPR or whose card has expired. Covers adult, infant and child CPR, foreign body airway obstruction and much more. It will be on Tuesdays, March 7 and 14 from 5:00 to 9:00 p.m.

Healthcare Provider Renewal - \$20 - a refresher course for those whose current Healthcare Provider CPR card is about to expire. The current CPR card needs to be brought to registration. Participants can choose one: Thursday, February 17; Tuesday, March 21; Monday, April 24; or Monday, May 15. All are from 8:00 to 11:30 a.m. There will also be an additional session held on Thursday, February 10 from 5:30 to 9:00 p.m.

Pediatric Basic Life Support Plus - \$25 - for parents, expectant parents and child care providers who want to learn basic CPR for infants and children, foreign body airway obstruction and other first aid. One session will be held on Monday, April 24 from 5:00 to 9:00 p.m.

A providership card will be granted on successful completion of each CPR course, per Ameri-

can Heart Association standards. Those standards require that each person pass a written test and demonstrate skills. Student manuals are available upon registration.

## FAMILY DAY AT THE DENTIST

As pall of National Dental Health Month, the Huntington County Dental Society is again sponsoring "Family Day at the Dentist," on Saturday, February 5, 2000.

"Family Day at the Dentist" is designed as an opportunity for individuals or families without a family dentist to have a free dental examination and establish a relationship with a local dentist according to Huntington County Dental Society spokesperson Dr. John E. Regan.

Local and national dental societies use this month to provide public health information on the importance of good oral health and preventive care. "Dentistry's message that almost all dental disease is preventable is particularly relevant at this time when the nation is trying to control health care costs," said Dr. Regan. He indicated that dental disease cannot be cured at this time but it can be controlled if

patients would control plaque, reduce or eliminate sweets, use fluorides and apply sealants. Family Day at the Dentist is an opportunity for the entire family to start to take advantage of preventive care that is available.

Any family or individual wanting to participate in "Family Day at the Dentist" may do so by calling 219/356-6119 any day this week between the hours of 9:00 and 4:00 for an appointment.

Huntington County dentists will also be participating in "Doctors With a Heart." This is a national program whereby free dental care is provided to needy individuals on Valentine's Day. To participate in this program, families or individuals must make an appointment for Family Day at the Dentist.

## SCHOLARSHIPS FROM SHERIFF

Huntington County Sheriff Rod Jackson has announced that the Indiana Sheriffs' Association will again be awarding college scholarships to qualified high school seniors or college students who are pursuing a degree in criminal justice studies. There will be approximately 40-\$500 scholarships awarded to qualifying students throughout the state.

The Indiana Sheriffs' Association Scholarship Fund was established for the purpose of receiving, investing and dispensing of funds to provide college scholarships to qualified students who are committed to pursuing an education and career in the law enforcement field.

To qualify for one of these scholarships, the applicant must be between the ages of 17 and 23, and either be a member of the association or a son or daughter of a current member of the association. Applicants must presently be listed scholastically in the upper half of their class.

GROUNDHOG DAY: FEBRUARY 2, 2000:

### FACTS ABOUT THE PROGNOSTICATING RODENT

According to the School of Veterinary Medicine, Cornell University:

Groundhog and woodchuck are names of the same animal. Related to squirrels, they can climb trees, and they can swim.

February 2 is a "cross-quarter" day, about halfway between the winter solstice and the vernal equinox in March. Many groundhogs end their hibernation a week or so later than this.

The groundhog's internal clock is believed to be affected by changes in the amount of daylight. Hormonal responses change the production of melatonin and are thought to be the signal to wake up.

Groundhog fur was never used for coats. Its hairs are used for tying trout flies. American Indians used its hide for the soles of moccasins.

Answer to the classic question: How much wood could a woodchuck chuck if a woodchuck could chuck wood? About 700 pounds. A wildlife biologist measured the inside volume of a typical woodchuck burrow; he estimated that if the burrow were filled with wood instead of dirt, the industrious animal would have chucked about 700 pounds worth. Of course, the woodchuck doesn't chuck wood.

They will chew on wood, but they are not adept at moving timber, especially when compared to beavers.

### LINCOLN'S EMANCIPATION PROCLAMATION

Black History Month is traditionally celebrated in February, the month of Abraham Lincoln's birthday. It was Lincoln who gave us the Emancipation Proclamation. In part, this is what he wrote:

*I do order and declare that all persons held as slaves within said designated States, and parts of States, are, and henceforward shall be free; and that the Executive government of the United States, including the military and naval authorities thereof, will recognize and maintain the freedom of said persons.*

*And I hereby enjoin upon the people so declared to be free to abstain from all violence, unless in necessary self-defence; and I recommend to them that, in all cases when allowed, they labor faithfully for reasonable wages.*

*And I further declare and make known, that such persons of suitable condition, will be received into the armed service of the United States to garrison forts, positions, stations, and other places, and to man vessels of all sorts in said service.*

*And upon this act, sincerely believed to be an act of justice, warranted by the Constitution, upon military necessity, I invoke the considerate judgment of mankind, and the gracious favor of Almighty God.*

By the President: Abraham Lincoln

### GRAIN MARKETS SHOW IMPROVEMENT

There has been some good news in the grain markets that has moved the local price of corn above \$2.00 and the price of soybeans up to about \$4.90 per bushel. For a long time there had been no movement in the grain market, now there has been some improvement.

Several factors continue to provide support for corn, soybeans, and wheat prices. Among these are continued dry weather in some South American growing areas, dry weather in some U.S. winter wheat areas, a solid rate of export sales, and a large number of cattle in U.S. feed lots. These factors

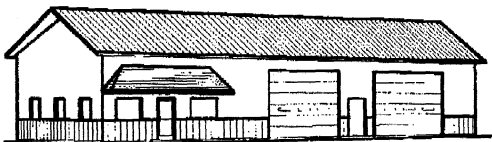

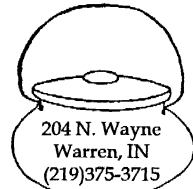
