JUNE 13-19, NATIONAL LITTLE LEAGUE BASEBALL WEEK LITTLE LEAGUE BASEBALL HAS COME A LONG WAY

Sixty-seven years ago, a guy by the name of Carl Stoltz gathered a group of boys to form a ball team. By the next year, he had formed three teams that played each other in a vacant lot. Little did he know that within half a century, his Little League baseball would be played in 95 countries around the world.

In 1942, Stoltz created the keystone logo that is still used in Little League. Some refinements developed for his teams were later moved to the big leagues. In 1945, the world's first remote-controlled electronic scoreboard was introduced for them, and in 1959, the modern protective helmet was developed by Creighton Hale, Director of Research for Little Leagues.

In 1970, the Canadian Headquarters of Little League Baseball opened in Ottawa. In 1974, Little League was revised to allow girls to participate.

In 1985, for the first time, ABC-TV carried the Little League World Series championship game live on Wide World of Sports. For the first time in baseball history, a miniature camera was mounted on the mask of home plate umpire Frank Rizzo.

By 1998, Little Leagues were playing in 95 countries.

In the latest phase of the Little League Child Protection Program, background checks on volunteers are made.
