LIVING WILLS:

Do You REALLY NOT WANT TO LIVE THAT WAY?

Just 50 years ago, society would have agreed: Starvation was bad; caring for the infirm was good.

But today, as the recent case of Terri Schiavo dramatically illustrates, there is widespread disagreement as to what should be done when a person is dying or, in the case of Schiavo, living and breathing on her own, but incapacitated.

One solution is for each person to create a document that tells their loved ones what they want. But this is no easy task. The only thing experts agree on is that you must be very specific.

Here's some tips:

Don't be quick to tell others you never would want to live in a certain situation. There is a difference between not wanting to be disabled and not wanting to be alive while disabled. In the case of Schiavo, her casual statements were accepted by a court as a legal will. Try to imagine yourself in situations where you are incapacitated but, with effort, you might recover or at least live to see a child grow up, for example. Be sure to write your will to cover such an eventuality.

Stay away from language that requires a value judgment on the part of a doctor or caregiver. Don't use words like "extraordinary measures." According to the National Right to Life Committee, social thinking has tended away from a presumption that people want to live. Saying you don't want extraordinary measures "might be interpreted to require starving you to death when you have a disability, even if you are in no danger of death if you are fed."

Avoid making doctors, courts, or your family determine whether your condition is a burden. If you can't speak, you might have a very different idea than they do of what is burdensome.

Some situations to consider: When to administer CPR; when surgery would be acceptable; or when a ventilator or feeding tube should be used.

You might also specify whether, if in a coma, you should be given rehabilitation or even whether people should be allowed to speak to you. Some nursing homes require that people in comas never be spoken to or around lest the family be given hope.
