COLLAPSE BRINGS IMMEDIATE REACTION

Shortly after the last parade entry passed the former Gene's Market the upper story gave way and collapsed into the street. Festival attendees sitting below, all escaped with no major injuries. Bumps, bruises and scrapes were the extent of the damages to frightened onlookers. There was a report that someone had a deep gash on their arm, but that has been verified as being false information.

Firemen, town employees, local volunteers, Town officials and others diligently worked through the night to finish taking that building and the one next to it, the former Racketty Packetty, down. Saturday morning dawned with a new landscape and a lot of tired workers.

A video of the destruction went viral on Facebook, and area TV stations. Reported was that Warren Indiana even made National news later that evening. Luckily we didn't have any fatalities to report.

A statement from Town Hall reads as follows:

"Warren Town Officials wish to take this opportunity to express appreciation for the response to what could have been a real tragedy during the Salamonie Summer Festival. We are thankful that injuries were at a minimum. To those emergency personnel including Indiana State Police, area Police Units, Paramedic Units, EMA, Fire Departments, DCD and other units from Huntington and from surrounding counties and communities, your immediate assistance to local departments was paramount in managing, assessing, and taking action. To local volunteers who provided assistance, to food vendors who provided water and food, to local businesses who also provided food, again, in speaking with local personnel, your support was so appreciated by those on the ground. To the Mayor of Huntington for his response and support during the evening and into the next day, we so appreciate your being available. To the volunteers who stepped forward from the crowd to use their technical experience in handling such situations and who stayed on scene for many hours, we cannot say enough. We know in talking

FORD IS PIONEER



At the Annual Samuel Jones Pioneer Award Breakfast on July 5 Tim Ford was honored as this years recipient.

WILD ANIMALS: IF YOU CARE, LEAVE IT THERE

People who encounter young wildlife such as a fawn or rabbit should leave the animal alone and avoid attempting to "rescue" it, according to the DNR Division of Fish & Wildlife.

April to July is the peak season for people to see baby animals in Indiana.

Often animals leave their young during the day to look for food or to deter predators. People often mistake the animal as abandoned when, in fact, it is being properly cared for by its mother.

Even if you think the animal is injured, you still should leave it be. It's best to let nature take its course. If you feel compelled to intervene, you should call a licensed wildlife rehabilitator. It's illegal to keep a wild animal without the proper permits and training. Most people are not trained in animal nutrition, nor do most people know how to raise a wild animal without it

developing a dependence on humans.

A list of licensed wildlife rehabilitators and their phone numbers is at dnr.IN.gov/fishwild/5492.htm.

White-tailed deer have babies through mid-June. If you find a fawn, give the animal distance and do not disturb it. The mother will not return if you are present, which may delay nursing for a hungry fawn.

Remember, if you care, leave it there. In almost all cases that is the best thing for the animal. Wild animals are not pets. These animals may carry diseases and are not suited for captivity.
