KUDOS, KICKS & KARATS

THE UPTOWN GARDENER

Officially summer came to us on Monday but I would rather think it has been here for a while. Remember when we were wishing for warmer weather and I said don't complain when it gets sultry hot? With all the rain it has made for some sticky days.

Recently a friend gave us a story that a former resident of Warren gave her in which she was reminiscing about Warren. It was fond memories of Warren and I found it quite interesting. It was about the telephone system of several years ago. It got me thinking of the faithful service those ladies gave to the community for many years. (One which I am proud to say I was a part of for several years in the 60's and 70's). The article we will try to run in its entirety later.

In the 50's and 60's I was working for Indiana Bell and can recall some of the difficult and stressful times when we had situations with operators in the big cities who could not understand these "strange and funny numbers" they were trying to reach and were determined that it was not possible to dial 527 R1 or 46 R or J. Of course they were right but couldn't believe such places existed.

If you were from a small town rural community you well understood the system and for the most part you were proud of your roots.

In my home town of Andrews we also had such a system with privately owned by a few individuals. My sister worked for them in early 40's for five cents per hour and thought she had a great after school job. The girls had the responsibility for the safety of the whole area. At 6 a.m. the siren blew to awake anyone who might have overslept (you could hear it plainly for a couple miles) and again at 12 noon and at 6 p.m. It was also used for the fire alarm, can you imagine what a chore it was to blow the siren depending on where it was located, how many times it went off and at the same time get the firemen all notified. Then most everyone called in to see where the fire was.

There was a red light on the corner light pole to let the town marshal know he was needed. In those days the marshal was patrolling on foot as it was much cheaper to buy a new pair of shoes rather than tires for his personal vehicle which they had to use.

The telephone operator was also the source of news releases such as the case when President Roosevelt died she notified as many as possible. If you were on a country line such as we had and the phone rang five long rings everyone picked up to get the message. Another time was in case of bad weather and school closings.

Those were just a few of so many memories of the ole telephone that hung on the wall at our house and of the faithful ones who served us as best as they could.

### COUNCIL NOTES

The Warren Town Council held their regular meeting on Monday evening, June 14. The meeting was held in Assembly Hall and opened at 6:30 p.m. President Bill Cartwright conducted the meeting.

Preceding the regular meeting two Public Hearings were held. The first pertained to a petition filed by Heritage Pointe to vacate certain unimproved alleys and streets. John Gamble was in attendance and commented on a portion of an unimproved street not in reference to the filed petition. Gamble was advised to meet with the Clerk-Treasurer for the procedure to follow.

The second Public Hearing concerned re-establishment of a rate in the Cumulative Capital Development Fund.

Minutes of the regular meeting May 10 were approved as submitted.

Family members of a resident at 111 North Hendricks Street requested information in regard to an area paved by the town up to a private curb. Neighbors are said to be using it for public parking. A discussion was held and Council agree additional information would be necessary and referred the situation to Municipal Attorneys.

Vicki Grim, chairperson of the Salamonie Summer Festival presented to Council a list of street closings for the festival and Council approved.

Council adopted Ordinance 2010-1, an Ordinance to vacate alleys and street, discussed during the Public Hearing.

Council also approved adoption of Ordinance 2010-2, an Ordinance to re-establish a rate in the Cumulative Capital Improvement Fund, discussed during the Public Hearing.

Council accepted a quote in the amount of \$3,400 from Charles May to complete brickwork and water-proofing of Town Hall.

On behalf of Roto Fab, Marilyn Morrison submitted an application to Huntington County CEDIT committee in the amount of \$72,036.40. The company expected to move it's business from Wells County to Warren.

Morrison reported to Council that submission of application for quotes on IACT sponsored insurance is ready to be submitted as soon as one

outstanding application is completed. Counsel urged that application be completed immediately.

A letter from Waste Management announced that company's buy out of Marion Services. They assured that all business will be handled as before. Dumpsters used during the Festival and dumpsters placed at Tower Park may possibly require \$160.00 for each one. Previously there had been no charge. It was noted that other companies could be contacted for dumpsters. The contract does not cover such service. A final decision is expected by June 15.

Morrison submitted an application to the Town of Warren for a grant in the amount of \$7,371 for Pulse Opera House. Council reviewed the application and approved a grant of \$5,000 to follow the same pattern of other grants in the Streetscape Program.

On behalf of the Chamber of Commerce, Greg Beumer of Beumer Consulting provided information concerning a planning grant not to exceed \$50,000 with a 10% match. The grant would be used to study the building infrastructure within the downtown and would be followed by a brick and mortar grant. This grant application could be up to \$500,000 with at least a 10% match. The Town of Warren to be facilitator of any grant, but Chamber would provide the 10% match. Council failed to make a decision until more information is available.

It was reported that the first meeting with the Department of Local Government Finance is scheduled for July 21 at 2 p.m. President Cartwright set a special meeting for June 23 at 2 p.m. in Assembly Hall to begin budget discussion.

Council granted permission to write-off four accounts in the

amount of \$168.67.

Curt Day reported that the paving project was scheduled to begin June 15, with milling Salamonie Heights and Grover Street, weather permitting.

The County Highway Department is replacing a culvert on Scout Cabin Road. The town will be responsible for reconstruction of the area around it.

Stoning of the alleys was set to begin soon.

Fire Chief Poulson asked permission to do annual pump testing. He was given permission to accept quotes and use the lowest bid if it did not exceed \$600.

Poulson said street cleaning for the Festival will be done by the Fire Department on June 28 at 5 p.m.

Damage was reported to Pumper 801. A driver had backed it into a pole. The

An eligible customer may receive the Lifeline discount on either a wireline or wireless phone, but the discount is available for only one telephone service per household.

Link Up Assistance provides a credit for up to one half (1/2) of the new service connection charges for telecommunications service. This credit is only available on the installation of a single residential access line at the principal residence of the eligible customer. A customer may receive the Link Up discount only once per address.

Council approved a \$250 donation to the Fireworks Fund.

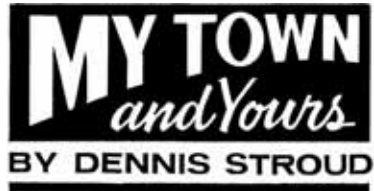

Now that summer is almost here how do you keep up with your yard work? Gardening is just like washing dishes or laundry. There is always some to do! We can't allow our perfectionism to get in the way of getting SOMETHING done.

Procrastination is what causes us to get overwhelmed. We have to figure out ways to stop ourselves from putting things off. Let's not think of Gardening as work. Look at what has to be done in your yard.

Mow  
Weed flower beds  
Dead head flowers  
Pick flowers for your table  
Fertilize your plants  
Water  
Mowing has to be done once a

week. What day are you going to mow? And do it. Mowing has four parts. Get mower ready to mow; do this when you put the mower away; that way you will always be ready to get it done.
