A LETTER FROM PRESIDENT TEDDY ROOSEVELT TO 21ST CENTURY AMERICA

Harriman, but their attitudes were the same. They wanted to build fiefdoms and if they had to do it on the dry bones of fired or underpaid employees, so be it.

So what should you do now almost one hundred years later? Well, for openers stop making speeches and start doing the kind of things I did. I sued forty-three corporations who were out of line. Set up a Bureau of Corporations with powers to inspect the books of all businesses engaged in interstate commerce. Revived the all but forgotten Sherman Anti-Trust Act. Indeed, it's time to make more of those guilty of white collar crimes wear prison gray.

Your problem is your leadership pays too much attention to polls. There is no doubt that I had a big mouth, and used it. That I believed in the bully pulpit and would today make it loud and clear that business leadership will not be allowed to sup at the public trough whenever and however they please.

I call on your 21st century Americans to find some old fashion ethics, and go after those who are breaking them. I did. Went after some judges bribed by a man named Jay Gould. Though I gave it my all I still lost, but did that stop me next time around? Not in a thousand years. Because in losing, I made it clear that when you did wrong Teddy Roosevelt would soon be banging on your front door.


Remember the Armour Meat Packing Company. Well, one day its founder and owner P. D. Armour, because his employees in a certain department had done such a wonderful job, decided he would offer each of them a new suit. In order to take advantage of such a generous offer, one young man ordered a suit costing \$150, a very healthy sum at this particular point in history. Receiving the

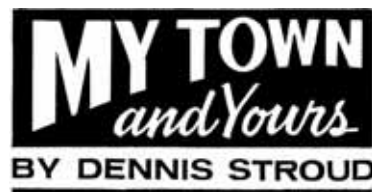
On May 1 Swayzee Telephone Cable will take over cable service in Van Buren. The town had previously been served by Longview Cable Company.

Officer Pat Collins gave his report. He presented quotes for radar and hand guns. He will ask for a grant through Round Robins before a decision is made.

The Eastbrook Band will hold a car wash May 1 from 10a.m. to 1p.m. at the Fire Station.

Town Clean Up is scheduled for April 30 and May 1.

Town Rummage Sales will be June 11 and 12. Anyone wishing their name on a town directory should call the Clerk-Treasurer's office.



Occasionally, I see people with cameras, walking up and down Wayne Street, taking pictures of the signs painted on the brick store fronts. The person who painted these signs was an excellent sign painter, self taught, and did it without stencils. He would take a Myers Department Store yard stick and a piece of chalk, lay out and paint most of the signs you can see on the bricks today. The painter was Blaine Brelsford.

Blaine was a shy boy growing up and at the age of 16 took his first drink. That first drink made him feel so good that he couldn't stop. He became an alcoholic. A lot of times he would be locked up in the town jail, like the lovable Otis on the Andy Griffith

show. In later years, he had said he had never married, had no children, and never had a home, a car or any respect because of alcohol.

A few years ago, in the Museum, an older gentleman was telling about Blaine painting the Gold Seal Drug Store sign on the side of the building. He would go up the ladder, paint one letter, and then have to go to the Wagon Wheel for a drink. He would come back, paint another letter, and go for another drink. Four or five old timers setting across the street were making bets on which letter he would fall off the ladder, but he never did. Blaine's work lives on still on Warren's buildings. One of Warren's personalities that we won't forget.

COUNCIL NOTES

The April 14 meeting of the Warren Town Council was held in Assembly Hall. President Bill Cartwright opened the meeting at 6:30 p.m. All in attendance repeated the Pledge to the American Flag.

Bob Pond spoke on behalf of the Knight-Bergman Civic Center Board. They have applied for grants for improvements to the Center. Council agreed to be the Fiscal Agents.

One person has been cited for feeding feral cats. They have agreed to work on reducing the population of cats.

Jeff Souder was in attendance, representing HCUED. They are requesting additional funds in the amount of \$4,000 per year from the Town, to hire an assistant in the office. Current

amount from the Town is \$1,700.

The town has been notified they will receive less from property tax. They will receive \$42,000 less this year due to an appeal filed.

AT&T asked permission to work on the antennae on top of the water tower. Permission was granted.

Town Spring Clean Up will be May 3 to 8.

Discussion between Council and the Park Board concerned improvements to the ball diamonds at Tower Park.

RED CROSS NEWS

The American Red Cross is excited to announce that a new law, Senate Bill 46, will encourage 16 year-olds to start a lifelong habit of donating blood. In the past, Indiana state law was silent on the issue of 16 year-old blood donations. This allowed the Red Cross and other blood centers to collect blood from 16 year-olds with written parental/guardian consent. Thirty states, including Ohio and Kentucky, already have written laws which specifically encourage 16 year-olds to donate blood. As a result, Sharyn Whitman, CEO for the Indiana-Ohio Blood Services Region of the American Red Cross, worked to see a similar law take effect in Indiana.

On Jan. 27, 2010, Whitman testified in front of the Senate Health Committee to show support for the bill. Indiana Governor Mitch Daniels signed Senate Bill 46 into law, after it passed in both the House and Senate. The law will go into effect on July 1, and will encourage 16 year-olds to donate blood with parental consent in the state of Indiana. This means that now even more high school students can help save a life by donating blood. The American Red Cross is excited to spread awareness that blood donation is

something a 16 year-old student can do to make a difference in their community.

"The Red Cross is grateful to Senator David Long and Senator Patricia Miller for the work that they did to make this bill a reality," said Whitman. "Many of our committed donors began donating blood while they were in high school. As our donor base continues to age, it is important to educate the next group of young donors about the importance of a safe and stable blood supply."

If you are 16 years of age and would like to donate blood, simply log-on to redcrossblood.org to find out more information. Before donating, 16-year-olds must review a few materials and have a parent or guardian sign a written consent form. This written consent form must be brought with the 16-year-old to the blood drive or donor center. High school students and other donors YOUNGER THAN 19 YEARS also have to meet certain height and weight requirements. Please bring your Red Cross blood donor card or other form of positive ID when you come to donate.

Application forms can be obtained by calling 1-800-227-2345 or online at www.cancer.org/camparainbow.

Camp Catch-A-Rainbow is accredited by the American Camping Association and is licensed through the state of Michigan. The American Cancer Society, Great Lakes Division, Inc., serving Indiana and Michigan, funds Young Camper's Day and Camp Catch-A-Rainbow. The camping program is just one of the many ways the American Cancer Society is able to save lives and creates more birthdays by helping people stay well and get well, by finding cures, and by fighting back.

Additional medical and non-medical volunteers, especially male volunteers, are currently needed to assist onsite at Young Campers Day and Camp Catch-

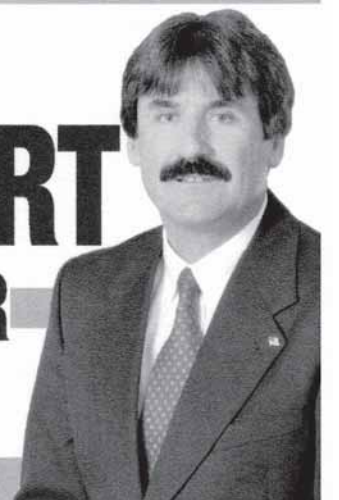

TURKEY SEASON

Indiana's 41st annual spring turkey hunting season begins Wednesday, April 21 statewide.

Hunters can harvest one male or bearded turkey in the spring

season, which runs through May 9.

Hunters must possess a spring turkey hunting license and a valid game bird habitat stamp, or a youth consolidated hunt/trap license, or a lifetime comprehensive hunting or comprehensive hunting and fishing license. An apprentice license is available to anyone, including hunters born after Dec. 31, 1986, who have yet to complete the requirement of hunter education. All persons, regardless of age, are limited to three apprentice licenses in their lifetime.

Legal turkey hunting equipment includes 10-, 12-, 16-, or 20-gauge shotguns, muzzleloading shotguns not smaller than 20-gauge nor larger than 10-gauge, bow and arrow, or crossbow.

Turkeys may be hunted one-half hour before sunrise to sunset, except at all DNR fish and wildlife areas, J. Edward Roush, Mississinewa, and Salamonie lakes, where legal hunting hours are one-half hour before sunrise until noon CDT and 1 p.m. EDT.

All turkeys must be properly tagged and checked-in at an official turkey check station. A list of check stations is available in the 2009-2010 Hunting and Trapping Guide or at wildlife.IN.gov.

SCHOLARSHIPS OFFERED

The Huntington County Extension Office currently has applications available for five local 4-H scholarships. Huntington County 4-H members who are eligible may stop by the Purdue Extension – Huntington County Office to pick up an application or may request the applications via email. Applications must be received no later than May 31, 2009.

Janell Marie Saunders Memorial (\$1,000) – open to a current high school senior or Huntington County 4-H alumni who completed their final year of 4-H within the past two years. Applicants need to be pursuing post high school studies in the area of nursing or a health/medical related field.

Ray Vanderspool Memorial (\$1,000) – applicants must be a current high school senior. Selection criteria include 4-H member record, community involvement and academic record.

County 4-H Swine and 4-H Beef Scholarships (\$500 each) – applicants must be enrolled in the 4-H swine or the 4-H beef project for a minimum of 5 years, with 4-H record and school/community activities considered in the selection process.

Huntington County 4-H (2 scholarships @ \$500 each) –

open to a current high school senior or Huntington County 4-H alumni who completed their final year of 4-H within the past two years. These scholarships will be presented during the 4-H Fair in July at Hier's Park.

SHEEP/GOAT ID DAY

Identification days for Huntington County 4-H Sheep & Goat members will be held on Saturday morning, May 1 at Hier's Park.

Youth enrolled in the 4-H Goat project will need to bring market goats to the goat pavilion (pole building immediately south of the Show Arena) between the hours of 7:30 – 10:00 am for identification and weighing of the animals. Members with breeding does or pet care entries must complete the enrollment paperwork but do not have to bring the animals to the fairgrounds.

4-H Sheep members must bring their market lambs and any non-registered ewe lamb or yearlings to the cattle barns between the hours of 7:30 – 10:00 am for the identification process and weighing for entry.

Youth planning to exhibit in the 4-H Goat or 4-H Sheep Shows at the Indiana State Fair must also have their market goats, sheep market lambs and sheep breeding females identified with electronic ear tags, provided through the County Extension Office.

Animal enrollment forms and specific details about the identification days were mailed directly to 4-H sheep and goat members. Members need to contact the Purdue Extension – Huntington County office if they have not received these forms in the mail.
