### June 1-July 4: Fireworks Safety Month.

Plan to make your 4th of July a safer celebration

Here are the best fireworks safety tips we can give you: Obey the law and use common sense.

Most parts of the U.S. have limitations on the types of fireworks that can be sold. You'll be safer if you follow the law and keep away from illegal fireworks.

Anything that will shoot, explode in the air, or spin uncontrollably should not be set off by an unauthorized person. Examples include Roman candles, firecrackers, bottle rockets, M -80s, and cherry bombs.

Even with legal fireworks, you really are playing with fire. Don't get burned. Think ahead of time about how you can follow these safety instructions:

- \* Choose a spot that is not near anything that can catch fire.
- \* Make sure kids under age 14 don't set off fireworks without adult supervision.
- Keep a bucket of water nearby. Use it for matches, spent fireworks, and to put out fires.
- \* When you light a fuse, move away quickly. If the fuse sputters or goes out, douse the device with water and move on to the next. Never try to relight a dud. It could explode in your face.
- Light fireworks on the ground, not in your hand. The fuse may burn faster than you realize it will. Douse used sparklers and other fireworks with water before picking them up. They could be very hot.
- Never drink alcoholic beverages while you are lighting fireworks. Drinking could alter your judgment.
- Light only one firework at a time.

Rules & Regulations

- 1. Teams must bring their own bed.
- 2. The bed must be based on a real bed of a standard manufactured size adult bed, (i.e., twin, double, queen, king, canopy, trundle, bunk - no youth beds, cribs, gurneys, hospital beds, waterbeds, bathtubs or coffins.)

- 3. Beds must have a headboard. footboard, and frame,
- 4. Beds can not have push bars on the sides of the frame - nothing should be protruding outward from the sides of the frame for safety reasons.
- 5. Beds must have at least four wheels and be designed so that four wheels contact the ground.
- 6. Wheels of any size can be used. Wheels will be permanently
- 7. No braking devices allowed. 8. The bed must be propelled by human power only. No motorized or mechanical propulsion.
- 9. Beds may not be pulled with ropes, chains, etc.
- 10. Decorations are allowed and encouraged.
- 11. Entrants are encouraged to decorate the bed to promote outlandish, silly, beautiful or socially relevant themes. Any bed deemed vulgar or morally inappropriate will be disqualified before the race begins.

- 13. All beds will have one rider and four runners/pushers with an alternate to be named on the registration form in case of accident or illness.
- 14. The rider MUST wear a protective helmet, with a strap.
- 15. Until a team is eliminated for the day, one member must remain with the bed at all times to receive messages from Race Officials, PLEASE NOTE: Race Officials will not attempt to communicate instructions and other information to teams who leave their beds unattended, Runners, riders and beds must be available at the call of Race Officials.
